




Introduction to ICANN At-Large

The ALAC vs At-Large Community

- The ALAC refers to the 15 members of the At-Large Advisory Committee (ALAC)
- The At-Large community refers to the ALAC plus the Regional At-Large
 Organizations consisting of At-Large Structures (ALSes) and unaffiliated members
