Purpose of the Review


The Accountability and Transparency Review is mandated by ICANN's Bylaws to examine ICANN's execution of its commitment to maintain and improve robust mechanisms for public input, accountability, and transparency so as to ensure that the outcomes of its decision-making reflect the public interest and are accountable to the Internet community.

Timeline of the Review

- ATRT3 is mandated by ICANN's Bylaws to complete the review within one year (i.e. by April 2020)
- ICANN66 Montreal: Draft recommendations socialized with the community
- December 2019: Draft final report published for public comment
- March 2020: Final report published
