What We Receive Input On:

ICANN Org is seeking community input on two different public comment forums:

- 1) Public Comment Proceeding for the implementation plan of the Registration Data for gTLDs Consensus Policy**
 - a) ICANN organization worked with the community-based Implementation Review Team (IRT) to produce the proposed Registration Data Policy for gTLDs and its implementation plan for community feedback. This public comment forum is intended to gather community feedback on the the proposed Registration Data Policy for gTLDs and its implementation plan for the EPDP Phase 1 [recommendations adopted](#) on 15 May 2019, the EPDP Phase 2 Priority 2 [recommendations adopted](#) on 21 June 2021 and the EPDP Phase 1 GNSO Council Supplemental Recommendation 12 [adopted](#) on 24 February 2022.

- 2) Public Comment Proceeding for the implementation plan of the EPDP Phase 1 Recommendation 27**
 - a) Recommendation 27 within the [EPDP Phase 1 Final Report](#) notes that as part of implementing the EPDP Phase 1 recommendations and to ensure consistency, updates will need to be made to existing policies and procedures that touch on Registration Data. Consistent with Recommendation 27, the Board directed ICANN org to work with the IRT to examine and report on the extent to which the EPDP Team’s policy recommendations require modification of existing consensus policies.

 - b) ICANN org performed a detailed review and analysis of 22 existing policies and procedures. 18 of the reviewed policies and procedures were determined to have been impacted by the Registration Data Policy. Impacts included outdated provision language (e.g., references to administrative contact requirements), higher-level issues such as the relevance or inconsistency of an existing policy or procedure with the new Registration Data Policy, or implications for existing contractual provisions. Three of the reviewed policies and procedures were determined to not be impacted by the Registration Data Policy. One advisory was reissued rather than redlined as part of the Recommendation 27 review. For a complete list of the reviewed policies and procedures, please refer to

This proposed policy represents the Stage-Two following the [Interim Registration Data Policy for gTLDs](#) published on 17 May 2019.

Proposals for your Input

- Registration Data Policy Consensus Policy
- Expedited Policy Drafting errors Development Process (EPDP) Phase 1 Recommendation 27 Redlined Consensus Policies.

Background:

On 17 May 2018, the ICANN Board adopted the [Temporary Specification for gTLD Registration Data](#). The Temporary Specification modified existing requirements in the Registrar Accreditation and Registry Agreements to comply with the European Union's General Data Protection Regulation (GDPR). Following the adoption of a Temporary Specification, the procedure for Temporary Policies as outlined in the Registrar Accreditation and Registry Agreements provides the Board "shall immediately implement the Consensus Policy development process set forth in ICANN's [Bylaws](#)." Additionally, the procedure provides this Consensus Policy development process on the Temporary Specification must be carried out within a one-year period as the Temporary Specification can only remain in force for up to one year from the effective date of 25 May 2018, i.e., the Temporary Specification will expire on 20 May 2019.

On 19 July 2018, the Generic Names Supporting Organization (GNSO) Council [initiated](#) an Expedited Policy Development Process (EPDP) to be developed in two phases and [chartered](#) the EPDP on the Temporary Specification for gTLD Registration Data Team. All GNSO Stakeholder Groups, Constituencies, and ICANN Advisory Committees, that indicated interest in participating, are represented on the EPDP Team, although the charter limits the number of members per group.

During Phase 1 of its work, the EPDP Team was tasked with determining if the Temporary Specification for gTLD Registration Data should become an ICANN Consensus Policy as is, or with modifications. In addition, the charter directed that the result must comply with the GDPR and take into account other relevant privacy and data protection laws. The purpose of Phase 2 of the EPDP Team's charter was to evaluate a System for Standardized Access/Disclosure of non-public gTLD Registration Data, address issues noted in the [Annex to the Temporary Specification](#), and address other issues deferred from Phase 1.

On 21 November 2018, the EPDP Team published its Phase 1 [Initial Report](#) for [public comment](#). The Initial Report contained the EPDP Team's preliminary recommendations and a set of questions for public comment. The EPDP Team also examined and made recommendations about: (i) the validity, legitimacy

and legal basis of the purposes outlined in the Temporary Specification, (ii) the legitimacy, necessity and scope of (x) the registrar collection of registration data and (y) the transfer of data from registrars to registries, each as outlined in the Temporary Specification, and (iii) the publication of registration data by registrars and registries as outlined in the Temporary Specification.

The Phase 1 Initial Report also provided preliminary recommendations and questions for the public to consider: (i) the transfer of data from registrars and registries to escrow providers and ICANN, (ii) the transfer of data from registries to emergency back-end registry operators (EBERO), (iii) the definition and framework for reasonable access to registration data, (iv) respective roles and responsibilities under the GDPR, i.e., the responsible parties, (v) applicable updates to ICANN Consensus Policies, and (vi) future work by the GNSO to ensure relevant Consensus Policies are reassessed to become consistent with applicable law. The EPDP Team documented each of the data processing steps, and the purpose and the legal basis for each. This foundational work was necessary to develop GDPR-compliant solutions and is available in the Report's Appendix.

After the publication of the Initial Report, the EPDP Team: (i) sought guidance on legal issues, (ii) carefully reviewed public comments received in response to the publication of the Initial Report, (iii) reviewed the work-in-progress with the community groups the Team members represent, and (iv) deliberated for the production of its Final Report. Consensus calls on the recommendations contained in this Final Report, as required by the GNSO Working Group Guidelines, was carried out by the EPDP Team Chair, as described [here](#).

The GNSO Council [adopted](#) the [Final Report](#) on 4 March 2019. ICANN org commenced a [public comment](#) period on the Final Report on 4 March 2019. The public comment proceeding sought to obtain community input prior to Board action on the final policy recommendations of the GNSO EPDP on the Temporary Specification for gTLD Registration Data. The Summary and Analysis [report](#) for the public comment was published on 23 April 2019. The Board resolved to [adopt](#) 27 of the 29 recommendations, with some exceptions, on 15 May 2019. The Board did not adopt Recommendations 1 in terms of Purpose 2 and Recommendation 12 regarding the deletion of contents in the organization field.

A Consensus Policy Implementation Team was formed to begin work on the implementation plan. An Implementation Review Team (IRT) consisting of members of the PDP Working Group and interested community members was also formed to work with the Consensus Policy Implementation Team in line with the [Consensus Policy Implementation Framework](#) (CPIF) developed by ICANN's Global Domains Division and adopted by the GNSO Council.

The IRT served as a resource to implementation staff on questions related to the adopted policy and technical implementation issues. The IRT has also served as a resource to ICANN organization on the background and rationale of the policy recommendations as well as assisting the implementation team in the planning for the technical implementation of a policy change.

Working in advance of the Board resolution, the implementation team produced the concept of three stages of the policy implementation.

- **Stage 1:** Continue to implement measures consistent with the Temporary Specification for gTLD Registration Data that expires on 25 May 2019. This is an Interim Registration Data Policy while the permanent policy is prepared and published based on the recommendations,
- **Stage 2:** This stage will begin after the ICANN organization publishes a Registration Data Policy as a Consensus Policy and formally notifies the contracted parties. During this stage, contracted parties may implement the Interim Policy, the Registration Data Policy, or elements of both as they prepare for the effective date of the Registration Data Policy. The timing of this milestone is to be determined.
- **Stage 3:** Contracted parties must comply with the Registration Data Policy as of its effective date.

On 17 May 2019, ICANN org published the [Interim Registration Data Policy for gTLDs](#) pursuant to the Board's 15 May 2019 [resolution](#). The Interim Policy effective as of 20 May 2019 requires that contracted parties to continue to implement measures consistent with the [Temporary Specification for gTLD Registration Data](#), which expired on 25 May 2019. The EPDP Team recommended that the final effective date for the Registration Data Policy for gTLDs be 29 February 2020 (see Recommendation 28 from the Phase 1 Final Report). However, given the complexity of the implementation and the possibility of additional input on the recommendations from data protection authorities or other sources there is a possibility that this date has not been met.

ICANN org first met with the IRT to begin work on implementation of the Registration Data Policy on 29 May 2019, including a detailed review of each recommendation and rationale and identification of implementation tasks needed to support these. On 2 October 2019, the Council liaison to the IRT provided an [update](#) to the Council, noting that the recommended date “was deemed to not be feasible due to not providing adequate time for IRT to complete a full review and analysis.” This communication also noted that the “IRT needs to fully understand the implications and not rush a policy that has such a wide impact.”

The Governmental Advisory Committee (GAC) also provided advice to the ICANN Board in its Montreal [Communique](#) to: “take all possible steps to ensure that the ICANN org and the EPDP Phase 1 Implementation Review team generate a detailed work plan identifying an updated realistic schedule to complete its work and provide and inform the GAC on the status of its progress by 3 January 2020.” ICANN org sent a [letter](#) to the GAC chair on 6 January 2020 with a status update as requested by the GAC. In that letter ICANN org cited that the CPIF is being applied, and summarized both this process and progress to date. Additionally, the letter notes that the implementation plan that will be published for public comment will include an implementation timeline.

On 10 August 2020, the EPDP Phase 2 Team published their [Final Report](#) which outlines recommendations for a System for Standardized Access/Disclosure (SSAD) to nonpublic gTLD registration data, as well as recommendations and conclusions for “Priority 2” topics, carried over from the EPDP

Phase 1 discussions. Since the Priority 2 recommendations relate to the implementation of Phase 1 recommendations, the Board considered these four recommendations separately and [adopted](#) the Priority 2 recommendations on 21 June 2021.

Following several discussions between the ICANN Board and GNSO Council, on 24 February 2022, the Board [adopted](#) the GNSO Council's Supplemental Recommendation for EPDP Recommendation 12, concerning the deletion of data in the Organization field as it addresses the Board's overarching concern of loss of essential data.

Next Steps:

ICANN organization will prepare a public comment summary report at the conclusion of the comment period. ICANN organization and the IRT will consider those comments in preparation of the implementation of the updated Registration Data Policy for gTLDs consensus policy. After the implementation plan has been finalized, ICANN's Contracted Parties will be notified of the implementation/compliance deadlines. The publication of the policy is planned for 2023Q1 with an effective date of 2024Q4.

Supporting Information:

All the final recommendations from the Final Report of the Temporary Specification for gTLD Registration Data Expedited PDP have been evaluated by the implementation team and tasks have been determined for implementation. 6.1. Recommendation #1 - Purposes for Processing gTLD Registration Data

- 6.1.1. This recommendation will be addressed in the terms of the data processing agreements with contracted parties, which will include language regarding the ICANN Purposes for processing gTLD Registration Data.

6.2. Recommendation #2 - (Divergence) Additional Purposes

- 6.2.1. This recommendation is a commitment statement by the EPDP team and will be considered as part of Phase 2 of its work.
