## **Subsequent Procedures**

### **Talking Points**

- 1. Expansion of the new generic top-level domains (gTLD) program must benefit all, as the previous round benefited large companies in the developed world.
- 2. Public Interest Commitments (PICs) and Registry Voluntary Commitments (RVCs) must be enforceable and enforced by ICANN Compliance.
- 3. Applicant Support Program design requires further work. ALAC/At-Large participation in that process is needed.
- 4. A notification tool for GeoName applications is needed.
- 5. ALAC must have automatic standing to file Community Objections.

### **Closed Generics**

#### **Talking Points**

- 1. The monopolization of a widely used term, by a single applicant, is significant and should require a high public interest bar.
- 2. The ICANN Board's requirement that a compromise be reached may be problematic because it's possible a ban on closed generics is still the right policy.

## **Domain Name System (DNS) Abuse**

#### **Talking Points**

- 1. Registrant data and its **accuracy remains critical to combat DNS abuse** and identify bad actors. Efficient access to redacted registrant data is critical.
- 2. Registry Agreements and Registrar Accreditation Agreements **need refinement** to empower ICANN org's Office of Contract Compliance to deal more effectively with bad actors.
- 3. Contracted Parties should be incentivized to adopt a more transparent, better articulated minimum compliance standard. They should be encouraged to adopt acceptable general business practices such as Know Your Customer (KYC), especially with bulk registrations.
- 4. ICANN org must continue to **improve its data collection and understanding of DNS abuse** as it relates to end users.
- 5. ICANN org must continue to **provide reliable and actionable DNS abuse information** to the community.
- 6. ICANN should **invest in capacity building for individual end users on prevention measures and fraud reporting** needed to reduce victimization.
- 7. ICANN should consider investment in technology, for use by all contracted parties, to mitigate malicious registrations.

### Internationalized Domain Names (IDNs) and Universal Acceptance (UA)

#### **Talking Points**

- IDNs are critical to individual user equity online.
- 2. IDN variants can support better individual Internet end-user experiences.
- 3. IDN variant management must ensure the security and stability of the root zone.
- 4. Adjustments to relevant processes and policies for the domain name life cycle must be considered carefully.

## **Transfer Policy Review PDP**

#### **Talking Points**

- Processes and policies must make Inter-Registrar Transfers and <u>Change of</u> <u>Registrant</u> updates simple, safe, and secure.
- 2. Registrars are obligated to inform the Registrant about the transfer processes in an understandable way.
- 3. This includes, but is not limited to, the processes and requirements for the Registrars to give Registrants access to the TAC, and distribute this in a simple, safe and secure way.
- 4. Must address reseller complexity.

## **Registration Data**

#### **Talking Points**

gTLD Registration Data Accuracy Scoping | Community Wiki Space

- At-Large strongly supports resumption of some level of analysis [such as the former Accuracy Reporting System (ARS)] to determine the current level of accuracy within the RDDS data. The number of contact fields was radically reduced as part of the EPDP Phase 1 and we have no current data.
- 2. At-Large supports getting confirmation from the European Data Protection Board (EDPB) that it has a legitimate right to access redacted RDDS data for the purpose of measuring its accuracy.
- 3. At-Large supports an independent study of the value of and feasibility of cross-filed verification (as required by the 2013 RAA but never enforced).
- 4. At-large supports a system to track requests for disclosure of nonpublic gTLD registration information.
- 5. Accurate contact data is important for individual end users as it facilitates law enforcement and cyber-crime professionals to reduce activities associated with fraud and related domain name abuse. It is also useful in case there is a technical issue with a website.



## **Registration Data - Talking Points Continued**

#### EPDP-TempSpec Recommendations (EPDP-TempSpec) | Community Wiki Space

- 1. At-Large supports a WHOIS disclosure system.
- 2. At-Large supports a disclosure system automated to the greatest extent possible.
- 3. At-Large supports having a mechanism for review and improvement of any disclosure system to allow it to evolve and to ensure efficient operations.
- At-Large supports a disclosure system with Service Level Agreements (SLAs) and response times that assure a secure and stable DNS ecosystem.
- 5. At-Large supports a disclosure system that is financially sustainable.
- 6. At-Large supports differentiation between natural and legal persons.
- 7. At-Large restates the importance that ICANN processes gTLDs registration data for the purpose of contributing to the security, stability and resilience of the DNS.
- 8. At-Large recognizes WHOIS data accuracy as an important matter that needs to be assured.

# System for Standardized Access/Disclosure (SSAD) Operational Design Assessment (ODA) | Community Wiki Space

- 1. Consumer protection is a priority.
- 2. At-large supports a system to track requests for disclosure of nonpublic generic top-level domain (gTLD) registration information.
- 3. At-Large supports future efforts to ensure differentiation between Legal (i.e., companies) and Natural (i.e., private individual) persons.
- The At-Large supports the development of the System for Standardized Access/Disclosure (SSAD) Light Design (now being referred to as the "WHOIS Disclosure System" in order to determine the next steps regarding the
  SSAD recommendations.
