## Hello All,

Just some thoughts on a follow up to the DNS Abuse session in the ccNSO.

I think it would be useful to have targeted survey of ccTLD managers to cover approaches to DNS Abuse which could include:

- What validation of registrants is done prior to registration if any
- What checking is done in the 48 hours following registration either manual or automated
- If an issue is detected immediately after registration what steps are taken e.g. immediate domain suspension etc
- What mechanisms are in place or a member of the public to directly report DNS abuse
- What trusted notifiers do you use (ie you do not separately do your own due diligence it sounds like the most common category for this is CSAM material)
- Does the Government in country have the legal power to direct take-downs for DNS Abuse by the ccTLD manager, rather than just make a request and where you do you own due diligence
- What DNS Abuse feeds are being used and which have been found to be the most reliable/trusted
- When a name is identified in a DNS Abuse feed what steps are taken e.g. 48 hours for the registrant to correct, followed by take down etc.

If this is an idea that is supported – I would be happy to take the lead in drafting a survey and sharing with the group to refine.

Once we have the survey results – we would summarise common approaches.
