## **Council Small Team on DNS Abuse: Update**

- Small team gathered input from SGs and ACs on DNS Abuse and are finalizing a report summarizing findings
- Recommendations to continue efforts in outreach and on CPH-developed anti-abuse tools and guidelines (e.g., guides for abuse reporters)
- Notes potential ambiguity in contracts based on ICANN Compliance feedback, recommends sending a letter to CPH to get their feedback
- After outreach and consultation with CPH, report will recommend "tightly scoped PDP" on malware, phishing, and botnets should the council believe this is warranted.

#### **AGP Limits**

- AGP Limits Policy implemented in 2009 to combat domain tasting
- Exceeding month AGP limit may not allow refunds from registries
- Maliciously registered domain names are often registered fraudulently
- Disincentivized to delete abusive domains within AGP
- RrSG proposal: exempt malicious domains from AGP and refund ICANN fee
- Goal: encourage registrars to identify and delete malicious domains quickly without financial penalty

## **Update on DPS Negotiations**

- The DPS is simply the legal mechanism to transfer data and comes out of the EPDP Phase 1 requirements.
- The CPH negotiation team held meetings during ICANN 74 and had one longer working session prior to ICANN 75.
- A small number of outstanding issues remain.
- We are trying to find time during glCANN 75 or soon after to wrap up these final issues.
