The deadline for voting in this round is fast approaching: voting will close on **Thursday, 30 November 2023 (23:59 UTC)**. Have you already voted? No further action is needed.

A majority of all the Emissaries in the Geographic Region entitled to vote constitutes a quorum. The winner is the candidate who receives the plurality of the votes. As only one candidate was nominated and seconded within the nomination period for the other ICANN geographical regions, no elections needed to be held in those regions.

## Business continuity implementation for small ccTLDs

### TLD-OPS Disaster Recovery and Business Continuity Playbook

In 2019, the TLD-OPS Standing Committee released its Business Continuity and Disaster Recovery (BC/DR) Playbook. The playbook is aimed at the senior and/or middle management of ccTLDs with a commitment, sponsorship and mandate to develop resilience to disruptive events in the form of a business continuity plan.

The Playbook includes:

- examples that can be used as templates or inspiration for the development of disaster recovery and business continuity plans
- tools to help a ccTLD conduct its own table-top exercise
- practical sample tables that can be copied and used at different stages of disaster recovery and business continuity development and implementation.

The BC/DR Playbook is available for download in the following languages Arabic, Chinese (Simplified), French, English, Spanish and Russian.

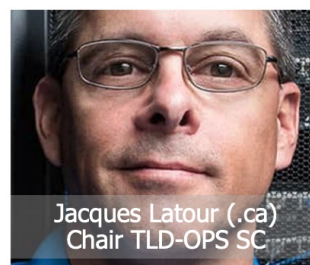

### Getting ready for the next workshop

At ICANN66 (Montreal, November 2019), the ccNSO Top-Level Domain Operations (TLD-OPS) Standing Committee held a workshop to test its draft Disaster Recovery and Business Continuity Playbook, which serves as a basic business continuity implementation guide for small ccTLD operators.

Given the positive feedback from the previous workshop, the TLD-OPS Standing Committee will hold a next edition with some modifications. Scenarios for the future workshop could include ransomware, DDoS, natural disasters, global pandemics, etc.

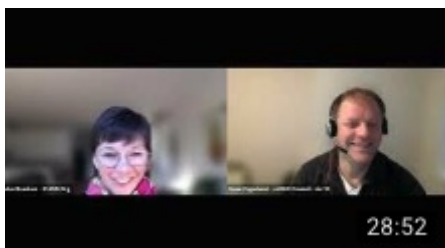
## ccNSO launches Statement of Interest procedure

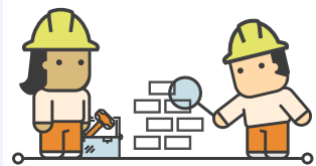
In 2023, the ccNSO celebrates its 20th anniversary. Representatives from the ccTLD community have reflected on
