# COMPILATION OF THE OPERATING PRINCIPLES OF THE REGIONAL AT-LARGE ORGANISATIONS

## Introductory Note

Prepared by the ICANN Staff

The following pages contain a reproduction of the texts of the Operating Principles for the Latin America and the Caribbean and Asia/Australia/Pacific Regions.

As further such documents are concluded, they will be annexed hereto and the document number and date above revised.

## *Introductory Note:*

The text set forth below constitutes the final version approved by consensus of the Third Session of the Meeting of the ALS of Latin America and the Caribbean held in Sao Paulo, Brazil on 4 December 2006. Negotiations on this text were conducted in Spanish.

#### OPERATING PRINCIPLES OF THE LACRALO

- 1. The LACRALO is composed of the ALSs of Latin America and the Caribbean accredited by the ALAC as a mechanism to promote and ensure participation by regional users in the process of developing ICANN policies.
- 2. The LACRALO will promote the formation of user groups and their accreditation by the ALAC. Nevertheless, mechanisms will be maintained to ensure that the regional users not integrated into ALSs can express their opinion on the development of ICANN policies.
- 3. The LacRALO will be multilingual from its inception. All documents will be written and all discussions will be held in English and Spanish. It is planned to add Portuguese and French in the near future and to periodically reassess the need to add other languages used in the region.
- 4. The governing body of the LacRALO will be a General Assembly composed of two (2) representatives of each accredited ALSs, freely appointed or removed by each ALS, which shall inform the Secretary of the appointments made.

Said individuals shall also act as official contacts of the ALS vis-à-vis the LACRALO for the duration of their appointment.

The General Assembly shall, to the extent possible, operate by consensus. If a consensus cannot be reached, each ALS accredited in the General Assembly shall be entitled to one vote and those votes shall decide by simple majority any matter put to vote. In the event of a tie vote, the person chairing the meeting shall have the casting vote.

5. The General Assembly shall be entitled to set up various *ad hoc* task forces to deal with specific topics.

- 6. The LACRALO shall be assisted by a Secretariat; the duties of said Secretariat may be performed by an ALS member appointed by the General Assembly.
- 7. The Secretariat shall have administrative and informative functions. IT will be responsible for maintenance of the communications systems and the proper flow of information on matters under discussion among all the ALSs belonging to the LacRALO, and any other responsibilities assigned to it by the General Assembly.
- 8. The LACRALO shall elect two (2) individual to serve as representatives before the At Large Advisory Committee (ALAC) on the terms specified in the ICANN By-Laws. Only those ALSs that have been accredited prior to the election shall be entitled to vote in the election. Each accredited ALS shall be entitled to one vote. The selected representatives shall be members of various ALSs, have their main places of residence in countries of the region, and their nationalities must be distinct. The representatives shall be responsible for the duties stipulated by the ICANN By-Laws.

In the case of the election, the affiliation, residency and nationality shall also be taken into account with respect to the person acting as a representative vis-à-vis the ALAC on behalf of the LAC appointed by the NONCOM.

9. The term of office of the two representatives elected by the LACRALO vis-à-vis the ALAC shall not exceed two (2) years and they may not be re-elected.

First Temporary Provision: The term of office of the initial members shall be two (2) and three (3) years respectively, and a new representative shall be elected upon expiration of their terms. In that manner, a candidate will be voted for each year. In the case of the first representative elected for two years, re-election for a single two-year term will be possible.

## Operating Principles of the APRALO

## PART 1: GENERAL

## 1 Name:

1.1 The name of this organization shall be the Asia Pacific Regional At-Large Organization. ( hereinafter referred to as "APRALO" )

## 2. <u>Definitions:</u>

2.1 In these Operating Principles the words standing in the first column shall bear the meaning set opposite to them if inconsistent with the subject or context.

"ALAC"	.At-Large Advisory Committee
"ALS"	At -Large Structure
"APRALO"	Asia Pacific Regional At-Large Organization
"ICANN	Internet Corporation for Assigned Names and Numbers
"RALO"	Regional At-Large Organizations
"Member"	.A full member of the APRALO unless otherwise specified
"Region"	Geographic Region as defined by ICANN
"Provisional Member	The status belonging to an organisation that has applied for ALS status, and has been endorsed by APRALO to ALAC, during the period between the APRALO's endorsement and the decision on the application by ALAC.

## 3. Objectives:

3.1 This body is formed with the following objectives:

- 3.1.1 to provide a forum and promote and encourage Asia/Pacific Internet users' participation and involvement in ICANN in an open, accountable and transparent manner;
- 3.1.2 to promote, understand and advocate for individual Internet users and to provide a forum for outreach, co-ordination and exchange of information and knowledge for persons who live in the Asia Pacific region as defined herein;
- 3.1.3 to act as an interface between individual Internet users and ICANN and to promote skills development and information exchange related to the Internet amongst Members;
- 3.1.4 to bridge the digital divide and encourage users in developing countries to participate in APRALO.
- 3.1.5 to select two individuals as representatives of the Members of APRALO to ALAC;
- 3.2 APRALO shall be certified by ICANN and abide by the by-laws of ICANN regarding individual users' participation and involvement.

#### PART II MEMBERSHIP

## 4. Membership

- 4.1 All ALS in the Asia Pacific region shall be Members of the APRALO.
- 4.2 There shall be no limit as to the number of Members of the APRALO.
- 4.3 All Members and Provisional Members shall be entitled to attend and participate at all Meetings and be entitled to access information via a publicly accessed World Wide Web site maintained by APRALO.
- 4.4 All Members and Provisional Members shall be entitled to participate in APRALO mailing lists

#### PART III: MANAGEMENT

## 5. The Chairperson, Vice Chairperson and Secretariat:

5.1 The Chairperson shall be selected for a period of two years and shall act as Chairperson at all APRALO Meetings and shall represent the APRALO in its dealings with outside entities.

- 5.2 The vice-chairperson shall be selected for a period of two years from the first annual general meeting and shall assist and deputize for the Chairperson in the latter's absence.
- 5.3 A secretariat for the APRALO may be appointed.
- 5.4 The secretariat shall be responsible for recording meetings and performing administration functions.
- 5.5 If a vacancy occurs a replacement for the remainder of the term shall be selected at an extraordinary Meeting

## Part IV: MEETINGS

## 6. Meetings

- 6.1 The APRALO shall hold once every year an Annual General Meeting, in addition to any other meetings in that calendar year, and not more than fifteen (15) months shall elapse between the date of one Annual General Meeting and that of the next.
- 6.2 The fiscal year shall be from July 1 to June 30.
- 6.3 The Annual General Meeting or a Meeting shall be held at a venue accessible to all members physically and/or electronically and shall be called with at least thirty (30) days notice and shall specify the time, date and venue of the Meeting and an agenda.
- 6.4 A quorum at any Annual General Meeting or Meeting shall be one third (1/3) of the Members, or seven (7) members, whichever shall be greater.
- 6.5 The Chairperson shall announce the results of any decision that has been made to the entire membership in a timely manner.
- At any meeting where at least one half (1/2) of members are present, a motion to amend, change, or repeal the Operating Principles may be initiated. Two-thirds of the whole membership must consent for the motion to carry.
- 6.7 All Meetings shall be public.

## 7. Decision Making

7.1 Unless otherwise specified herein, to the extent possible all decisions shall be made by consensus; if a consensus cannot be reached then a vote shall be held. Only those ALSes that have been accredited prior to a vote will be able to vote. Each accredited ALS will have one (1) vote.

7.2 Where a vote is needed, it may be carried out using such electronic and or on-line means (including web applications, e mail and/or video or tele-conferencing) as determined appropriate by the chairperson.

## 8. Dissolution

- 8.1 APRALO may be dissolved by a two-thirds vote of the entire membership if:
  - 8.1.1 it is determined the objectives of APRALO have been achieved and its existence is no longer necessary, or;
  - 8.1.2 it is determined that APRALO will no longer be able to function effectively, or;
  - 8.1.3 the number of Members is less than the minimum required by the ICANN Bylaws for a RALO.
- 8.2 A motion for dissolution may be passed at a General Meeting provided notice of the intent to move for Dissolution is given to all Members 90 days before the Meeting is held.
- 8.3 Any motion for dissolution must provide for the disposal of any assets of APRALO.

**IN WITNESS WHEREOF,** these Operating Principles are initialled this 28th day of February 2007 by the ALS representatives present this day, confirming their consensus approval of this text and signalling their intent to sign it subject to ICANN General Counsel's positive review and a public comment period.
