About Us

LACRALO (Latin American and Caribbean Islands At-Large Regional Organization) is comprised of the ALSs (At-Large Structures) in Latin America and the Caribbean, accredited by ALAC (At-Large Advisory Committee), as a mechanism to ensure and promote the regional users participation in the policy development processes of the Internet Corporation for Assigned Names and Numbers. ICANN manages the domain name and unique identifiers of the Internet, such as domain names and IP addresses. LACRALO connects civil society organizations representing the interests of the Internet's individual end users in Latin America and the Caribbean, making it possible to get our voices and opinions heard within ICANN's bottom-up, consensus-based multi-stakeholder process of global Internet development.



LACRALO has different and varied organizations in Latin America and the Caribbean Islands, which are organized in At-Large Structures (ALSs) working on issues related to the development of the Internet. To ensure that the perspectives of Latin America and the Caribbean are represented, we invite Internet user organizations from throughout the region to join us. If your organization focuses on improving security and privacy issues of the Internet's final users and/or on consumer protection, participate and join us!

"At-Large"

"At Large" is the name for the community of individual Internet users involved in ICANN's policy development process. There are currently over 136 active At-Large Structures representing the opinions of Internet users.

At-Large provides a participation space so that worldwide individual end users can participate In matters that are part of ICANN's work, such as:

- Guidance on how to run Internationalized Domain Names (IDNs):
- · How to introduce new gTLDs (.info, .name, .museum);
- How to implement a stable and fair transition from IPv4 to the next Internet addresses generation, IPv6.

About ICANN

To reach another person on the Internet you have to type an address Into your computer - a name or a number. That address has to be unique so computers know where to find each other. ICANN coordinates these unique identifiers across the world. Without that coordination we wouldn't have one global Internet. ICANN was formed in 1998. It is a not-for-profit publicbenefit corporation with participants from all over the world dedicated to keeping the Internet secure, stable and interoperable. It promotes competition and develops policy on the Internet's unique identifiers. Through its coordination role of the Internet's naming system, ICANN has an important impact on the expansion and evolution of the Internet.

Our Main Topics

ICANN's policies affect us all, every time we connect to the Internet. We in LACRALO are particularly interested in addressing issues such as: new generic top-level domains (gTLDs), trademarks, Internationalized Domain Names (IDNs), transition from IPv4 to IPv6, representation and protection of Internet endusers, democratization of ICANN, multilingualism and civil society participation.
