- 1967-70, research worker at CNRS (French national centre for scientific research) : acquired the tools and discipline of research

- 1971-2005, diplomat at the French ministry of foreign affairs, including as Ambassador for ten consecutive years (Ambassador & Permanent Representative to WEU in Brussels 1995-1998, Ambassador to Estonia 1998-2002, Ambassador to Finland 2002-05)
- 2005, acting Governor for France, Board of Governors, ASEF (Asia-Europe Foundation)
- 2005 August, retired from the diplomatic service
- 2005-06, consultant
- 2008-09, tutor at ENA (French national school of public administration)
- 2007-10, Chairman of the Advisory Board, Institut Pierre Werner, Luxembourg
- 2007 (till the end of 2010), Member of the Board of Directors, ICANN
- 2009- , Senior advisor to the Board, CCRN (Centre culturel et de rencontres Neumünster), Luxembourg, and member of the Board, EUNIC (European Union National Institutes for Culture)
- frequent speaker in conferences; articles & interviews on trends and future challenges, on international affairs, on the European Union, on Asia, on defence & security, on governance, on culture & society, on the social, cultural and economic dimensions of the Internet

  - Since early 2008, I have promoted and/or supported initiatives at the Board level, for example
    - the creation of a seat on the Board of Directors, to be filled by a person proposed by the At-Large community
    - the enhancement of the international dimension of ICANN, e.g. in Staff recruitment, in Board appointments, in call for tenders from consultants wishing to be selected as independent reviewers, in the provision of linguistic services in ICANN's international meetings, etc.
    - the creation of a Board committee for international & institutional affairs (finally implemented by a Board decision in August 2010, establishing the BGRC, Board Global Relationships Committee)
    - speaker at several sessions of "ICANN Studienkreis"
    - attended all IGFs so far

Overall experience:

- responsibility (Ambassador for 10 years; tutor at France's top school of public administration)
- planning, financing, implementing and evaluating policies and projects (official development aid, social and educational projects, foreign policy)
- representation (as a diplomat for 38 years, of which 10 as an Ambassador)
- public diplomacy at a high level (conferences, speeches, interviews, articles)
- working with, and sometimes leading, teams made up of professionals from various cultural and linguistic communities
- personal involvement in various cultures, and knowledge of some languages
- respect is an absolute rule, not an option

Service at ICANN:

- member of the Board
- engaged in many tasks, beyond the basic obligations of a Board member: served on several committees, first chair of a new committee (Public Participation), served on several Review Working Groups (Board Review, ALAC Review, ccNSO Review as Chair)
- supported the At-Large Summit in Mexico, where I was honoured to be invited as a speaker
- was instrumental in the creation of a Board seat to be filled by a person selected by the At-Large community
- advocated, since early 2008, oversight by a Board committee of the international and institutional dimensions of ICANN
- helped the CEO establish stronger relations (e.g. in France)
- the PPC, which I chair, has defined a linguistic policy for ICANN, a policy on document deadlines (15 working days before an ICANN international meeting), a long-term plan for public participation (with a public consultation on its content), improving the format and style of the Public Forum ICANN international meetings, improving remote participation (from Nairobi onwards)...
- contributed to the preparatory work on IDNs, and represented ICANN at the launch of one of

them (DotTaiwan in Chinese script, August 2010)

- the fact that, sometimes alone among Board members, I abstained or voted against resolutions which, in my mind, would not serve the wider public interest of the Internet and its users
- the ability to approach issues from several standpoints, thanks to experience gained in a variety of committees and working groups
- familiarity with the international dimension of ICANN, which is of growing importance
- seniority of experience

Under sections 1, 2 and 4 above, I have outlined what I think I could bring to the Board.

Once a person is appointed to the Board of ICANN, she/he no longer represents the interests of any particular stakeholder or segment of the ICANN community. Each and every member of the Board has the obligation to take into consideration all these factors, but ultimately to vote or determine her/his position with the public interest in mind. This is currently, and will remain, my guideline.

The history of the Internet and of ICANN can be viewed in archeological terms:

- the deeper strata are made up of pioneers (military, academic, engineers)
- Next came the diversification of users and usages (commercial interests, trademark lawyers, NGOs, ordinary users)
- The uppermost strata is ICANN today: multistakeholder and (hopefully) bottom-up. But we must face new challenges.
- The coming challenges are of a different nature: they will require a better knowledge and professional competence in international affairs, in the internal and external governance of ICANN, in cultural and linguistic diversity.

I think I can bring a useful contribution in this respect.
