The Association unites over 100 Ukrainian and international members and during 10 years the Association has provided legal and policy protection for its members and lobbied open policy for Ukrainian Internet market. My role is research of the best international practices for Internet and representation of the Ukrainian Internet community interests in international organizations.

In 2004 I've been a Board member of Ukrainian Internet Association and conducted several personal consultations and trainings for a new class of Internet businessmen how to promote their interests on policy and legal level using open, transparent, and legal processes.

From 2001 till 2005 I have been a consultant for UN Development Program and Open Society Institute in Ukraine and helped several professional and business associations to establish sustainable non-corrupted relationships with Ukrainian parliament and government. During 9 months in 2005-2006 I have been involved by the then prime minister to help with establishing of transparent and open relationships with business and professional communities for development market-oriented policies.

I am 35 years old professional woman with masters in law and business administration, who reside in the US and Ukraine and understand the diversity of the modern world and society. As a lawyer with strong academical education and comprehensive experience in practical law, policy, and governance I understand task and decision making complexity and I am ready to put all my knowledge and capacity for development of symmetrical and sustainable decisions that meet Internet community expectations. I am willing to serve as volunteer and be involved in everyday ICANN and At-Large activities, because I get encouragement not only from the Ukrainian Internet community but my family also supports my efforts for development open and accessible Internet.

Finally, as professional lawyer and individual with strong moral characteristics I am ready to separate local interest of Ukrainian Internet Association and global role of ICANN Board Director and acknowledge the priorities of both statuses.

I am sure that my biggest contribution in the Internet development is my leading role in the development of Ukrainian legislation that stopped the monopoly of national telecom and initiated the era of the Internet for everyone. That legislation supported development of local independent Internet providers that provide low-price service for customers and governmental support for the Internet usage by educational and social institutions. After more than 3 years involvement in policy and legislation development the Ukrainian parliament passed the Law that established open and transparent rules for the Internet.

However just policy and legislation changes cannot impact society and government, therefore I contributed a big effort to education and training for professional and civil society organizations that represent wide range of interests of the Internet community: business, users, policymakers, and content providers. In cooperation with such global institutions as the UN, the Open Society Institute and others I developed a system of public activities with participation of civil society, government, and business that established efficient and result-oriented dialog between all parties. It was the first experience for Ukrainian government, especially intelligence agency that has a special interest in th Internet regulation, in such dialog and I am happy that the practice of such events is happening even I've stopped my active involving in this process. I think that is a sign that proposed by me approach is sustainable for such country as Ukraine that has very unstable governance.

62 years ago when the United Nations General Assembly adopted the Universal Declaration of Human Rights the definition of "human" was unspecified and had many interpretations, therefore during next decades the UN adopted other declarations and documents that specified rights for different groups as women, children, immigrants, etcetera. Like human, an individual Internet user needs core rights and interests description, but at the same time the definition of an individual Internet user has to be specified and developed within the scope of ICANN mission. As Board Director I will promote an idea that an individual Internet user is not an individual in the abstract, but real persona or group whose needs and problems can be resolved with ICANN participation and ICANN has to be concerned about an individual Internet user needs.

I never been involved in ICANN activities directly, so I think that I can present the fresh and detached point of view that needs for holistic and sustainable decisions.
