ICANN76 Highlights

[ICANN76 was a Community Forum](#) organized as a hybrid meeting in Cancún, Mexico from 11–16 March 2023.

- Prior to the meeting, the ICANN76 [Prep Week materials](#) & [Policy Outlook Report](#) were released.
- Meeting was attended by 1168 people in person and 799 registered to attend virtually.
- Universal Acceptance, Internationalized Domain Names (IDNs), and the next round of new generic top-level domains (gTLDs), the challenges ICANN is facing such as Domain Name Abuse and future of technical internet governance were discussed.
- ICANN Board [adopted](#) 98 recommendations from the [New gTLD Subsequent Procedures Policy Development Process Final Report](#) and directing ICANN org to deliver a comprehensive implementation plan by 1 August.
- The contracted parties approved proposed [contract amendments](#) to improve the WHOIS system by which will now be tabled to the Board to consider the proposed amendments.

At-Large @ICANN76

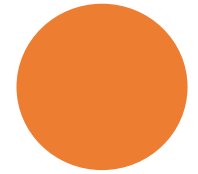
- At-Large held 12 sessions @ ICANN76 under the three At-Large work streams of: policy, outreach and engagement, and operations.

 - Three joint session with the ICANN Board, Supporting Organizations and other Advisory Committees (ALAC & GAC discussed DNS Abuse and ways to improve accessibility to ICANN documents for ICANN community members and newcomers ; ALAC & SSAC discussed DNS Abuse; ALAC & ICANN Board discussed ALAC letter to the ICANN Board on the SubPro ODA and previous ALAC advice on the New gTLD SubPro ODP)
 - Two RALO sessions (RALO Coordination)
 - An At-Large Welcome Session
 - At-Large Wrap-Up Session.
- During the meeting, over two days the Latin American and Caribbean Regional Organization (LACRALO) held its General Assembly.

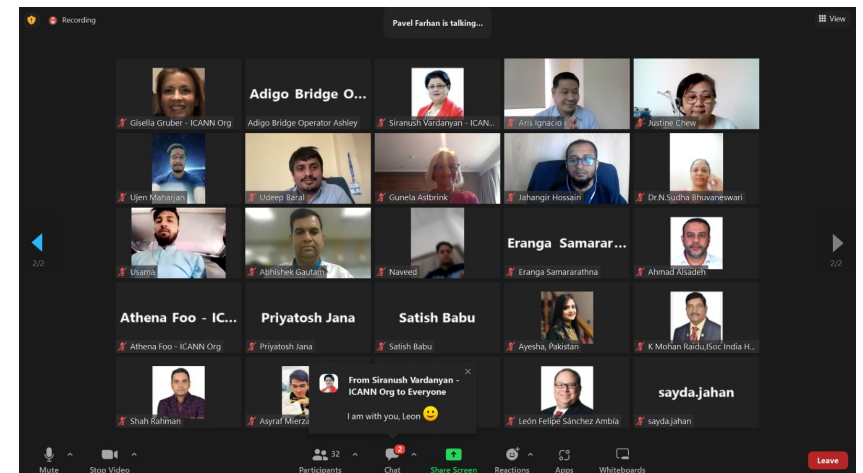
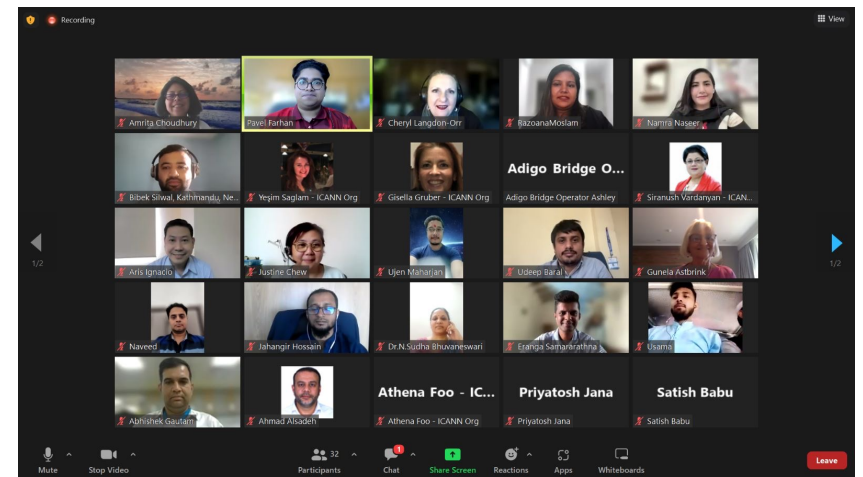
An Overview of ICANN76 was made by the ICANN Fellows & APRALO Young brigade. The discussion was moderated by Aris Ignacio .

ALAC Subcommittee on Outreach and Engagement

APRALO is actively engaging in outreach and engagement initiatives. Recently, different ALSes across the Asia Pacific region held Universal Acceptance (UA) Days in March 2023.

Additionally, on May 26, 2023, IN2ITION 2023: 2nd Philippine Youth Internet Governance Forum (PhYIGF), will take place at the Luxembourg Hall of Southville International School and Colleges in Las Piñas City, Philippines. The event will feature local speakers and facilitators from the technology and internet governance field, and students and youth from across the country are expected to participate. This year's theme is "Emerging Technologies in the New Normal".

To plan for the upcoming APRALO General Assembly, primary representatives from ALSes are reminded to complete a survey that will determine the number of onsite and online participants. The GA is scheduled for September 12 and 13 in Istanbul, Türkiye.

In addition, the APAC DNS Forum 2023 will take place on July 4 and 5 at the Hong Kong Convention and Exhibition Centre, located in downtown Hong Kong. The event will be in hybrid mode, allowing attendees to participate either onsite or online. UA Day Armenia

On March 28, 2023, Armenia joined the International UA Day and held a Regional Conference on IDN and EAI in Yerevan, Armenia (<https://uaday.am/en/>). The event was co-organized by the .am/.huj ccTLD manager and the ISOC Armenia Chapter and supported by the Ministry of the High-tech Industry. It brought together around 100 participants from 7 countries.

The conference program included a plenary session where representatives of the key international Internet organizations discussed the issues of increasing inclusiveness and development of multilingualism in the global Internet; a marketing section for the promotion of internationalized domain names; a technical section on implementation features: the five universal acceptance criteria in software and successful examples in this field, as well as the EAI manual for configuring mail systems.

Participants and representatives of international Internet organizations (ICANN, ISOC, APTLD, etc.) discussed the prospects for the development of the global network as a multilingual environment , the technical aspects of implementing the IDNA and EAI standards.

The conference ended with a training on configuring mail systems with full support for the EAI standard.

Also, within the framework of the conference the Working Group of the Regional Coordination Group on Universal Acceptance of the CIS countries and Eastern Europe held a meeting.

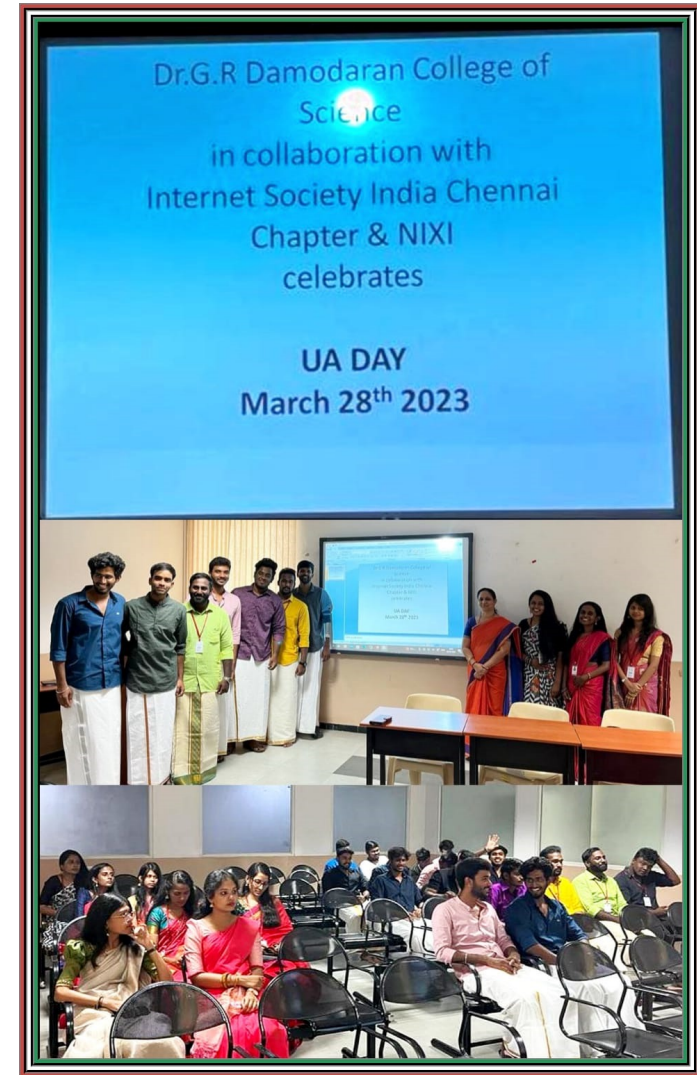
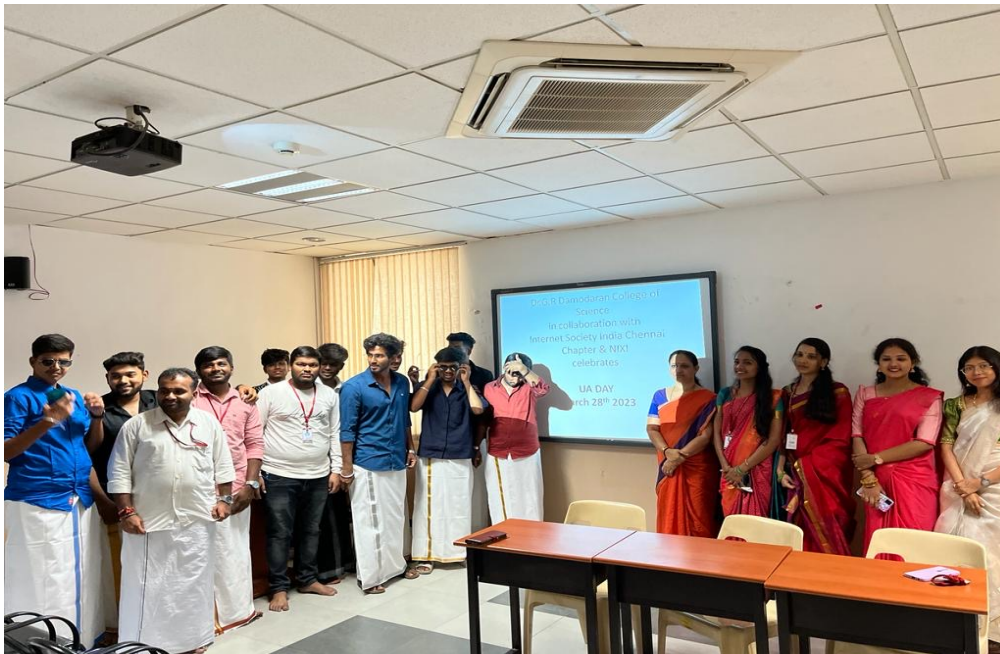

Updates From Our ALSes

.MY ICANN76 Readout

The Malaysian Communications and Multimedia Commission (“MCMC”) through the Numbering and Electronic Addressing Management Department (“NEAMD”) organised its inaugural ICANN Readout on 29 March 2023.

A virtual event, the **.MY ICANN76 Readout Session** provided the 162 participants from various departments under the MCMC an account of proceedings from the ICANN76 Community Forum that was held in Cancun, Mexico from 11-16 March 2023. MCMC is the Malaysian government agency entrusted to promote and regulate the communications and multimedia industry and to enforce the communications and multimedia laws in Malaysia.

The four speakers who headlined the event are Mohamad Afiq Ammar Tulos, Deputy Director, Numbering and Electronic Addressing Management Department, Licensing and Monitoring Division of MCMC (representing GAC - Malaysia); Tan Yien Chyn, Stakeholder & Engagement Manager, ICANN APAC; Yeo Lee Ling, Legal Manager, MYNIC (the .MY ccTLD operator); and Justine Chew, ALAC Liaison to the GNSO (representing the ALAC and APRALO).

Justine spoke about the ALAC, the At-Large Community, and our work on Subsequent Procedures and DNS Abuse Mitigation, as well as APRALO's special interest in Universal Acceptance (UA) and Internationalized Domain Names (IDNs) - in particular, that APRALO members are actively promoting UA, and participating in policy development for IDN variant management through the Expedited Policy Development Process on Internationalized Domain Names (EPDP on IDNs).
