- ICANN74 Policy Forum Meeting was organized from 13-16 June in Hague. The ICANN74 Prep week from 31 May-2 June. This hybrid meeting was attended by 1,817 attendees from 101 countries and territories—917 in person and 900 remotely.
- During the meeting the <u>ICANN Community</u> <u>Excellence Award 2022 was awarded to</u> <u>Vanda Scartezini</u> from LACRALO.

## **ALAC Call**

The ALAC call in July had updates presented by ICANN Board Vice Chair Leon Sanchez on the board activities, updates on ALAC policy development activities; updates from the ALAC leaders and liaisons and discussions on the At Large activities and preparations for ICANN75

## **APRALO Call**

There was no APRALO monthly call in June. In the July monthly meeting, updates were provided on the upcoming ICANN75 meeting preparations, current policies being discussed in CPWG, updates from the hot topic survey initiative of APRALO policy forum and updates from the engagement working group.

## **APRALO Policy Forum: Fireside Chat**

After kicking off its latest initiative - the Fireside Chat Program - in May 2022, with the inaugural Fireside Chat: <u>Let's Talk</u> <u>About PDP 3.0</u>, the APRALO Policy Forum produced another 2 Fireside Chats in June.

Let's Talk About Closed Generics, held on 8 June 2022, saw Olivier Crépin-Leblond, Co-Chair of the At-Large CPWG chatting with Holly Raiche, APRALO ALAC Member on how the issue of closed generics might impact Internet end-users. In engaging audience participation on examples and scenarios of strings that might qualify as closed generics Holly also discussed some factors in favour of versus against closed generics being made available for application in the next round of new gTLDs.

Participant Raymond Mamattah commented, "The event was very well organized, with experts who know much about the topic. One interesting part is it was very engaging and we the participants were very much involved as well. For instance, I asked a question and I was asked to share my thoughts on what I think about the question, which of course generated into great chats. In all, I think it will be good to do [a] series of by-the-fire-side concept events. Well done to the organising team."

## **APRALO Policy Forum: Fireside Chat**

<u>Let's Talk About Transfer Policy</u>, held, on 29 June 2022, had **Jonathan Zuck**, ALAC Vice Chair for Policy and Co-Chair of the At-Large CPWG, speaking with **Steinar Grøtterød**, Member of the GNSO Transfer Policy Review Policy Development Process Working Group (TPR PDP WG) selected by the ALAC.

That conversation focused on identifying the impact of the 2018 General Data Protection Regulations (GDPR) on existing ICANN Policy around inter-registrar transfers of domain name registrations insofar as registrants and/or individual end-users are concerned. It also highlighted recommendations proposed by the TPR PDP WG to make such transfers less onerous but without forsaking certain safety mechanisms aimed at protecting registrants.

Participant **Samik Kharel** shared, "Although slightly technical, the third fireside chat on transfer policy was extremely valuable for me as a domain owner and a policy enthusiast. In the talk, ... operational and transfer hurdles were discussed, inline with how the transfer policy has been struggling to be updated inline with the GDPR. It .. made me realize how everything is intertwined with each other in a policy. It would be great if we could also make some pointers and summary from each fireside chat and distribute it amongst our peers. Shoutout to Jonathan Zuck and Steinar Grøtterød for trying to simplify things for non technical folks."

## **APRALO Policy Forum**

A brief post-mortem of the 3 Fireside Chats revealed, among others, the following insights:

- 92% of participants like or really like the informal style of the chats;
- 95% of participants found the chats to be either very useful or useful in presenting an overview of each topic; and
- 95% of participants found the Guest Speakers to be either very helpful or helpful in sharing knowledge and addressing questions on the respective topics.

Based on the overwhelming support, we plan to continue the series in due course, amid organizing a few events for ICANN 75 in Kuala Lumpur. In the meantime, recordings of all 3 Fireside Chats can easily be accessed at the <u>APRALO Policy Forum Fireside Chats Wiki Page</u>.

## **Operations Finance and Budget Working Group Update**

The work of the OFB WG follows the annual cycle of ICANN Planning, starting in May-June with the Operating Initiatives, followed by the development of the IANA Operating Plan and Budget in late July-August and then in September-October working on the ICANN Operating Plan and Budget based on the ICANN Planning cycle.

The OFB WG recently reviewed the outcomes of the ALAC/RALO Chairs Strategic Trends workshop. The workshop, run by ICANN planning, asked the participants to contribute their own views of ALAC priorities under six headings: Security, ICANN governance, Unique Identifiers, Geopolitics, Financials and Trends. Some of the hot topics for the participants included several aspects of DNS Abuse, issues surrounding attracting and assisting new members to ALAC, and impacts of global issues on ICANN. The outcomes from the workshop will inform the ALAC responses to Operating Initiatives in the ICANN budget.
