# Safer Internet Day and Youth IGF Movement Russia (Together against Cybercrime, EURALO ALS)

On February 18, 2020, at the Higher school of Economics (Moscow), we held a discussion with students of the E-Business course. The topic of discussion is "Safety kids on the Internet" which measures are being taken and what can guarantee the security of the Internet for users, especially for the most vulnerable – children.

We successfully managed to get away from the restrict format of academic lectures with a monologue of speakers to freedom of expression and active discussion.

The Students, about 40 participants, listened to brief interesting introduction part about opportunities to join the ranks of multistakeholders and take part in the work of IGF (global and regional initiatives), ISOC, ICANN, RIPE NCC, and so on.

And then the youth participants of the discussion gave an expert and knowledgeable opinion about the set of end internet users` problems and continued with examples and suggested possible scenarios for the security of the presence of children and older people on the Internet (personal data protection, bullying, hating and other dangers of network communication, toxic content, access, behavior in the network, responsibility and ethics, etc.).



Coordination Center for TLD .RU/.P $\Phi$  announces entry into force of updates policies In Russia, the Coordination Center for TLD .RU/.P $\Phi$  announced the entry into force of updated versions of its <u>Terms and conditions of domain name registration in .RU and .P $\Phi$  and the <u>Policy on the</u> procedures applicable to domain name disputes'.</u>

The Terms and conditions of domain name registration in .RU and .P $\Phi$  now include the list of domain names reserved for government purpose. This change was needed because the *Policy on reserving* domain names in the .P $\Phi$  domain for government purposes expired on 30 November 2019, but some of the domain names reserved have not been used so far.

**The EURid registry**, who manages the unified national domain of the European Union countries .EU, has published a report for the 4th quarter of 2019.

The document notes a number of positive developments in the life of the pan-European national domain and the registry itself. However, all these unconditional achievements, unfortunately indicate the fact the .EU domain continues to "dive".

## Registration standardised metric definitions – German translation added

The Registry-Registrar Data Group (or RRDG) has added German translations for its standardised definitions of common domain registration terms. Find the translations alongside the English version <a href="here">here</a>. If you would like to see other languages added, please <a href="mailto:contact the RRDG">contact the RRDG</a>.

The purpose of the list is to give organisations who work with domain names a standardised reference point of clearly-defined terms for them to use in market reporting and business analysis. Creating standards in registration metrics is particularly helpful in situations where registries share data with their registrars. As more registries adopt these standard terms, registrars can more easily consume reports and will have greater consistency in understanding the numbers they get.

CENTR has adopted the RRDG metrics definitions within its data platform (CENTRstats) and encourages all registries and registrars to consider them.

On February 12-13, 2020, the 63rd General Assembly of the Council of European national top-level domain registries (CENTR) was held in the Slovenian capital of Ljubljana, which brought together more than 70 representatives of the national domain registries (members of CENTR). Also during the Assembly were introduced the new Vice President of ICANN in Europe, Chris Mondini. Chris Mondini visited the CENTR meeting to meet representatives of European national registries and tell about ICANN's plans in the European region.
