ICANN77 Highlights

[ICANN77 Policy Forum](#) was organized as a hybrid meeting in Washington D.C. from 12th-15th June.

- Prior to the meeting the ICANN77 [ICANN77 Policy Outlook Report](#) were released.
- Meeting was attended by 1100 people in person and 630 registered to attend virtually representing 108 countries.
- The community and Board worked on advancing four deliverables related to [The New Generic Top-Level Domains Program Next Round - ICANN](#) .These deliverables include finalizing the implementation plan for the Next Round, which is due to the Board in early August.
- ICANN org and the Contracted Parties House held an [Outreach Session](#) to discuss proposed contract amendments that aim to strengthen obligations in mitigating abuse in the Domain Name System.
- ICANN org provided an update on the progress made in implementing the [Registration Data Request Service](#).

At Large @ICANN77

- At Large held 9 sessions @ICANN77 under the three At-Large work streams of: policy, outreach and engagement, and operations. These include:
 - One policy sessions (Unfinished Business - The Challenges of Auctions):
 - One At-Large Perspective Session on The Next gTLD Application Window:
 - Two NARALO Sessions
 - One AFRALO-AfrICANN Sessions
 - One Joint Session With SSAC: Discussion on New gTLD Next round and alignment on .ZIP
 - One RALO sessions (RALO Coordination)
 - An At-Large Welcome Session
 - At-Large Wrap-Up Session.
 - At-Large expressed its commitment to expedite SubPro while considering end user interests. Updates given on ICANN77 workshop, SubPro positions, CEO search, delegating new strings and protecting individual Internet users.
 - Emphasis was given on reducing barriers and increasing participation in the next gTLD round, supporting IDNs and language scripts, with discussions on pro bono services, fee reductions, awareness and financial support.
 - At-Large RALO Coordination Session discussion around NomCom re-balancing took place. Success of UA Day was acknowledged, and plans for the implementation of the next round of gTLDs were discussed.

- The APAC Space session held during ICANN77 covered several key topics and activities.
- The key topics discussed in the APAC space were:
 - Expedited policy development process for internationalized domain names (IDNs):
 - Universal Acceptance
 - Registration Data Request Service
 - Q&A Session
 - Networking and collaboration session
 - Overall, the session provided updates on important developments in APAC and ICANN space, highlighted fostered collaboration among stakeholders in the APAC region.

ICANN77 read-out by APRALO Policy Forum

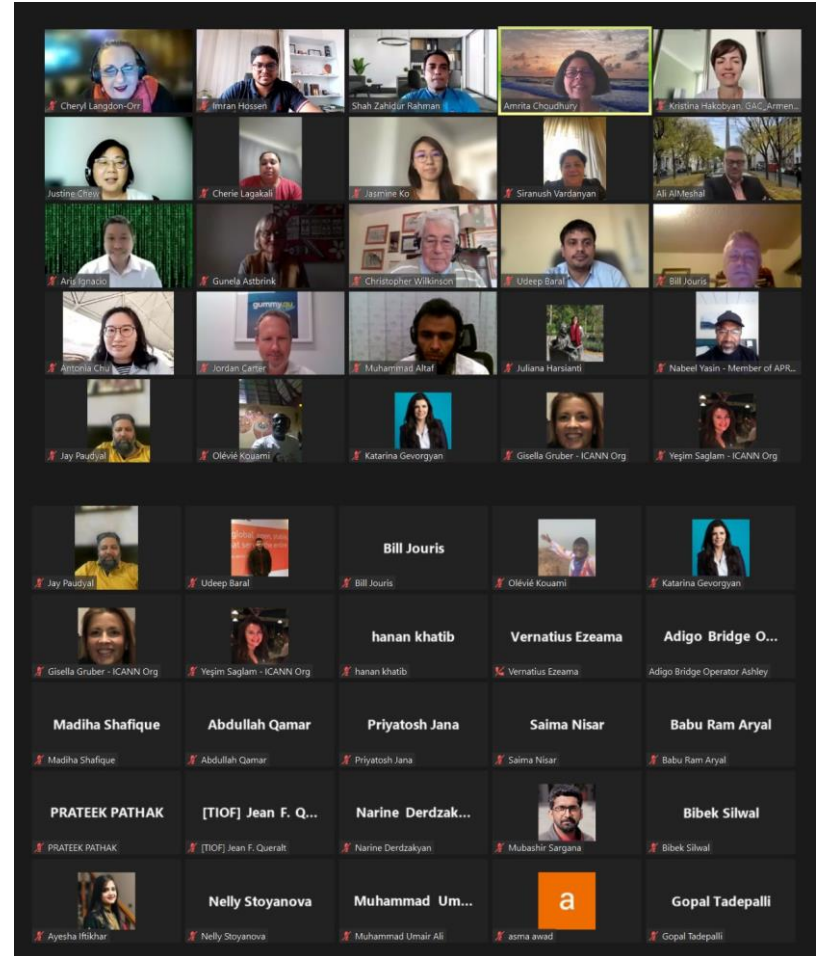
On Thursday, 6 July 2023, at 06:00 UTC, the APRALO Policy Forum organized the ICANN77 read-out for 90 minutes, featuring At-Large, GAC, GNSO and ccNSO panellists from the APAC region.

The session was moderated by Cheryl Langdon-Orr, At-Large Leader, based in Australia and the panelists were:

- Amrita Choudhury, APRALO Chair, based in India
- Juliana Harsianti, ICANN77 Fellow, based in Indonesia
- Antonia Chu, GNSO Councillor, Registrar Stakeholder Group, based in China
- Kristina Hakobyan, representing GAC Armenia, based in Armenia
- Jordan Carter, ccNSO Vice Chair, based in Australia

The panelists discussed their respective key takeaways from ICANN77 and participants were welcomed to join in the conversation aimed at identifying where and how end-users may play a role in any next steps to each of those takeaways.

Updates on the GNSO Guidance Process (GGP)

Maureen Hilyard provided updates on the GNSO Guidance Process (GGP) related to the Applicant Support Process. The GGP has been actively working on six tasks, including setting the SubPro Report that defines criteria for Applicant Support in the next round of new gTLDs. Task 6 focuses on the allocation of funds to qualified applicants, while the GGP also emphasized the importance of developing metrics to measure the success of the Applicant Support Program beyond financial assistance. Maureen questioned assumptions regarding the Board's potential rejection of funding requests for other costs and suggested exploring the possibility of additional funding options.

Maureen expressed concerns about the visibility of the GGP's contributions and the need for effective guidance and outreach activities. She emphasized the importance of gathering feedback from applicants and incorporating their perspectives in developing metrics for evaluating the program's impact. Maureen encouraged members of the APRALO Policy Forum to engage in reviewing the forthcoming public comment document on the Applicant Support process and to provide constructive feedback to shape and improve the process.



The 4th ICANN APAC-TWNIC Engagement Forum

The 4th ICANN APAC-TWNIC Engagement Forum, held in conjunction with the 39th TWNIC IP Open Policy Meeting, took place in Taipei from May 22nd to 24th, 2023. The event, organized by the Taiwan Network Information Center (TWNIC) and ICANN, aimed to foster an open platform for discussions on domain names, IP-related issues, and emerging trends in the Asia Pacific region, with a particular focus on Taiwan's perspective. The hybrid format of the event allowed for diverse viewpoints and fruitful exchanges between stakeholders from both the Asia Pacific region and Taiwan.

The parallel TWNIC IP Open Policy Meeting served as a valuable opportunity for participants to engage in discussions on network technology research and industry development. It provided a platform for ISPs in Taiwan to share their opinions, contribute to relevant IP policies, and establish effective management mechanisms. During the forum's final day, two talented APRALO individual members, Pavel Farhan and Jaewon Son, shared their insights on youth engagement and cross-generational collaboration in Internet governance in a session titled "Empowering the Next Gen: Fostering Youth Engagement and Cross-Generational Collaboration in Internet Governance."



APAC DNS Forum Session on Community Effort on DNS Abuse Reporting

In a pre-event panel organized by APRALO before the APAC DNS Forum, the theme of "Community Effort on DNS Abuse Reporting" was discussed. DNS Abuse poses significant threats to internet security, user trust, and online services. The session was moderated by Satish Babu and the panelists were:

- Rowena Schoo, DNS Abuse Institute;
- Edmon Chung, ICANN Board/DotAsia Registry;
- Maureen Hilyard, Member, ALAC; and
- Amrita Choudhury, Chair, APRALO.

The panel explored the need to empower end-users in reporting incidents, focusing on tools, capacity building, multilingual support, collaboration, regional challenges, and the role of APRALO. They emphasized the importance of a community-driven approach, cyber hygiene practices, information sharing, and personal strategies for defense. The session aimed to promote active participation and empower end-users to combat DNS abuse, ensuring the stability and security of the domain name system. The summary of this panel's discussions will be presented at the upcoming APAC DNS Forum in Hong Kong on July 4-5, 2023.

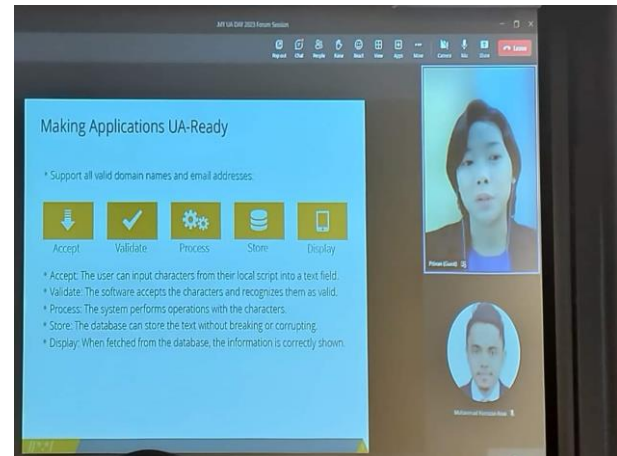


Updates From Our UIMs
