In terms of qualifications I possess a MSc. In Computer Science.

I specialize in ICT strategic planning and implementation at the national level and also specifically for rural community and hinterland development. Professional services have been commissioned by such organisations as the United States Agency for International Development (USAID), The Inter- American Development Bank (IDB), The World Bank, The U.S. Departments of Commerce and Treasury.
