Timeline

- Wed, 19 April 2023

 - Start selection procedure (if more than 1 candidate)

- 18 May Council meeting

FAQ

When is the nomination and secondment procedure?

The nomination- and secondment procedure starts Wed, 19 April 2023 (noon UTC) and closes Fri, 5 May 2023 (23:59 UTC). Nominations and secondments should be sent to the IGLC mailing list, by the applicable deadline.

Who can nominate/second?

Any IGLC member may nominate an individual to serve as IGLC Vice Chair. Nominations must be seconded by another IGLC member. IGLC members may self-nominate themselves, but are not allowed to second their nomination. Self-nominations must be seconded by two IGLC members. Nominations and secondments should be sent to the IGLC mailing list, by the applicable deadline.

Who is eligible for the role of IGLC Vice Chair?

The IGLC Vice Chair can be any individual IGLC member, nominated, seconded, and selected by the IGLC, and eventually appointed by the ccNSO Council.

What is the role of the IGLC Vice Chair?

- Joining efforts with the Chair. Vice Chair is aware of the current issues within the IGLC to be able to stand in at short notice.
- work with Chair and ccNSO staff in facilitation, coordination and communication ensuring that committee members are actively engaged in the achievement of the work by the committee

When will the list of candidates for the role be known and what happens next?

After closure of the nomination period, the ccNSO Secretariat will ask the candidates that are nominated to accept their nomination. Self-nominations are understood to have accepted their nomination. When accepting nominations, candidates are expected to send a short statement to the IGLC mailing list, including an answer to the following 2 questions:

- What is your interest in this position?
- What skills and attributes do you have that will assist you in your role as IGLC Vice Chair? If there is only one candidate for the position of Vice Chair who has accepted its nomination, that person will be considered the Vice Chair nominee of the IGLC. If there is more than 1 candidate, the IGLC members will need to select their preferred candidate. The preferred candidate will need to be appointed by the ccNSO Council.

What happens if there is more than one candidate for the role of IGLC Vice Chair?

The IGLC members will need to select their preferred candidate.

Example instructions, in case of 2 candidates: "Your most preferred candidate should receive two (2) points, and the second and least preferred candidate one (1) point. If you believe a candidate does not meet the criteria: please assign zero (0) points." The person with the highest ranking is the nominee for the position of IGLC Vice Chair. If the two most preferred candidates have the same total rank, the expression of preference procedure will be run again. The preferred candidate will need to be appointed by the ccNSO Council.
