# Planning Prioritization Group Operating Procedures

- The FY25 Operating Procedures are on the wiki: [Planning Prioritization Group \(PPG\) Operating Procedures - May 2023](#)
- Participation:
  - The Planning Prioritization Group (PPG) members are expected to actively engage in and attend all meetings.
  - If a member cannot participate in a meeting, the secondary members is expected to attend on the member's behalf. In such cases, alternates have the full rights and responsibilities of a member for the duration of their participation on the member's behalf
- All PPG meetings are open to observers from the Community, org and Board. Observers are not to speak or otherwise participate during the meeting, and the chat room function will be disabled for observers.
- The PPG shall work openly and transparently. The PPG mailing list will be recorded and publicly archived, including through publication on the designated wiki space.
- The PPG is not expected to need a chair or any specific leadership mechanism. The ICANN org Planning team will facilitate the work of the PPG
- Members are expected to observe the [ICANN Expected Standards of Behavior](#) and the [ICANN Community Anti-Harassment Policy](#).
- The PPG shall operate on the basis of consensus. For the purpose of its deliverables, consensus shall mean general agreement without any formal objections.

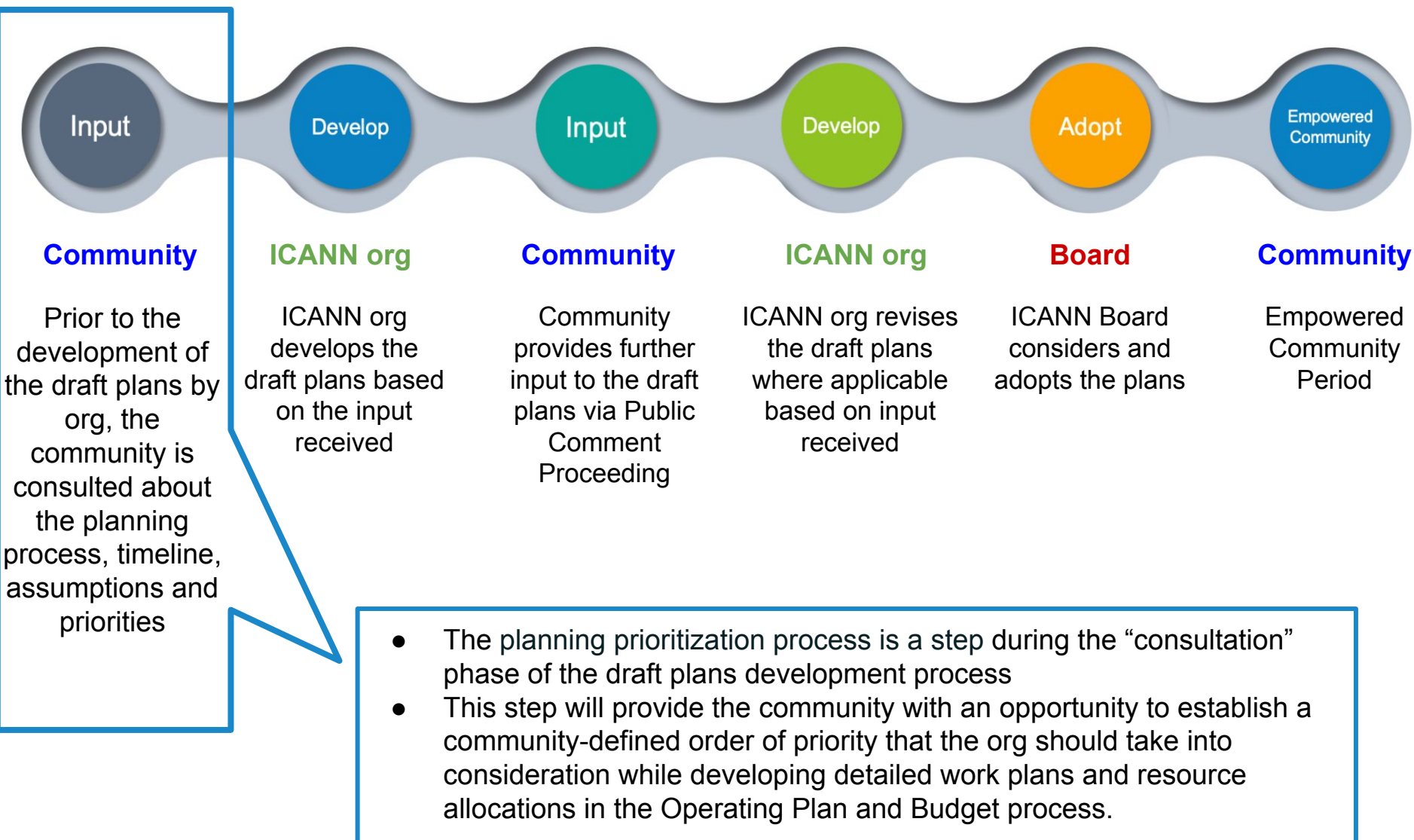
# Planning Prioritization Framework

# Planning Prioritization Framework Background

---

- Planning Prioritization Framework is one of the deliverables of “Planning at ICANN” Operating Initiative in the Operating Plan
- The Framework is intended to serve as a guide the prioritization process during the annual planning process
- The Framework describes and outlines what to prioritize, who will prioritize, when and how to prioritize
- The Framework is developed and updated based on input received from the numerous webinars and consultation workshops with SOs/ACs and other stakeholders. The Framework will continue to evolve at as needed basis
- The latest Framework is Planning Prioritization Framework Version 3 (V3)

# Framework V3 - Scope

## SCOPE

This element defines what to prioritize.

Based on the input received, the framework will focus on prioritizing Board-approved implementation work, such as PDP recommendations, Specific Review recommendations, and the implementation of other non policy and advice work. The process also includes any activity previously prioritized but has not yet commenced within 2 years of its prioritization

# Activities To Be Prioritized During FY25 Planning

*The chart below illustrates at a very high-level, how the work flows through different phases within the ICANN ecosystem.*



- Based on the framework, the activities in scope are Board approved implementation work, which include:
  - PDP recommendations
  - Review recommendations
  - Advice work
  - CCWG
  - Other non-policy recommendations
  - Previously prioritized activities that have not yet commenced two years after being prioritized

# Framework V3 - Participants

## PARTICIPANTS

This element defines who will conduct the prioritization, and the roles and responsibilities of all involved parties during this process.

The “Participants” element defines who will conduct the prioritization and the roles and responsibilities of all involved parties during this process. Based on input received, the framework suggests forming a Planning Prioritization Group, with members from each SO/AC, at the beginning of the annual planning process to help prioritize the activities identified in the Scope.

These members are to be nominated by the Chairs of the SO/ACs, but they are acting in their own capacity within the Planning Prioritization group. They will also be requested to identify a secondary member that should also attend the group meetings. The secondary member will be available should the primary member be unable to participate due to unforeseen reasons

1. ASO - Address Supporting Organization
2. ALAC- At-Large Advisory Committee
3. GNSO/CSG - Commercial Stakeholder Group (CSG)
4. GNSO/CPH - Contracted Party House
5. GNSO/NCSG - Noncommercial Stakeholder Group
6. ccNSO - Country Code Names Supporting Organization
7. GAC - Governmental Advisory Committee
8. RSSAC - Root Server System Advisory Committee
9. SSAC - Security and Stability Advisory Committee

# Framework V3 Overview - Frequency

## FREQUENCY

This element defines when to prioritize and how often to prioritize

Based on input received, the prioritization step will take place once a year during April-June. The suggested timing will allow sufficient time for the org to develop the detailed work plan and resourcing estimates during the annual Operating Plan and Budget development process. This will also allow the community to provide further input via the draft plan Public Comment proceeding.

Additionally, the org suggests that a midyear planning prioritization process could be considered on an as-needed basis should there be a need to review activities that are approved by the Board during the planning cycle.

# Framework V3 Overview - Techniques

## TECHNIQUES

This element defines techniques or models that can be used to help prioritize

Prioritization is a process of making choices and making decisions. Based on the input received, the “Urgency-Importance Matrix” prioritization technique will be used during the prioritization process. ICANN org will provide the list of activities in advance of the meetings and a suggested level of priority for each as a starting point. Other techniques may be reviewed if agreed upon by the Planning Prioritization Group.

## SYSTEMS AND TOOLS

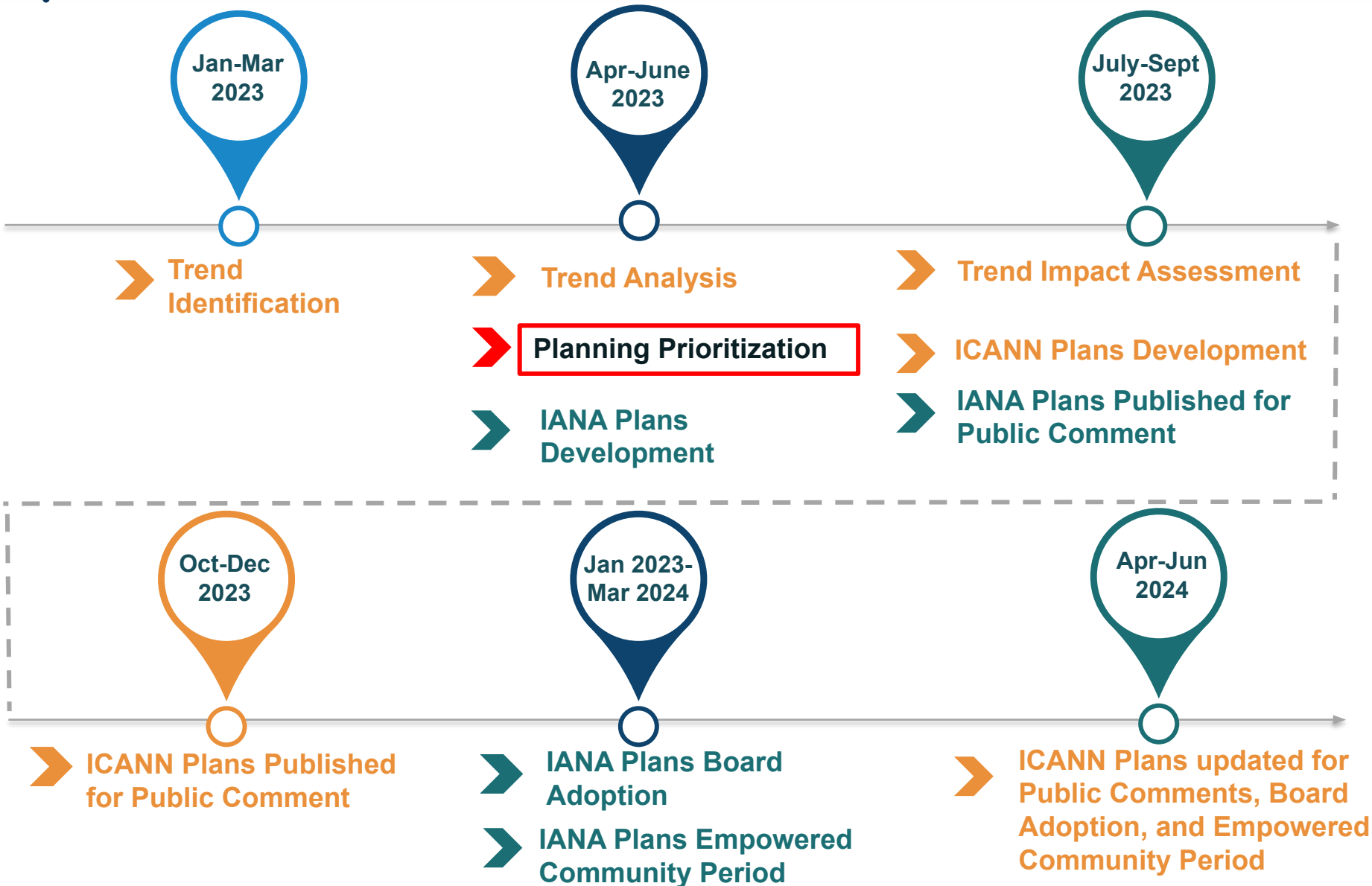
This element defines what resources are helpful to use when prioritizing

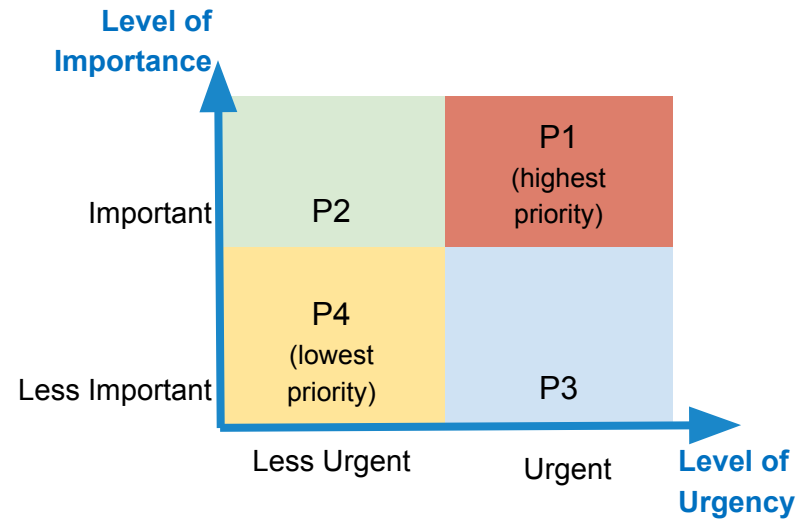
# Introduction to Prioritizing

---

- Prioritization is a recommended process to enhance decision making in order to plan out the proposed implementation work
- Prioritization requires trade offs
  - Not everything can be the most urgent and the most important.
  - By selecting one activity as a priority we need to evaluate what other activity will be delayed or scheduled for later
- The use of a technique is to permit discussion and foster constructive decision-making
- Based on the Planning Prioritization Framework, ICANN will use the “Urgency-Importance Matrix” prioritization technique
- ICANN org provides a level of prioritization for each activities as a starting point based on information available.
  - Members can then react to the pre score and discuss their various viewpoints

# Prioritization Technique Proposed

- Evaluating Urgency:
  - A deadline to meet?
  - A dependency to another recommendation?
- Evaluating Importance:
  - Determined as “high priority” by Review Team? (*For Reviews Recommendation only*)
  - Mission critical?
  - Strategic?
  - Operational excellence?
- The matrix results in 4 level of priority
  - P1 = highest Priority
  - P4 = lowest priority

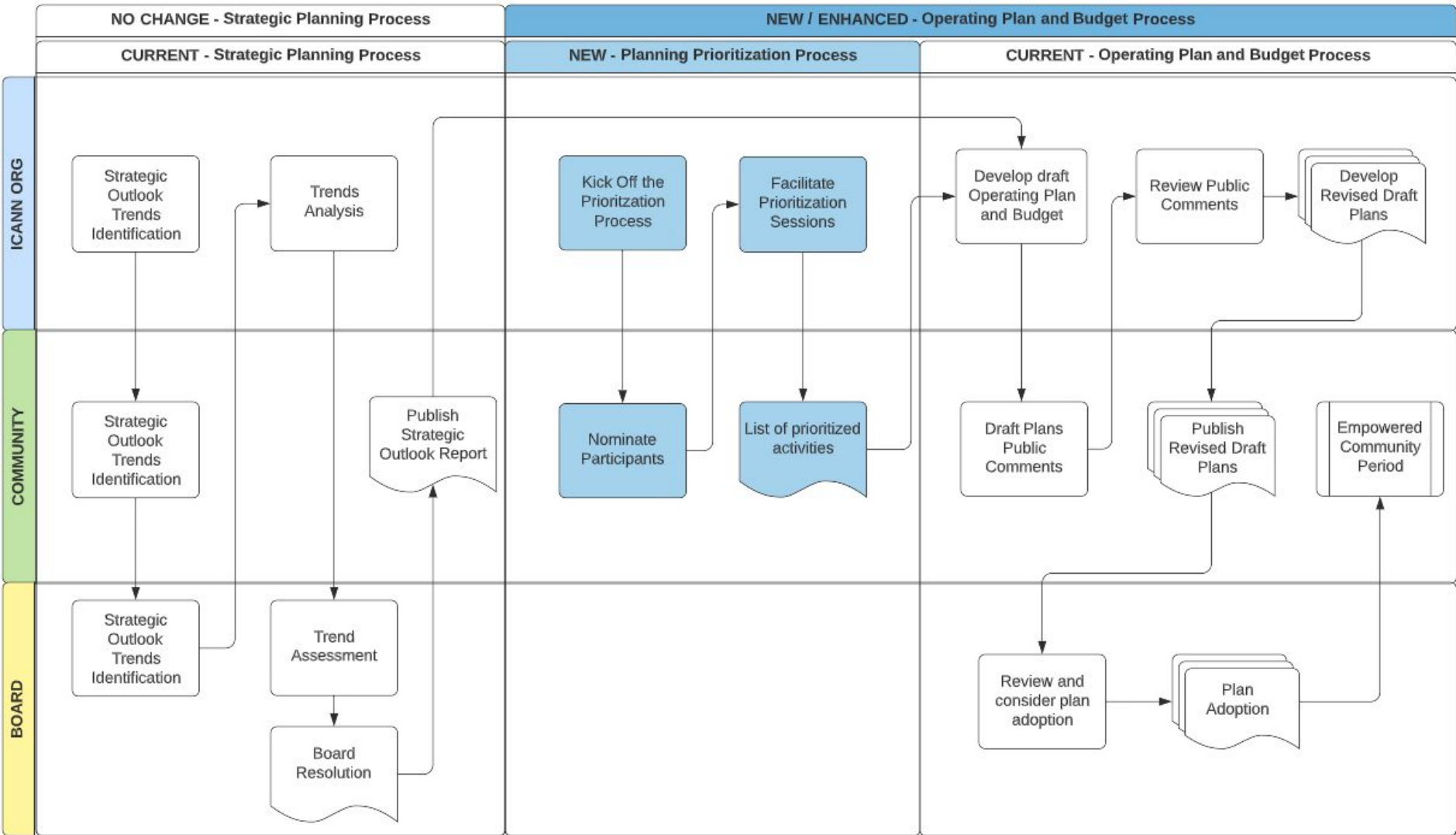
