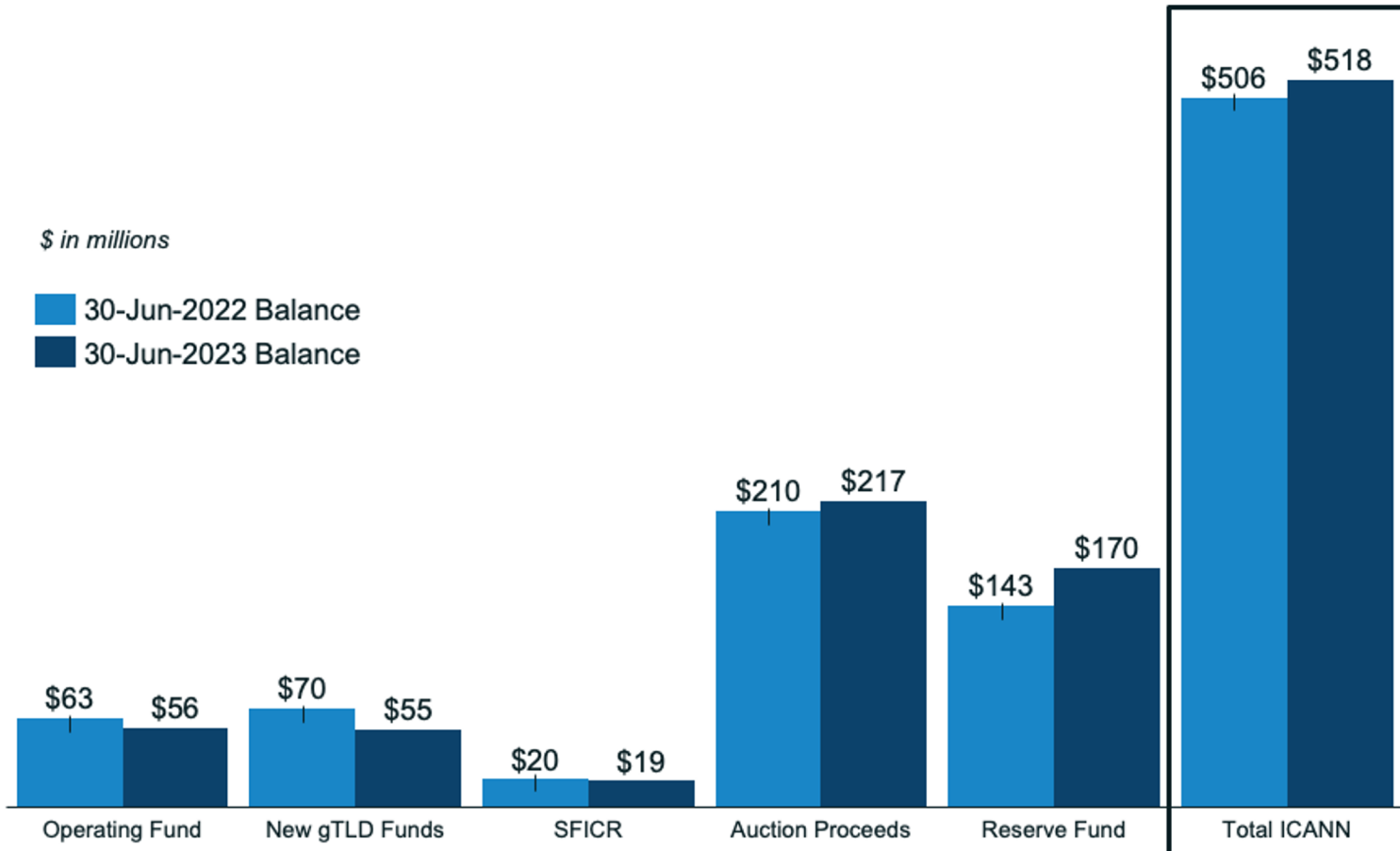

- This information reflects Full Year financials, corresponding to twelve months beginning 1 July 2022 and ending 30 June 2023.
- Funds under management increased US\$12 million since the beginning of the fiscal year due to investment income and net excess, partially offset by segment operating expenses.

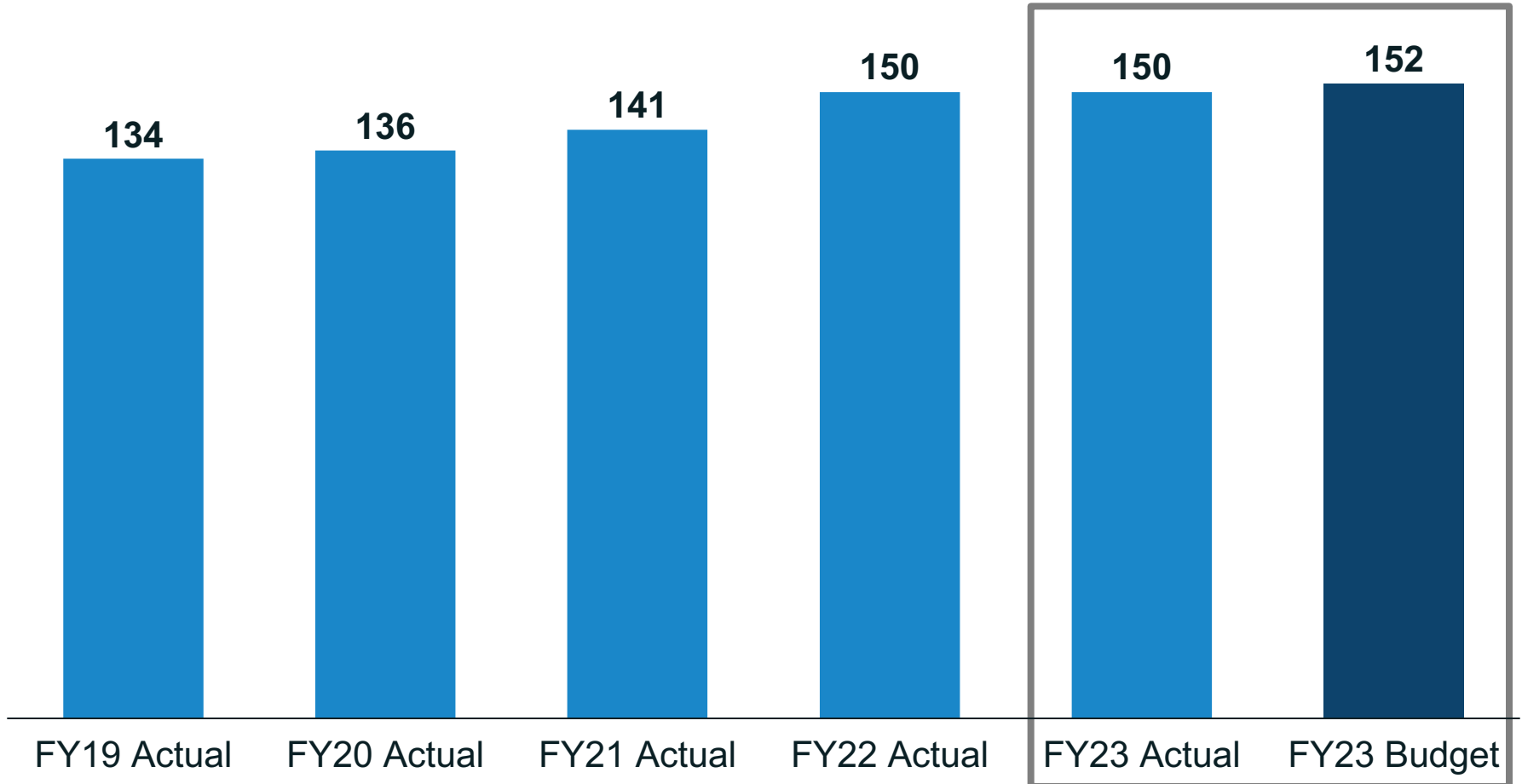

- FY23 Funding was \$2M lower than budget primarily due to lower than planned transaction fees.
- FY23 Expenses were \$10M lower than budget driven by lower than planned professional services and personnel costs.

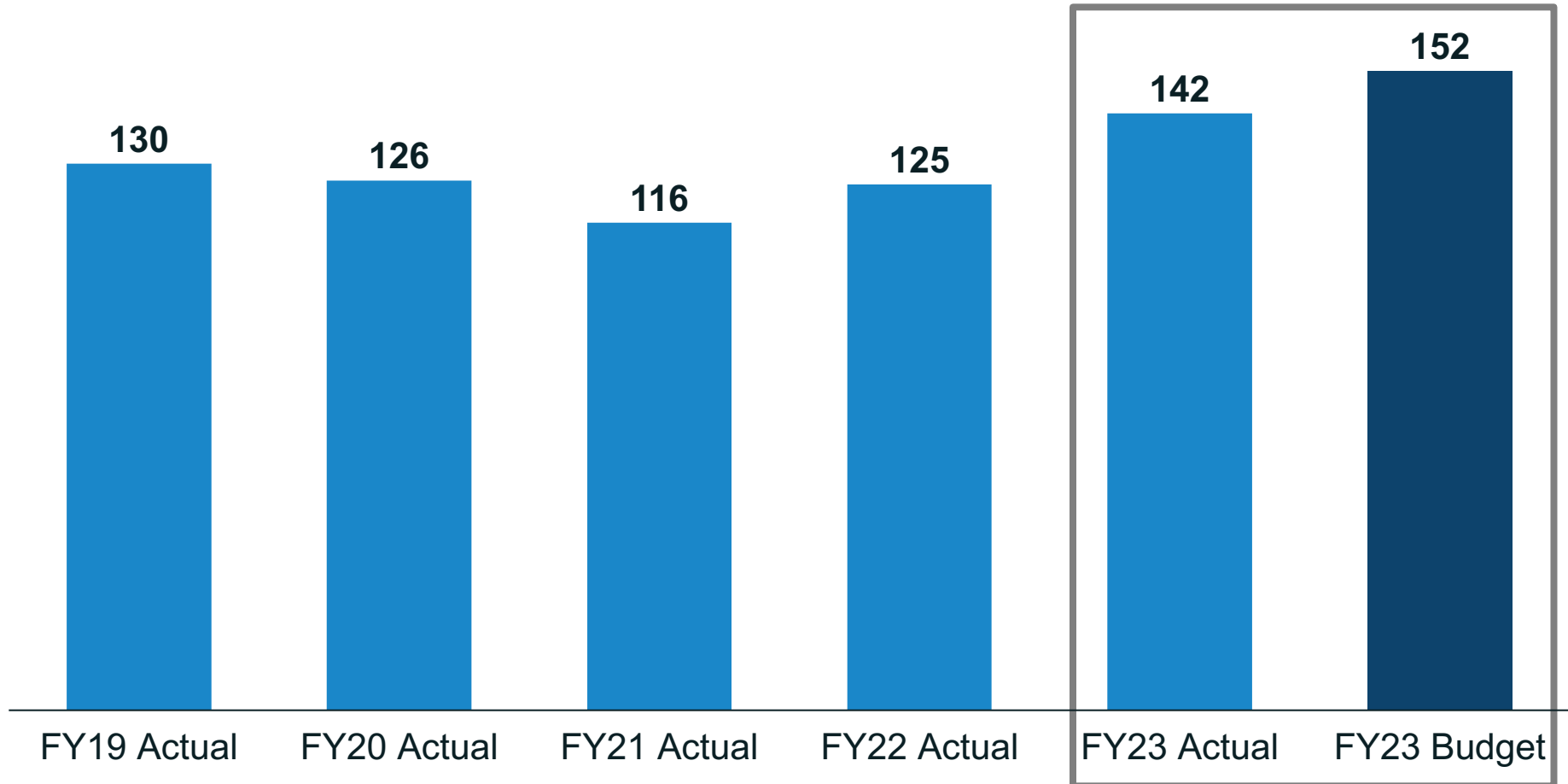
ICANN Operations – Funding Trends

- Funding for FY23 was aligned with prior year and budget



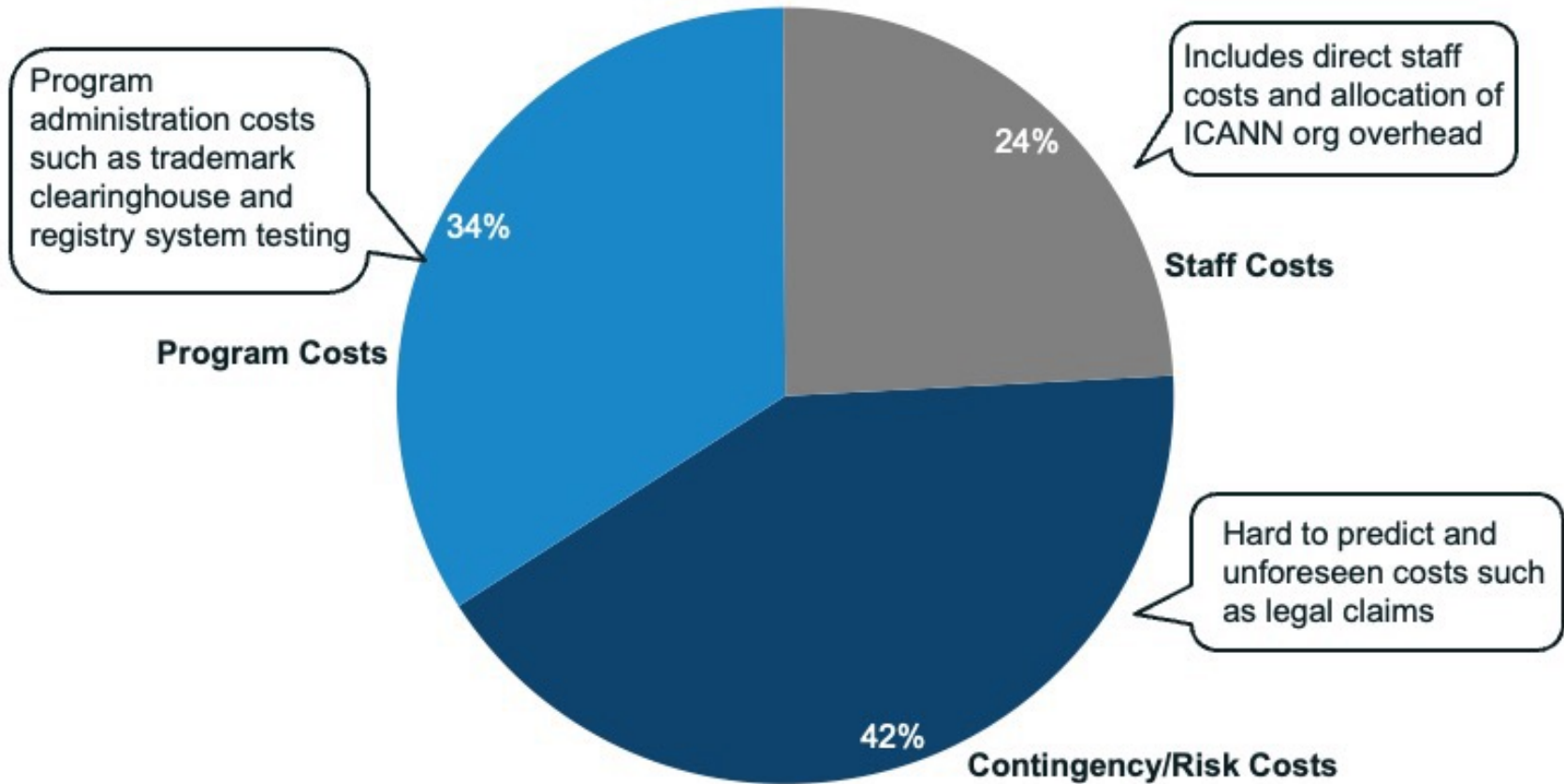
ICANN Operations – Cash Expense Trends

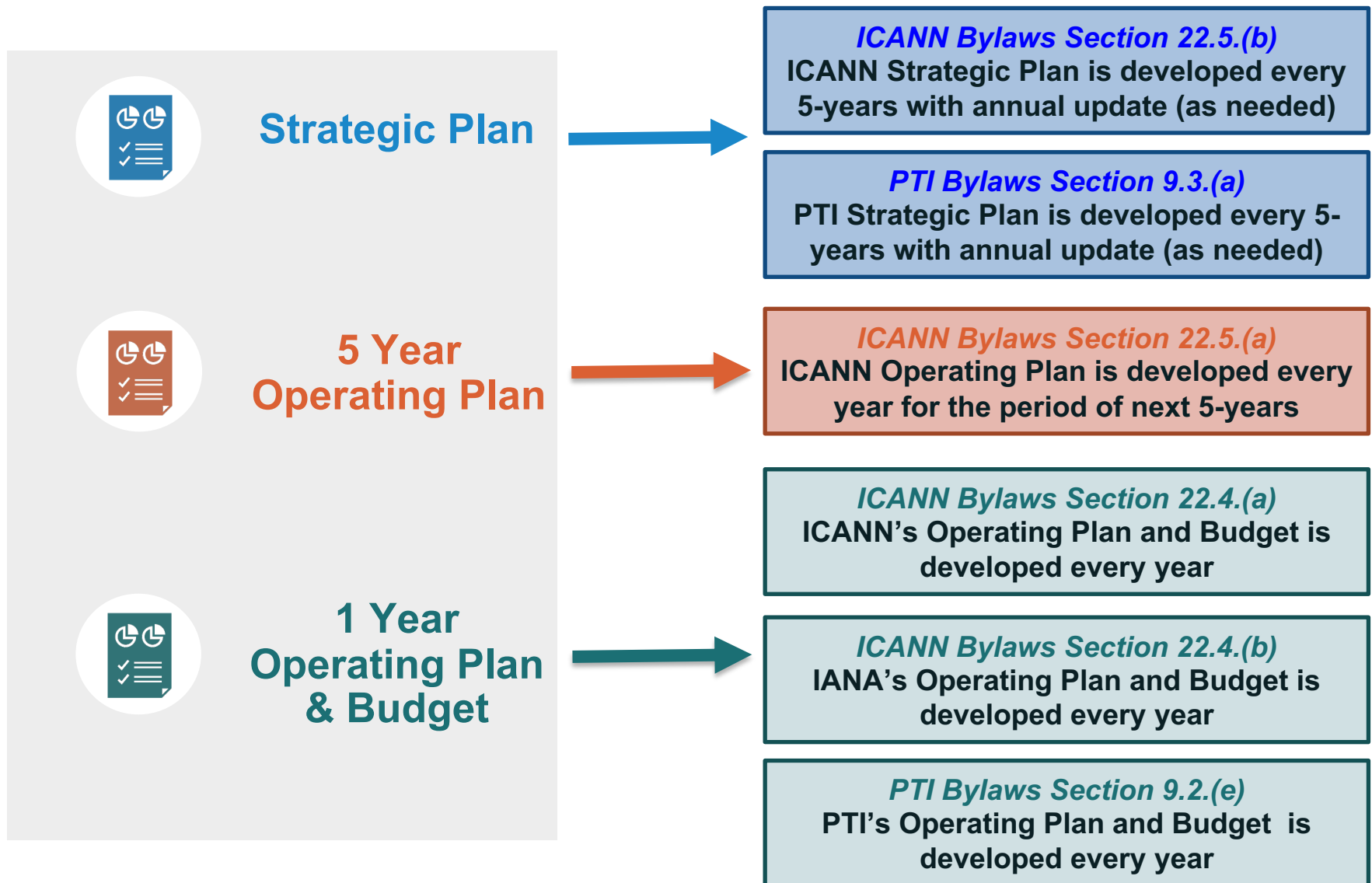

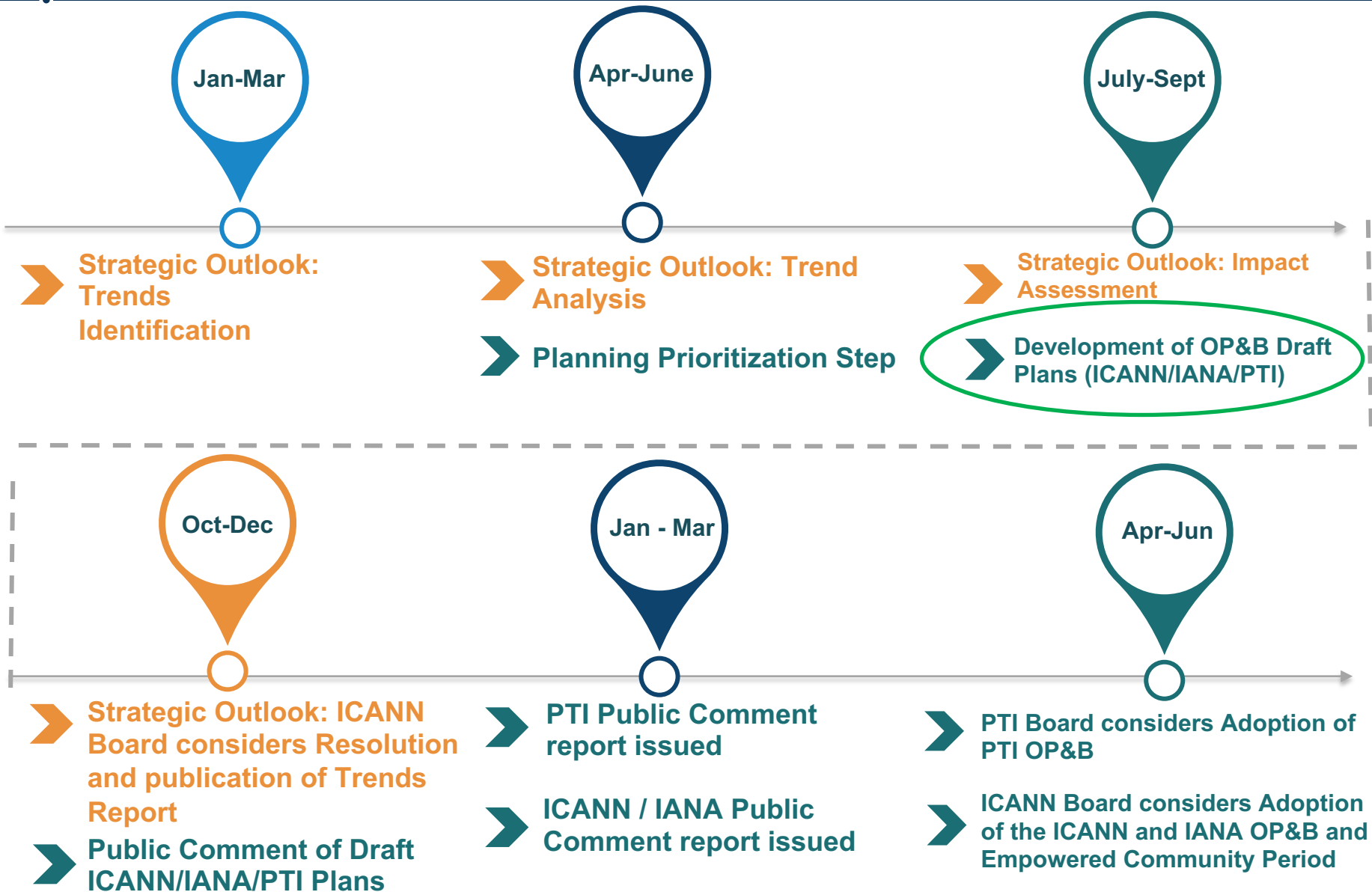

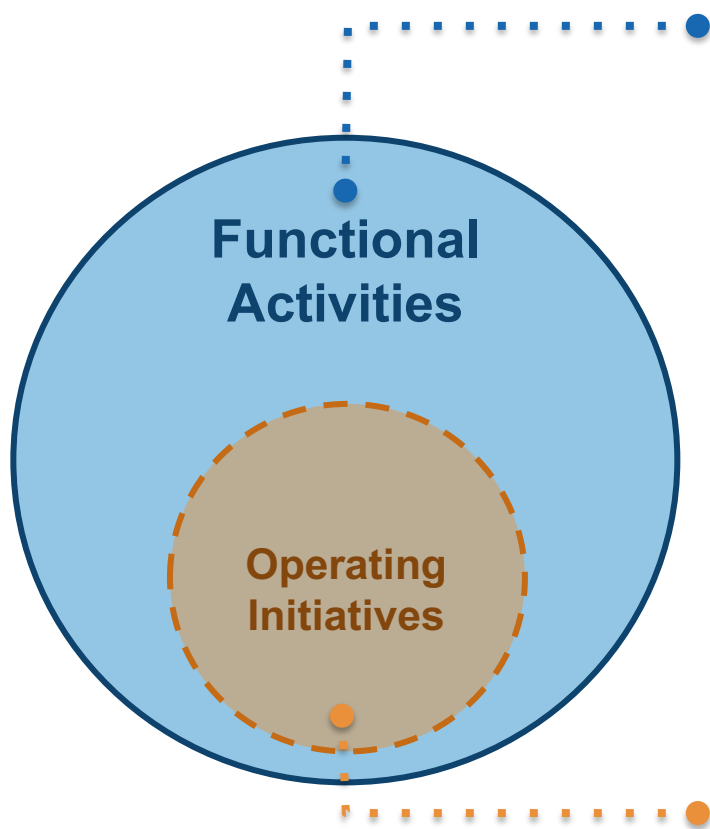

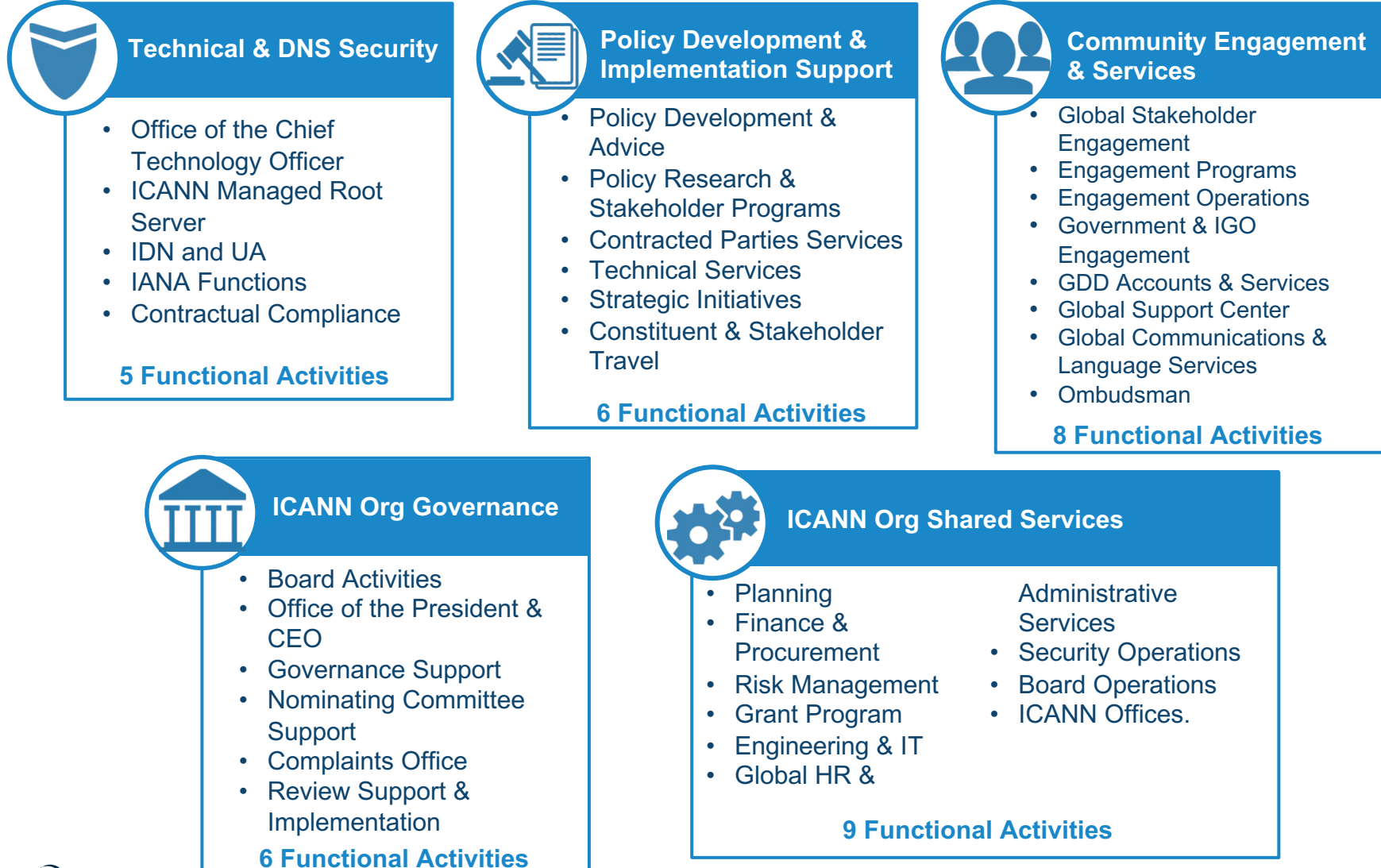

Key FY25 ICANN Planning Assumptions (1 of 2)

Strategic Plan Remains Unchanged

The Strategic Outlook trends impact assessment is underway. We will assume no changes to the Strategic Objectives set forth in the FY21–25 Strategic Plan for planning purposes

Affordability and Balanced Budget

The Draft plans are based on “base” scenario Operations funding projections. ICANN plans for operating expenses to remain at or lower than budgeted funding, drawing from designated and available funding sources

ICANN Public Meetings and Engagement

The Draft plans assume that ICANN public meetings, Board, org and community engagement will occur based on the public meeting schedule

Planning For Board Approved Activities

ICANN begins designing the expected implementation work only when recommendations and policies are Board approved

Key FY25 ICANN Planning Assumptions (2 of 2)

Planning Prioritization Framework

The two Board approved activities prioritized in the FY25 Community Planning Prioritization process are:

- Specific Review: SSR2 Recommendation 5.3
- Specific Review: SSR2 Recommendation 7.5

Implementation of the recommendations are already in progress and will be addressed in the FY25 plans

The following two programs were not a part of the Planning Prioritization process but are Board approved to move towards implementation and will be prioritized in the FY25 Plans:

1. New gTLD Program: The Board approved a set of policy recommendations for the next round in March 2023. This sets in motion the start of the implementation process for the next round of new generic top-level domains (gTLDs).
2. Registration Data Request Service (RDRS)- The RDRS recommendation was approved by the ICANN Board in February 2023. The Registration Data Request Service will streamline the process for submitting and evaluating requests for access to nonpublic gTLD registration data through the use of a single platform.

In addition, any multi-year projects from previous Planning Prioritization cycles will also included in the FY25 OP&B

FY26-30 Strategic Plan Development

Introduction and Objective

- The ICANN Bylaws (Section 22.5) mandate a five-year strategic plan for each fiscal five-year period, and a five-year operating plan for each fiscal year.
- Starting 1 July 2025, a Five-Year Strategic Plan has to be in effect for FY26-30.
- The current development approach and process aims to deliver the FY26-30 Strategic Plan no later than March 2025.
- The Board Strategic Planning Committee (BSPC) is responsible for initiating and leading the strategic planning process for ICANN on behalf of the Board.
- The strategic plan development process is designed to be highly inclusive, emphasizing the active participation of the ICANN community, Board and org. The Board firmly believes that by pooling everyone's insights together, we can shape a strategic plan that not only reflects our shared vision, but also drives ICANN towards a bright future.

5 Year Strategic Planning Deliverables

- Planning for FY26-30 is a program as there are multiple deliverables mandated by the ICANN Bylaws.
- The below plans should be adopted no later than May 2025 to allow sufficient time for the Empowered Community process to conclude prior to the start of FY26, so that the plans can go into effect at the start of the fiscal year (assuming no rejection petition is pending):
 1. ICANN FY26-30 Strategic Plan
 2. ICANN FY26-30 Five Year Operating and Financial Plan
 3. ICANN FY26 Operating Plan and Budget
 4. IANA FY26 Operating Plan and Budget

The **ICANN Five Year FY26-30 Strategic Plan** and the **ICANN Five Year FY26-30 Operating Plan** will provide fundamental input into the development of all the other plans.

Strategic Planning Approach

Strategic Planning is also known as the **Strategic Thinking** process. This is the process of discussing and learning from what we are doing now to enhance what we are going to do next.

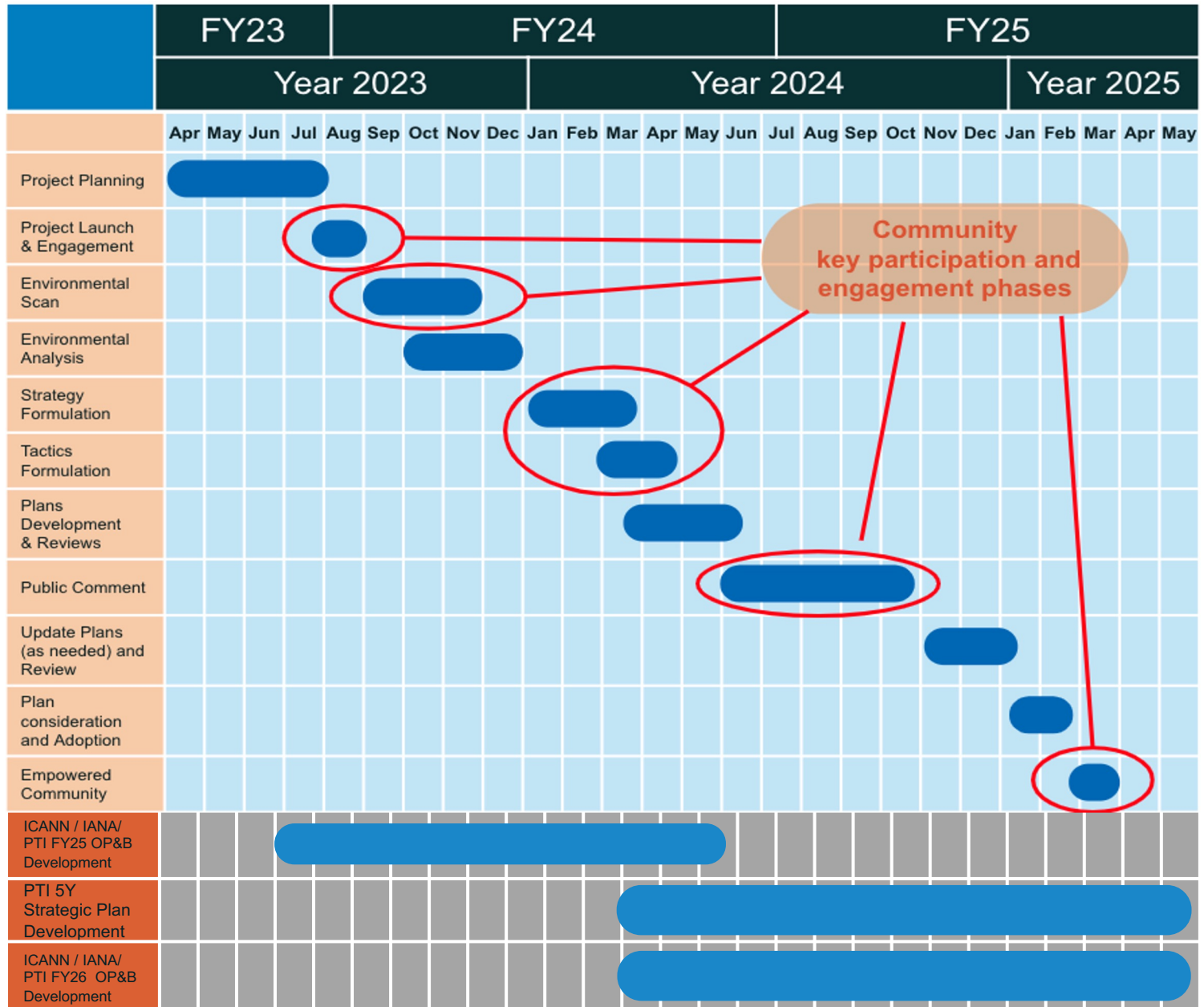

- The FY25 Planning process kicked off with the Fiscal Year 2025 (FY25) Trends Identification Sessions, which ran from March through April 2023.
- The ICANN Planning team worked on the FY25 Trend Analysis from May through July 2023 with input from org Subject Matter Experts.
- Next steps include finalizing the impact assessment with the Board Strategic Planning Committee, which will formulate a recommendation to the Board on potential changes, if any, to the current ICANN Strategic Plan at ICANN78. Following the Board decision, the FY25 Strategic Outlook Trends Report and Impact Assessment will be published.

Planning Prioritization

- The Plans include prioritized activities from the FY22 through FY25 Planning Prioritization Process

- Four Board approved activities were prioritized in FY25 and are included in the plans:
 - SSR2 Recommendation 5.3
 - Specific Review: SSR2 Recommendation 7.5
 - New gTLD Program: The New gTLD Program recommendation was approved by the ICANN Board in March 2023
 - Registration Data Request Service (RDRS)- The RDRS recommendation was approved by the ICANN Board in February 2023

- Four Board approved activities were also prioritized in FY24 and are included in the plans:
 - GNSO PDP Implementation: EPDP Temporary
 - Specification for gTLD Registration Data – Phase 2A
 - ccNSO PDP Implementation: PDP 3 Retirement
 - ICANN Grant Program
 - Specific Review: SSR2 Recommendation (Outreach and education on ICANN’s involvements and achievements in the security space)

- The FY25 plans also include activities prioritized in FY22 and FY23:
