

A fundamental part of ICANN's Mission is to coordinate policy development related to the Internet's system of unique identifiers.


Policies are developed through formal policy development processes (PDPs), as set forth by the ICANN Bylaws.




Governmental Advisory Committee

- The GAC consists of representatives from national governments and public authorities.
- Emphasizes the need to ensure adequate financial resources for ASP to assist deserving applicants from diverse backgrounds.
- Highlights the ASP's role in supporting IDN registries and their efforts to address specific causes, such as accessibility and language diversity.







Generic Names Supporting Organization Advisory Committee

- The GNSO is responsible for developing policies and making recommendations on generic top-level domains (gTLDs).
- Seek a balanced approach that considers the financial burden on stakeholders while supporting the goal of providing necessary assistance to deserving applicants.
- The GNSO seeks to balance the prioritization of IDNs with the need to address concerns about potential unfair competition.







At-Large Advisory Committee

- The ALAC represents the interests of individual internet users and non-commercial organizations.
- Recognizes that ICANN's funds come from domain registrations, and it is important to engage in discussions with the GNSO to secure their support for contributing to the ASP.
- Advocates for prioritizing IDNs in the Next Round to enhance internet access and bridge digital divides.
