

Operation Rules submitted to MTT in **April 2019**

MTT started Rules review with TRA in **November 2019** and completed in June 2020.

LLOC published the Rules on 10th August 2021.

Miaratior

Sunrise (60 Days) & Grandfathering [3rd November 2021 – 2nd January 2022]

Government Registration [3rd November 2021 – 2nd May 2022] Local Registration Phase (120 Days) [3rd January 2022 – 2nd May 2022]

General Availability [3rd May 2022]

Transfer the available zones from Batelco DNS to the TRA DNS.

COMPLETED 1st AUGUST 2019.

A 60 days Sunrise phase making .bh registrations exclusively available to trademark holders. And offering them . البحرين. at the same time.

This is to allow government agencies, departments and associated organizations to have domains .BH (at the second level) rather than gov.bh and to reserve the names. To run in parallel with Sunrise.

In this phase on local residents and entities will be allowed to register a .bh domain. The verification will be managed by Abu ghazala or by TRA as is managed now with checks. The phase will run for 120 days.







Launching Period – Sunrise Phase














