Background

At ICANN76, ICANN Board:

- Adopted 98 recommendations from the Final Report of the New gTLD Subsequent Procedures PDP (SubPro Recs)
- Marked a remaining 38 SubPro Recs as "pending" citing concerns
- Requested from GNSO Council, inter alia, plans for resolving the 38 Pending SubPro Recs

Since ICANN76:

- GNSO Council Small Team on SubPro has been working with Board SubPro Caucus members to resolve Board concerns on 38 SubPro Pending Recs
- This work is bifurcated along need for:
 - Clarifying Statement(s)
 - Additional processes: either a GNSO Operating Procedure Section 16 processes or Supplementary Recommendations



Background

- Since ICANN77, Aug-Sep 2023
 - GNSO Council's First Clarifying Statement¹ submitted to the Board
 - ICANN Board recent Sep workshop -> resolution² together a SubPro Scorecard³
 The Board SubPro Scorecard comprises:
 - Section A: Outputs that the Board adopts
 - Section B: Outputs that the Board adopts with GNSO Council-approved clarifications
 - Section C: Outputs that the Board does not adopt this time
 - Section D: Outputs that the Board is still discussing
 - Second Clarifying Statement expected to address another 10 SubPro Outputs

Topic 26: Security and Stability	26.9	Uncertainty/risks in ICANN's ability to enforce PICs/RVCs per mission	"any level" interpreted only in respect of DNs that are allocated by the RO
Topic 29: Name Collision	29.1	Not concern, merely awaiting NCAP Study 2 Report	 Adoption does not immediate implementation, can wait for NCAP Study 2 outputs
Topic 34: Community Applications	34.12	Possibly required to publish CPE provider confidential info for public comment	 No intention to require ICANN org to disclose any confidential terms with CPE Provider
Topic 35: Auctions	35.3, 35.5	Mention of "private auctions" should not endorse/prohibit private auctions	 Confirms references to private auctions merely acknowledge existence of private auctions in 2012 and should NOT be seen as an endorsement or prohibition of their continued practice in future rounds

Topic 17: Applicant Support	17.2	Open-ended nature of potential payees and potential fiduciary concerns
Topic 18: Terms and Conditions	18.1	Does not want to unduly restrict ICANN's discretion to reject an application in circumstances that fall outside the specific grounds set out in the recommendation.
Topic 18: Terms and Conditions	18.3	Covenant not to sue subject to challenge/ appeal mechanism leading to undue legal exposure (tied to Recs 32.1, 32.2, 32.10)
Topic 22: Registrant Protections	22.7	Exemption of COI means no EBERO funds – better to be case-by-case than blanket exemption (similar to Rec 9.2)
Topic 24: String Similarity	24.3, 24.5	Enforcing "intended use" of singular-plural through PICs may fall outside ICANN mission


