Review Process Overview



ICANN Board passes resolution to convene review



Selection process, leadership appointments, IFR2 team announced



Identify objectives and plan approach to work based on Bylaws scope



Collect & analyze data (document review, interviews, site visit etc.)



Formulate findings, recommendations based on research, observations & input.

Check against scope



Consult with community & SMEs on initial findings, recommendations (including Public Comment)



Update findings and recommendations based on consultation



Publish final report for Board consideration




Ways of Working

- IFR2 meetings and working procedures are open to the public and conducted in a transparent manner to the fullest extent possible.
- Meeting records and review team working documents will be posted to this <u>wiki</u> <u>space</u>.
- Observers are welcome to follow the publicly archived mailing list and observe team meetings. Observers should contact IFR2 support staff to subscribe.
- Review team to determine the approach to work. Some possible approaches:
 - Establish sub-teams to work as research teams and explore specific issues
 - Assign individual volunteers to review sections of the contract and draft findings.

Proposed Roadmap for Next Meetings - Some Suggestions


- Develop and adopt of the Terms of Reference (includes scope, objectives, deliverables).
