

### **FY25 Planning Process Timeline**





#### Changes in the Operating Plan and Budgets every year

- ICANN acknowledges that the planning documents are lengthy
- ICANN has made progress include marking new strategic activities with a delta icon (Δ) in the plans
- ICANN will continue to evaluate ways to improve clarity around changes and additions to the planning documents
- ICANN welcomes opportunities with community to gain insight into how to improve the structure of ICANN's planning documents

#### Preview of FY25 Planning document changes

- July November Development of the Operating Plan and Budgets
  - Functional Activities and Operating Initiatives
- Operating Initiatives are evaluated each year to measure progress towards achievement of the Strategic Objectives in the Adopted FY21-25. Strategic Plan
  - Several completed Operating Initiatives will be reported upon



### **Operating Plan and Budget Changes**

- Per the FY24-28 Operating Plan part of the Planning at ICANN
   Operating Initiative includes launching a progress measurement framework which is due to launch in FY24
- ICANN is exploring opportunities to engage with the community (including the ccNSO SOPC) regarding this project in the near future.
- As the project progresses there will be numerous opportunities for the community to explore and provide feedback on the topic of Key Performance Indicators (KPIs) and metrics and their potential utilization in future Operating Plans and Budgets
