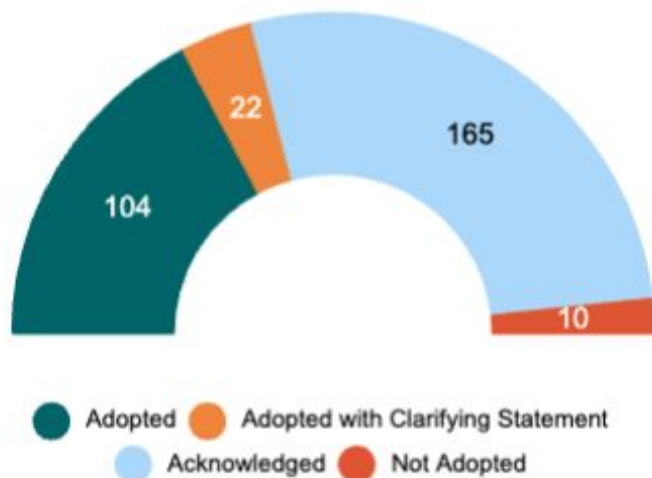

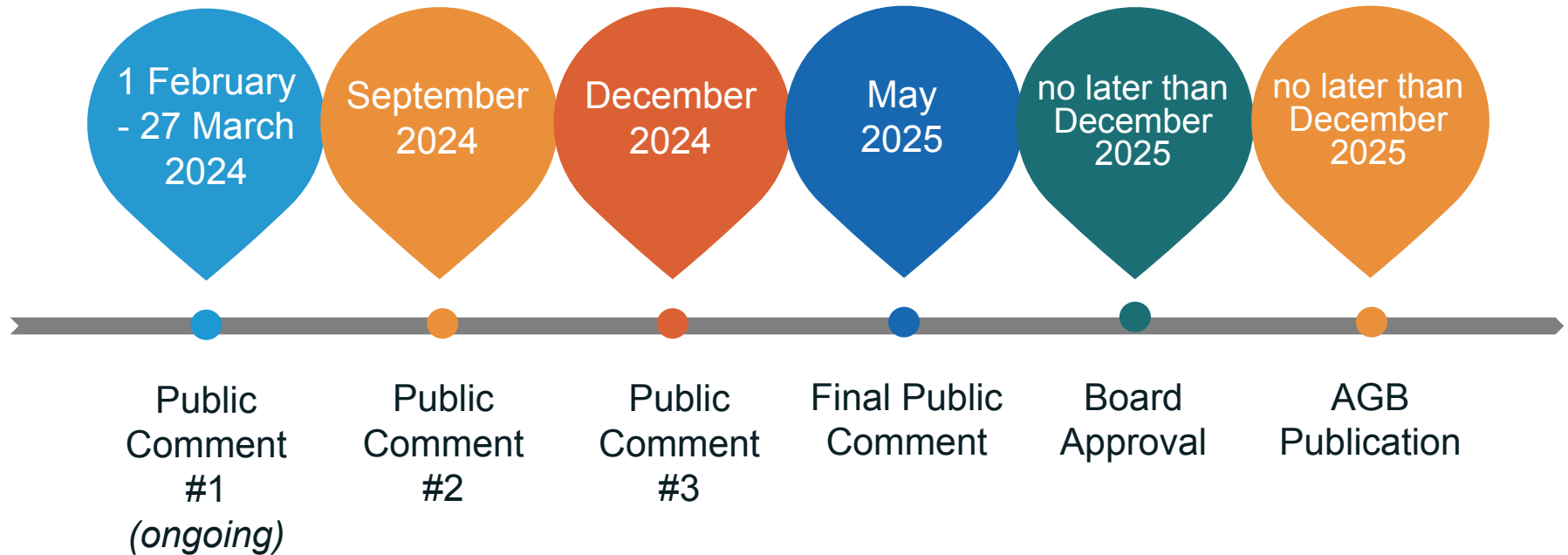

Vendor Engagement

- **Auctions: Mechanisms of Last Resort / Private Resolution of Contention Sets: Selection**
 - ICANN org is working with a vendor to conduct research on auction mechanisms that may help applicants with limited financial resources (such as bid credits and multipliers). In addition, ICANN org is working with the vendor to assess potential methods to prevent or strongly disincentivize private resolution of contention sets. This work is being conducted in line with the IRT timeline, and ICANN org currently expects to discuss the auctions topic with the IRT by July 2024.
- **Community Priority Evaluation: Contracting**
 - ICANN org is working with a selection of vendors to review the definition of "community" and to assist in the development of evaluation criteria. This work is being conducted in line with the IRT timeline, and ICANN org currently expects to discuss the topic with the IRT by October 2024.

Public Comment: String Similarity Review Guidelines

7 February - 27 March 2024

- String similarity review is part of the Initial Evaluation of the next gTLD round. GNSO Phase 1 Final Report on the Internationalized Domain Names Expedited Policy Development Process ask for developing guidelines to manage the process.
- String similarity review guidelines provide details on preparing for, and organizing, the review of applied for strings with respect to other applied for strings, previously delegated TLDs, and reserved words or their variant strings.
- The current [Public Comment](#) shares a draft set of criteria and methodology for string similarity review. The input will help formulate detailed guidelines and methodology in second phase of this work.

Public Comment: Applicant Support Program Handbook

12 February - 2 April 2024

- For each section of the [Applicant Support Program \(ASP\) Handbook](#), commenters will indicate whether the section in question accurately reflects the policy recommendations on Topic 17, Applicant Support, based on the recommendations of the [Subsequent Procedures \(SubPro\) PDP Final Report](#) and the guidance of the [GNSO Guidance Process on Applicant Support](#).
- ICANN org is seeking input on several key topics, specifically on Section 5, which is about Applicant Eligibility and Evaluation Criteria:
 - 5.5.3: Indigenous/tribal people's organizations (Question 5: Section 5, pp. 22-23)
 - 5.5.5: Micro or small sized business from a less-developed economy (Question 5: Section 5, pp. 25-27)
- The [Public Comment](#) period for the draft ASP Handbook is 50 days, which is 10 days longer than the standard 40 days, to take into account the ICANN79 Community Forum. **Currently, the New gTLD Program team does not anticipate that the timeline for the ASP will allow for an extension of this 50-day Public Comment period.**

Public Comment: Registry Service Provider Evaluation

13 March - 22 April 2024

- Registry Service Provider (RSP) Evaluation:
 - ICANN org is seeking feedback on the RSP Handbook as it relates to the fulfillment of the Topic 6 recommendations of the *Final Report on the new gTLD Subsequent Procedures Policy Development Process*.
 - New gTLD applicants are required to use evaluated RSPs.
 - Organizations may apply to be one of each type of RSP (Main, DNS, DNSSEC, or Proxy) under one application fee. Main RSPs may apply for one or more Exhibit A Registry Services and IDN Services.
 - All applications undergo an initial technical screening and technical testing using the new Registry System Testing (RST) 2.0 service. Applications from organizations exhibiting no Specification 10 service disruptions in the previous six months are exempt from a secondary technical screening.

Public Comment: Registry System Testing 2.0

26 March - 5 May 2024

- Registry System Testing (RST) 2.0:
 - ICANN org is seeking feedback on the RSP Handbook as it relates to the fulfillment of the Topic 39 recommendations of the *Final Report on the new gTLD Subsequent Procedures Policy Development Process*.
 - Feedback in relation to the [RST Test Specifications](#) and [RST API](#).
 - Both are already in the public domain and [feedback](#) can be submitted via GitHub.

Draft ASP Handbook - Overview

- The [Draft ASP Handbook](#) is out for public comment until 2 April.
- Section 1 - Introduction
 - This section discusses ICANN's mission, the primary purposes of the New gTLD Program, and the objectives of the Handbook. The Handbook is intended to be a step-by-step guide to applying for such support and includes information on application deadlines, criteria, processes, and evaluation.
- Section 2 - Overview
 - Reinforces aim of the ASP to serve the global public interest by fostering diversity, encouraging competition, and enhancing the utility of the DNS. The intent is to make New gTLD program application fees and process accessible to entities (potential ROs) who otherwise would be unable to apply due to financial and resource constraints.

- Section 2 - Overview (cont'd)
 - Overview of the support - not only support to pay application and evaluation fees, but also non-financial support in the form of access to a list of pro bono/volunteer service providers, Application Counselors, ASP training program, and reduced or waived base RO fees (Pending Board consideration of the community's supplemental policy recommendation 17.2).
 - ASP Evaluation Phases & Categories
 - Phase 1:
 - General Business Due Diligence
 - Phase 2 (see [High-Level Eligibility Flowchart](#)):
 - Public Responsibility Due Diligence
 - Financial Need
 - Financial Stability
 - Eligible Entities

- Section 2 - Overview (cont'd)
 - Qualifying for ASP does **not** automatically mean an approved New gTLD Application. All applicants, supported or not, need to complete a New gTLD Program Application. Applicants that apply for, but do not qualify for, support are still welcome to submit a New gTLD Program application and pay the full gTLD application fee and any applicable evaluation fees.
- Section 3 - Applicant Support Program Timeline
 - Applications can be submitted from Q4 2024 to Q4 2025, and will be evaluated on an ongoing basis
 - Applicants should expect to receive the results of their application within 12-16 weeks of submission
 - ASP application submission period is 12* months long
 - Deadline to submit ASP applications is 6* months prior to start of the New gTLD Program application submission period (which is Q2 2026) (*with option to extend)

Draft ASP Handbook - Overview

- Section 4 - Reduction of New gTLD Program Application Fees
 - Qualified ASP applicants will be eligible to receive a [50-85%] reduction in the New gTLD Program Application fees.

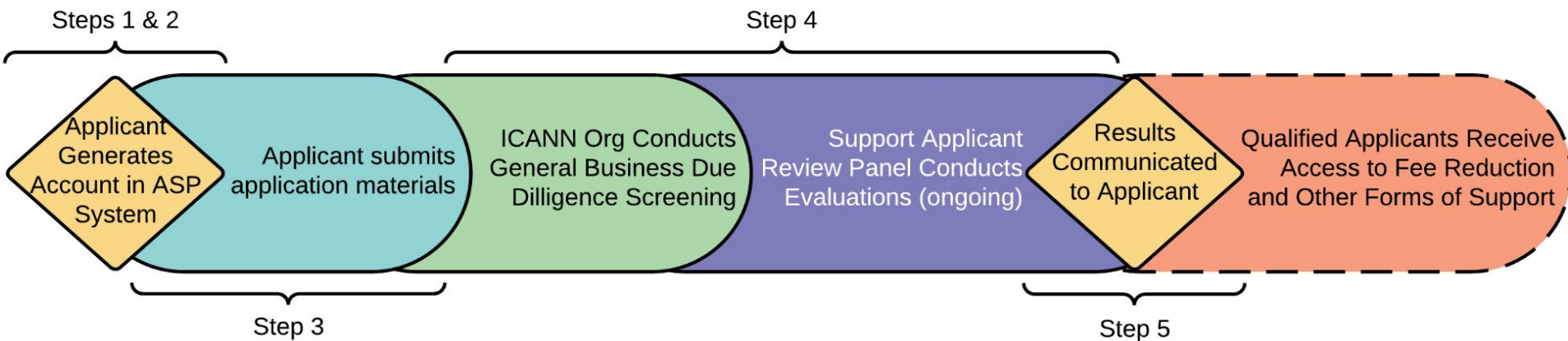

- Section 5 - Applicant Eligibility and Evaluation Criteria (see p. 25 of [Draft Handbook](#))
 - This section outlines the eligibility criteria mentioned above (towards the end of slide 9) in further detail. It also includes a reminder that ASP applicants are advised **not to submit information about their intended New gTLD Program application string** when applying to the ASP

Draft ASP Handbook - Overview

- Section 6 - Applicant Support Program Application Process
 - This section of the Handbook provides a high-level overview of the ASP steps:
 - Register
 - Access application materials
 - Submit Application
 - Evaluation Process
 - Evaluation Results



- Section 6 - Applicant Support Program Application Process (cont'd)
 - Applicants may change or update their applications throughout the processing and evaluation period. In general, all applicants will be required to update ICANN org in a timely manner of any material changes to information previously submitted on their application, which may then need to be re-evaluated by ICANN org and/or the Support Applicant Review Panel(s) (SARP(s)). Once an applicant's ASP evaluation begins, changes to the application will need to be submitted via an application change request. ASP applicants are **not** permitted to re-apply or re-submit an application to the ASP once the results of the ASP evaluation are complete.

- Section 7 - ASP Application Evaluation
 - ASP application evaluation will occur in **two phases**:
 1. ICANN org-managed General Business Due Diligence Screening evaluation.
 2. Independent third-party vendor-managed evaluation

- Section 7 - ASP Application Evaluation (cont'd)
 - ICANN org will utilize the ASP criteria and indicators to conduct the General Business Due Diligence Screening evaluation, and after this step, the SARP(s) will assess the ASP criteria categories.
 - SARP(s) - Recognizing that the ASP criteria categories are distinct and may require different evaluative capabilities, the third-party vendor may establish several SARPs to fully assess the applicant.
 - Evaluations will be conducted on a pass/fail basis against each required criterion and its related indicators.
 - SARP(s) may conduct independent research or ask CQs of applicants, if necessary.
 - Applicants are assessed on an ongoing basis.

- Section 7 - ASP Application Evaluation (cont'd)
 - Applicants who do **not** qualify for support (may submit a request for challenge—pending outcome of this topic), and may proceed to the main New gTLD Program (paying full application fee)
 - Minimum fee reduction (50%) to be the same for all. In the event that ASP funds remain available, qualified supported applicants may receive additional fee reduction up to 85%, to be **distributed equally**.
 - In the event that ICANN org's budget for minimum fee reduction is exhausted during submission period, ICANN org may pause accepting new ASP applications and communicate that available funds have been exhausted. Complete applications submitted before the pause will still proceed through evaluation.
