At all my subsequent ICANN meetings while serving at ATRT3 and on NOMCOM, I usually found ways of attending Fellowship programs and connected with those willing to network with experienced stakeholders. ICANN has gone through massive transformation in the recent past with new information coming up every time, it will be important for an experienced and a good tutor to help steer fellows into the somewhat confusing ICANN multistakeholders model.

Outside ICANN, I have strong passion for mentoring people and have led an annual Leadership Academy for ten years where participants were followed through on accomplishments after the Academy.

As a Professional, I was a member of Rotaract and later Rotary Clubs, as well as the JCI (www.jci.cc). I have been President of JCI-Aso, Abuja and served at the National level in various capacities including Chairman, JCI-Nigeria Training Institute, National Executive Vice President, and General Legal Counsel.
