3. You need to fill in all sections of the form. If a given criteria (e.g. expertise) does not apply to you, leave the field empty.
4. Once you have completed the form, save it on your computer/tablet/smartphone.
5. Create a new email message addressed to gnso-secs@icann.org, attach the form which you previously saved and submit the application.

I am currently part of no WG but have been active in PDP WGs, from 2014 to three years ago when I took a sabbatical off ICANN.

During that period, I also served as a member of the GNSO Council for one term (two years). The GNSO Council oversees the PDP work across the GNSO. That said, I am very familiar with the process and can guide a newcomer.

I am currently serving as a member of GNSO Standing Selection Committee for the 2nd year.

4. Please describe any past involvement in the ICANN Fellowship Program, if applicable. For example, have you previously been a fellow or served as a program mentor?

I joined ICANN as a Fellow in 2014. "Once a fellow, always a fellow", is the spirit!

My fellowship was renewed twice and for the third time, I joined as a Coach/Mentor which was an opportunity to support onboarding 2 newcomers.

When I first joined ICANN, I benefited from the support of a Coach who helped me find my way in that ICANN meeting, an experience I also shared with newcomers. I found this very important. I believe in mentorship!

I was involved in the Fellowship Program review and was one of the voices in support of its stay because I see its value, helping bring new blood and new voices to ICANN but also supporting those who are willing to come back and continue their involvement.

I am fluent in both French (native) and English, which can be beneficial to those fellows who don't have English as their first language and who find it hard to navigate though the ICANN world.

- **Active participant in GNSO structures and policy development processes with a track record of engagement**

After the opportunity given to me by the Fellowship program to get introduced to ICANN in 2014, I had to find my way in order to be able to stay and contribute to ICANN's work. In fact, that's what newcomers at ICANN (through the fellowship) need to be told by their mentors; that they should use the fellowship to come in, then be active in a specific community in order to be able to come back through other available opportunities.

Being selected to the GNSO Council by the NCSG was a highlight for the Fellowship program and I was used as a good example of someone who got in through the fellowship and then worked his way up to a leadership role.

All this, because I was active in my SG and a good contributor to the PDP WGs.

- **Previous experience serving as a mentor, teacher, or learning facilitator is a plus**

Within ICANN, I officially served as a Coach (Mentor) after my two fellowships; a rewarding experience, a way to give back and introduce new commers to ICANN.

In my professional life, I have served as a trainer and a learning facilitator, being the executive of a nonprofit running capacity building programs.

I have also supported the onboarding of newcomers within various programs and opportunities I have had in the past, outside of ICANN.

- **Strong written and verbal communication skills**

I am fluent in French (mother tongue) and English (work language), which is a plus in this ICANN ecosystem that welcomes those who are non-English natives as well.

I know how difficult it is for a non-English native to get into ICANN and find their way, I will be happy to specifically help this category of fellows navigate. I am also a sworn-in translator between English and French.

I am a researcher in social sciences and have produced research reports (in ICT field), have given interviews and have been an outstanding blogger in my younger age. I still blog, but not very often anymore due to time constraint. I am a published author.

- **Project management and coordination skills**

Having benefited from the help of a Coach for my first ICANN meeting and later on served in the same capacity, I know how important it is to be able to better organize oneself and to coordinate tasks and fellows, ensuring everyone is ready for the meeting, is able to navigate the actual meeting as well as able to feedback after the meeting (reporting phase).

As an executive for the last 12 years, I can confirm my project management and coordination skills that I am willing to lend to the fellowship program.

- **Networking skills**

Fellows need to be introduced to the ICANN community and to its leaders. This is important and having been in and around ICANN since 2014, I will be able to help this way.

Outside of ICANN, I have served in the global IGF MAG for three years (currently with the African IGF MAG), been active in ISOC, the ITU and the other major I* institutions, giving me a broad understanding of the ecosystem and the necessary networks to support fellows.
