"the Similarity Evaluation Panel may include additional variants" or "additional variants ... should be included" ?

Current text suggests both (may and should)

However I still fail to understand the reason to extend the request side

If the variant is NOT requested, what is the practical reason to do the evaluation? Even if SEP decides that there is (not-requested) variant that is confusingly similar to a string in Comparison side< what will be the outcome? There is no intension to use such a string anyway/

Please correct me if I'm wrong

Part B and Part C heading are missing in Table of Contents

Page 28 newly added text – should it be part of Notes and Observations?

Page 31 Section 5.1 - 1'd make the language more formal (just to be consistent in 'style' of the document):

"The section addresses the following two questions with respect to (IDN)ccTLDs:

- definition of variants of the selected IDNccTLD string
- management of variants of the selected IDNccTLD string •

I cannot see the definition itself. If we use the definition given in Label Generation Rule (LGR) Procedure for the Root Zone (RZ) – why don't we clearly state this?

Page 34

5.4 No selected IDNccTLD, no variants. According to section 6.2.1 and 6.2.2 - are these right section # or should it be 5.1 and 5.2?

Page 43 Notes and Observations section 7.2.3 A & 7.2.3 B – are these correct section numbers?

Page 60 – should the # of Section be 9? Section 9. Completion of IDNccTLD selection process

There are probably more wrong references in the text
