Assumptions:

- This Drafting Team should be able to complete its work in a timely manner (i.e., no more than 3 months), given the extensive existing details included in <u>Annex E</u> of the New gTLD Subsequent Procedures Final Report;
- The Drafting Team will use the Annex E guidelines as the starting point in developing the
 draft charter, where applicable. In some instances, elements of Annex E are applicable
 elsewhere (e.g., captured in the <u>Predictability Framework</u>, utilized when recruiting for
 the SPIRT Team);
- The Drafting Team members actively engage in the drafting and reviewing of the charter, providing timely input in between meetings;
- Commitment to this overall timeline, which would allow consideration by the GNSO
 Council, at the earliest by ICANN80 (June 2024), may require increasing the frequency of
 meetings from biweekly to weekly, if it turns out that more time is needed for
 deliberations;
- No additional opportunities for community feedback are foreseen (i.e., Public Comment);
- The draft charter is subject to adoption by the GNSO Council, which may also elect to amend the charter at its discretion.

Key issues to be addressed:

- Agreement on which elements of <u>Annex E</u> are properly captured in other documentation (e.g., Predictability Framework, call for volunteers, etc.).
 - In particular, how are policy issues (changes) addressed? (refer to the Predictability Framework flow chart, p.7)
 - In what way, if any, should the SPIRT Charter cross-reference the <u>Predictability</u> <u>Framework</u>?
- Triggering events and mechanisms to escalate issues to the GNSO Council.
- SPIRT Membership Model Open or Representative? Criteria and Length of Term?
- SPIRT Leadership Model and Criteria?
- GNSO Working Group Guidelines (section 3.6) as the sole basis for decision making methodology suitable?
