The SSR Review Team undertook the following:

a) Private Organizational Meeting

The SSR held a private organizational meeting on Monday, 12 March in order to prepare for the ICANN week and to reach agreement on a modus operandi. The Review Team Chair presented the schedule (available at: <https://community.icann.org/display/ssrreview/San+Jose+Meeting>) and the Team identified its goals and desired outcomes in light of this. (AP) and (SMC) provided the team with an overview of the current status of the draft report and solicited Members' feedback on whether they would be able to dedicate some of their time to reviewing supporting text. A number of recommendations were signed-off during this session. Member (SMC) was tasked to hold the pen on any amendments to the draft report.

b) Drafting Effort

The Drafting Team and any other Review Team Member available at the time met as often as possible during the ICANN week to make progress on the supporting text, structure of the report and layout with a view to having a document ready for sign-off at the Review Team face-to-face meeting. c) Session with ccNSO & ICANN Community
