Alice Jansen:To make WHOIS data more accessible for consumers, ICANN should set up a dedicated, multilingual website (like icann.org) to allow "unrestricted and public access to accurate and complete WHOIS information". Such website would provide access to WHOIS data, regardless of where it resides, for all gTLD domain names.
