### News from the Chair

ICANN is fifteen years old in 2013. It has an amazing history of addressing challenges and calls for improvements since its incorporation in late 1998.

Today, the Affirmation of Commitments is achieving the kinds of improvements that business and others sought. Further work is needed, but ICANN deserves our continued support. ICANN has made progress.

But externally, it is not a rosy picture. External geopolitical risks to ICANN's role, and its responsibilities continue. Business emerged from the WSIS aware that ICANN and the IGF are 'new models'; and that older institutions would struggle to accept these new players and multi stakeholder participation in policy areas. Various UN entities and some governments are still seeking to establish government only, or mostly intergovernmental authority over the Internet, with severe consequences for innovation, the Internet, online services, Internet users, and for ICANN and the IGF.

Business must address these external geopolitical events and challenges, but as a key stakeholder at ICANN, we need to also work at ICANN. The better ICANN fulfills its mission as a non-profit public benefit self regulatory entity, operating for the benefit of the Internet community as a whole, the stronger will be support for ICANN.

For business, ICANN and the IGF are two key global fora that we encourage all stakeholders to participate in. And, we need to also join with others to address the external geopolitical questions and challenges about who should 'govern' the Internet. It is our ICANN, after all.

Gathering in Costa Rica, the Business Constituency has over 50% of our members present. ICANN's busy schedule will fully engage the BC's members. Saturday and Sunday are the GNSO Council's Working Sessions, primarily briefings on gTLD policy topics, but including interactions with the GAC and Board.

Numerous workshops of interest to the BC are scheduled, including RAA Improvements; Consumer Trust; and Ethics and Conflicts of Interest, and a workshop on ICANN and the Internet Governance Landscape.

Tuesday kicks off with the Cross Constituency Breakfast with the Governmental Advisory Committee. We move into the CSG's Dialogue with the Board, followed by our BC@ ICANN meeting, and conclude the day with a special invitational event for the CSG's constituencies, local Costa Rican business and the Board.

Of priority to the BC are the Reports and interactions with the Security, Stability and Resiliency Review Team and the WHOIS Review Team. The Board's Public Participation Committee will hold a public consultation. And, thanks to the involvement of the BC, the IP Constituency and others from business, a special session on defensive registrations is scheduled for Thursday.

The BC arrives in Costa Rica looking forward to interacting with others from the community, the Board and staff. We also look forward to interactions and discussions with local Costa Rican business colleagues.

### Policy Update by Steve DelBianco, Vice Chair Policy Coordination

The BC mission is to promote business development "via an Internet that is stable, secure and reliable while promoting consumer confidence." But it'll be harder to meet that mission as ICANN several hundred new top-level domains.

Through years of policy planning for this expansion, the BC has been the voice for business registrants and their internet users. Our perspective is to encourage competition and innovation in the DNS, while minimizing costs

of defensive registrations and fraud. The BC has not won all our policy points, but we've helped make this TLD expansion safer for business registrants and users.

As new TLD applications move through evaluation to delegation, the BC will focus on implementation and contract compliance challenges. Join the BC and help us to improve the integrity of the DNS and maintain the private sector's leadership in Internet policymaking.
