Regional At-Large Organizations (RALO)

There are 5 geographic regions with recognized organizations











- MOUs with ICANN
- Made up of ALSes and Individual Members in their Geographic Region

About RALOs - ALSes

ALSes accredited by ALAC, to ensure and promote the regional users participation in the policy development processes of ICANN

All interested civil society organizations are invited to apply and join

The RALOs connect civil society organizations representing the interests of the Internet's individual end users in each region

The RALOs help to get our voices and opinions heard within ICANN's bottom-up, consensus-based multi-stakeholder approach to Internet governance.

About RALO — Unaffiliated Individual Members/Observers


- Unaffiliated Individual Member (UIM)
 - An individual Internet user may join the At-Large community independently without being a member of an ALS
 - Unaffiliated Member Observers

About At-Large and ALAC

How is ALAC different from the At-Large Community

- ALAC is a small subset (15 members) of the At-Large Community (260) ALSes and (160) UIMs that it represents and Unaffiliated Observers (17)
- ALAC includes 4 Liaisons to the GAC, GNSO, ccNSO, SSAC
- ALAC Advises on the activities of ICANN including Internet policies and operations
- ALAC Appoints delegates to the NomCom RALO recommended
- Seat 15 on the ICANN Board of Directors is selected by the At-Large
 Community
