

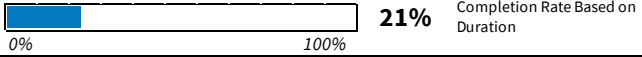
Continuous Improvement Program Community Coordination Group (CIP-CCG)

Fact Sheet as of: 31 March 2024

The group is being convened to help evolve ICANN Organizational Reviews into a CIP to implement Recommendation 3.6 of the Third Accountability and Transparency Review (ATRT3). The development of a CIP is part of a larger effort to enhance the effectiveness of the ICANN multistakeholder model, and is also in furtherance of the ICANN Interim President and CEO Goal 11 related to the management and refinement of Reviews. The CIP-CCG will: 1) Develop a shared understanding of the meaning of continuous improvement in the context of ATRT3 Recommendation 3.6, 2) Consider a range of methodologies for effective CIPs, 3) Agree on the methodology that is fit for ICANN purpose, and 4) Formulate a CIP Framework, to be used by each of the Supporting Organizations (SOs), Advisory Committees (ACs), and the Nominating Committee (NomCom).

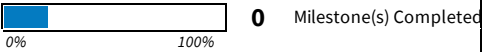
