Audits internal and external are all part of these activities. I have acted as an internal auditor for clients maintaining their ISO9002 Accreditation in various industries including Agribusinesses (including food production Nationally in Australia and in SE Asia) and Constructions and Demolition.

Data analysis was a vital part of my graduate and post graduate work, specifically non-parametric analysis and the use of broad based human testing in stress physiology for use in the further development of specific psychoactive pharmacological agent selection in emergency use; my skills and expertise in this arena was fundamental to the later Laboratory services, QAS systems work and the basis of several patents developed in conjunction with the Australian Military Medical Corps.

I have continued my interest in and kept up to date in my knowledge of recognized frameworks for organisational effectiveness, excellence and relevant industry AS and ISO Standards (I also receive and read NIST updates etc.,)

I am very familiar with ICANN structures having been pan active part of ICANN since joining the DNSO in its earliest year; and ICANN Reviews having served on or been active in many Organisational and Specific Reviews; I was an observer in ATRT1; served in ATRT2 as the ALAC representative, and in ATRT3 as it's Co-Chair; I was Co-Chair of the PHR Term of Reference WG. I currently serve as the ALAC representative on the CIP-CCG. Finally I have implemented S.M.A.R.T systems in several arena's including For Profit and NFP enterprises.
