




## **ICANN 79 UPDATES**

The ICANN79 Community Forum was held 02 - 07 March at San Juan, Puerto Rico.

- Prior to the meeting the <u>ICANN79 Policy Outlook Report</u> was released.
- Meeting was attended by 1096 people in person and 526 registered virtually from 106 countries.
- This six-day meeting, had nearly 200 public sessions, focused on outreach, capacity building, and showcasing ICANN's work to a broader global audience.
- Information was shared on the <u>ICANN Grant Program</u>, preparations related to <u>Universal Acceptance Day</u>, contribute to the next <u>ICANN Strategic Plan</u>, and the ongoing conversations around the future of Internet governance. There were plenaries, discussions on the next round of gTLD Auction, Application Support Handbook, Registration Data Request Service, DNS Abuse, etc.
- Manal Ismail was felicitated as the recipient of the <u>ICANN Community</u> <u>Excellence Award 2024</u>.
- At the meeting GAC as always released the ICANN79 GAC Communique.
- Prior to the meeting, the ICANN79 Prep Week was organised online between 20
   22 February, which comprised 12 sessions. One session which was newly introduced was ICANN Board's Engagement with the ICANN Community.

Maureen shared on NomCom's search for new ICANN leaders and Shah moderated the Community Discussion. This was followed by networking over refreshments.



## AT LARGE @ICANN 79

At ICANN 79, At-Large hosted a diverse range of sessions aimed at addressing key policy issues, enhancing outreach and engagement, and discussing operational matters. These sessions Includes:

- At-Large Leadership: Strategic Priorities and Metrics Work Session
- At-Large Policy Discussion
- One Joint Session With GAC, SSAC and ICANN board
- At-Large Leadership Working Session with NPOC Leadership and ICANN Grant Program
- At-Large Regional Leaders Coordination session
- Two At-Large Plenary Sessions
- At-Large Wrap-Up Session.
- At ICANN 79, At-Large emphasized equitable allocation of travel slots and objective metrics, aiming for fair representation.
- Updates on the Applicant Support Program (ASP) underscored the need for clarity in terminology and advocated for qualitative evaluation methods to enhance inclusivity and support.

• Collaborative efforts with SSAC concentrated on educating end-users about security concerns, while discussions with NPOC aimed to clarify ASP criteria for effective implementation and outreach strategies.

#### **March Call**

The March monthly call was held on 21 March. At the call ICANN79 Fellows shared their perspective on the meeting. The discussion was moderated by Aris the speakers were: Hafiz Farooq (Saudi Arabia), Russel Deka Harada (Papua New Guinea), Jahongir Jabborov (Tajikistan), Willie Meck (Papua New Guinea). Further Amrita presented the key takeaways from the APF's ICANN79 Readout and an update on the CIP-CCG WG face to face meeting @ICANN79

#### **April Call**

The <u>April</u> monthly call was held on 18 April. At the call Amrita <u>presented</u> on the work done by the CIP-CCG WG and during the call a small team was formulated to work on the next phase of work to be done. The <u>APRALO Travel Policy poll results</u> were also shared and discussed. Cheryl shared that the APRALO Rules of Procedures (ROP) was now ready and would be shared with the community to initiate the process. Justine provided an update on the <u>APRALO Policy Forum</u> and Project RoSi. Staff provided and update on the APRALO elections.

## APRALO Contribution to ALAC Public Comment Submission for the Draft Applicant Support Program Handbook, February -March 2024


The APRALO Policy Forum established a small team of regional community members to work on APRALO's contribution towards the ALAC's submission to ICANN Org's <u>Call for Input on Next Round Draft Applicant Support Program Handbook</u>. The APRALO Leadership Team selected **Cherie Lagakali** (Cook Islands), **Mabda Haerunnisa Fajrilla Sidiq** (Indonesia), **Phyo Thiri Lwin** (Myanmar), **Faheem Soomro** (Pakistan), and **Samik Kharel** (Nepal) to ensure diversity of input and especially from underserved countries (in respect of the New gTLD Program). These 5 small team members reviewed the Draft Applicant Support Program Handbook in detail and also participated in the <u>ALAC Policy Discussion at ICANN79</u> and a number of follow up At-Large Consolidated Policy Working Group (CPWG) calls where comments to that draft was discussed with the At-Large community. Led by APRALO Policy Forum Chair & ALAC Representative to the Subsequent Procedures Implementation Review Team (SubPro IRT) **Justine Chew**, this APRALO Small Team's contributions, along key input from **Cheryl Langdon-Orr** (ALAC Alternate to the SubPro IRT) and **Avri Doria** (CPWG Co-Chair), guided the At-Large discussions and ALAC's final submission (<u>AL-ALAC-ST-0224-02-01-EN.pdf (161.11 KB</u>) to ICANN Org.

Given the success of the small team format, the APRALO Leadership Team is looking to establish other small teams to improve engagement opportunities with APRALO community members on ICANN-related work.

#### APRALO ICANN79 Readout, 19 March 2024

Organised by the APRALO Policy Forum, the <u>APRALO ICANN79 Readout</u> saw moderator **Amrita Choudhury**, APRALO Chair joined by panellists **Aris Ignacio**, APRALO Vice Chair, based in Philippines; **Manju Chen**, GNSO Councilor representing NCSG, based in Taiwan; **Pranav Bhaskar Twari**, ICANN79 Fellow, based in India; **Dr Shamsuzzoha**, representing GAC Bangladesh and **Russell Deka T Harada**, representing ccNSO, based in Papua New Guinea.

Panellists discussed their respective key takeaways from ICANN79 and briefly shared with participants their next steps to those takeaways towards ICANN80. Panellists also shared how they saw individual end-users playing a role in the ICANN mission. Forty-eight participants in attendance actively engaged with the panellists throughout the discussion. ## **APRALO Policy Forum Updates contd..**

#### APRALO Policy Forum 5th Fireside Chat, 25 April 2024

The APRALO Policy Forum hosted its <u>5th Fireside Chat: Let's Talk About Internet Fragmentation & Multistakeholder Internet</u> <u>Governance</u> where Amrita Choudhury, APRALO Chair, chatted with her guest speakers Anriette Esterhuysen, Senior Advisor on Global and Regional Internet Governance; Chris Buckridge, Independent Consultant on Internet Governance and Digital Policy, and ICANN Board Member; and Pablo Hinojosa, Senior Director of Engagement at APNIC.



The conversation began with the speakers providing their interpretation of *Internet Fragmentation* and discussing the spectrum of fragmentation across technical vs governance & coordination vs commercial levels. They alluded to global geopolitical tensions, misinformation, national legislations introduced to protect sovereign interests, new challenges ushered in by new digital technologies as <u>some</u> obvious causes of Internet Fragmentation and how these factors impact us as Internet end-users.

Engagement with the over 60 participants then proceeded onto the concept of Internet governance and explored the role the Multistakeholder Model and in particular, the At-Large Community, can play to avert global fragmentation of the interconnected Internet. #### **CIP-CCG Group - Amrita Choudhury**




## Sharing the outcome of the APRALO Travel Policy Poll.

Do you agree with the position taken by the APRALO LT on the Pilot Project so far? <sup>34</sup> responses




Should APRALO reject the current Pilot Project, like the other three RALOs, given that it was not extensively discussed?



## **OTHER UPDATES**

#### APRALO and ALAC Participation in the 5th ICANN APAC-TWNIC Engagement Forum, Taipei, Taiwan, 23-24 April 2024

Justine Chew, ALAC Vice Chair and APRALO ALAC Member, participated remotely as a panelist in the 5th ICANN APAC-TWNIC Engagement Forum's session on Digital Rights/Privacy & Online Safety on April 23. The discussion, moderated by Edmon Chung, CEO DotAsia and ICANN Board Member, centered on registry and registrar practices to uphold Internet security and stability. Panelists, including industry figures Chiayo Kuo, Wilson Kao, Tom Hong-Fu Meng, and Ken-Ying Tseng, explored topics such as DNS Abuse amendments, Public Interest Commitments (PICs), and Registry Voluntary Commitments (RVCs). Justine stressed the vital role of education and awareness in combating cybersecurity threats, extending beyond vulnerable communities. She expressed support for recent DNS Abuse amendments, urging continuous evolution of definitions to address emerging threats. Furthermore, she highlighted challenges in DNS Abuse reporting and emphasized preventive measures like Know-Your-Customer practices and Al-driven tools. Justine proposed careful design of RVCs to ensure Internet security while respecting ICANN's non-regulatory stance on Internet content.



## **OTHER UPDATES**

#### NetMission APRALO Study Group Activity

The NetMission APRALO Study Group convened with APRALO Chair, Amrita Choudhury, on March 25, 2024, to enrich their understanding of APRALO and its endeavors. This group acts as a platform for individuals to delve deeper into Internet governance, domain name systems, and related policies. Through various engagement initiatives, members refine their capabilities in advocating for a more inclusive and equitable Internet landscape. By fostering connections and collaborations within the ICANN and APRALO spheres, the group aims to empower young individuals to actively shape the Internet's future. Its objectives include empowering NetMission Alumni and youth engaged in APRALO activities, fostering their skills and knowledge, encouraging active involvement within the APRALO community, and producing quarterly reports to document their progress and contributions.





#### ISOC Bangladesh Chapter - Shah Zahidur Rahman

20th April,2024 Internet Society Bangladesh Chapter has celebrated a hybrid full day event on Universal Acceptance (UA) day celebration. This day-long program was divided into two parts, first two hours was on UA awareness building and the remaining four hours was on capacity building for the technical community on DNS and EAI. Participants were from different stakeholders groups but the majority was from young engineers, software developers and system administrators.

Opening session keynote was made by Sajid Rahman from ICANN Board remotely and Samiran Gupta, SVP ICANN gave his speech also remotely however ICANN community members promotional messages were shared by video playing. Whole day session was conducted by Internet Society Bangladesh Chapter Leader, ICANN community leader remotely and Bangladesh Telecommunication Regulatory Commission (BTRC) subject matter expert and Bangladesh Computer Council consultant subject matter expert.

Closing remark has been given by the BTRC Director general who is also a GAC representative of ICANN from Bangladesh. Ending of the event participants have received certificates on-site.
