# APRALO Policy Forum Update

The APRALO Policy Forum (APF) began the new year with a call to refresh its membership so as to tap the interest of existing and new members in our region to participate in activities related to policy issues within ICANN's remit. As of 1 February, we have 31 members [subscribed](#) to the APF mailing list.

Since toward the end of 2023, the APRALO Leadership Team has been busy developing the [APRALO Policy Forum \(APF\) calendar of activities](#) for January and February 2024. As a result, we have delivered 3 key activities, with one more activity planned for late February, right before travel to ICANN79 begins.

**[APF Call on the Expedited Policy Development Process on Internationalized Domain Names \(IDNs-EPDP\) Phase 2 work](#)**, 25 January 2024

**Satish Babu**, APRALO ALAC Member and ALAC-appointed representative to the IDNs-EPDP, [provided](#) an overview of the work of the IDNs-EPDP which focuses on developing policy recommendations for variant management at the top-level and the second-level. He took the 21 participants through the concept of variants, and explained how the EPDP's Phase 1 work resulted in 4 key principles for top-level variant management and 69 policy recommendations impacting New gTLDs for the Next Round. He also explained the bifurcation of the EPDP's work by comparing how Phase 1 and Phase 2 related to each other, and talked about the EPDP's charter questions for Phase 2 as well as those related to the IDN Implementation Guidelines. [APF Call on APRALO Statement to the ICANN Board Call for Public Comments to the IDNs-EPDP Phase 1 Final Report](#), 13 February 2024

**Satish Babu**, APRALO ALAC Member and ALAC-appointed representative to the IDNs-EPDP led this APF call to discuss whether there was a need for an APRALO Statement in response to the ICANN Board's call for public comments to the IDNs-EPDP Phase 1 Final Report. Satish [brought up 3 issues](#) for the 18 participants' consideration, which were discussed at length. The call concluded with 2 of the issues not needing a statement, while the third issue of the potential need for greater community involvement in the development of Label Generation Rulesets (LGRs) and their integration into the Root Zone Label Generation Rules (RZ-LGR) would be an issue better broached with ICANN org through a preliminary conversation with the At-Large selected Board Member, Leon Sanchez.

### APF Call on ICANN Board Consultation on Public Interest Commitments (PICs) and Registry Voluntary Commitments (RVCs), 31 January 2024

In late December 2023, the ICANN Board initiated a community consultation to gather input on their [Draft Implementation Framework for Content-Related Registry Commitments](#) which was prefaced with a [Community Webinar](#) held on 18 December 2023.

**Justine Chew**, in her capacity as the ALAC-appointed Representative to the Subsequent Procedures (New gTLD Program Next Round) Implementation Review Team (SubPro IRT), led a discussion with 25 participants, explaining the context of the ICANN Board's proposed framework and questions for which it sought answers from the Community. In brief, the Board wanted input around the use of PICs and RVCs for the Next Round of New gTLDs, especially where registry commitments potentially touch on content are concerned, whether those would have limitations in terms of monitoring and enforcement by ICANN org in light of the ICANN Bylaw provision which frowns on regulation of content served through the DNS. This APF was to help facilitate APF members' participation at the At-Large Consolidated Policy Working Group (CPWG) calls where ALAC/At-Large positions/responses were being formulated. This issue will be further discussed by the ICANN Board at an [ICANN79 plenary session](#).

# APRALO WG UPDATES

## APRALO RoP - Cheryl Langdon- Orr

Update regarding the now [FINAL draft of the updated APRALO Rules of Procedure \(AP-RoP\)](#); after extensive review and drafting work, including that carried out by the APRALO Community in the 2023 AP-GA held in Istanbul, the now 43 page document along with 9 new or substantially updated Adjunct Documents were bundled and forwarded on 14 Feb 2024 to ICANN Legal to check that we have not created any inconsistencies or unintended consequences in relation to the ICANN Bylaws etc.

Once this cross-checking has occurred the APRALO Leadership Team (AP-LT) will set up an online poll/ballot or vote to seek endorsement and adoption of these new Rules, which once carried by affirmative vote, will come into force. As per the CURRENT RoP 23 Amendment of the Rules of Procedure paragraph 23.1, approval of any modification of the APRALO Rules of Procedure requires a Supermajority vote of the APRALO. As APRALO currently has 65 ALSes and the UIM Representative is +1 for an electorate of 66, therefore, 3/5ths (60%) or more of this will constitute the required Supermajority i.e. we require 40 affirmative votes for the adoption. So if you are a voting representative in our community it is extremely important that you cast your vote (Hopefully for or at worst an abstain ;-)). Failure by Representatives of ALSes and the UIMs to cast a vote in this poll/ballot will also count negatively in the performance metrics for those who hold these roles, so issues such as technical or connection issues need to be brought to the attention of At-Large Staff as soon as possible once the poll/ballot commences. Until then we trust that a small cadre of motivated APRALO Members will put themselves forward to be the shepherds on these new RoP to then act as facilitators and supporters for our Community as we use and are bound by the amended version.

## Operations Finance and Budget Working Group Update - Shah Zahidur Rahman

The Operations, Finance and Budget Working Group (OFB-WG) reviewed a number of ICANN operating and financial plans put out for public comment, namely: (1) the [Draft ICANN FY25 Plans](#) (which comprises the ICANN FY25-29 Operating and Financial Plan, the Draft ICANN FY25 Operating Plan and Budget, and the Draft IANA FY25 Operating Plan and Budget), as well as (2) the [Draft PTI FY25 Operating Plan and Budget](#).

The OFB-WG discussed draft statements for the 2 public comments on its calls held on 11 January 2024, 18 January 2024, 25 January 2024 and 1 February 2024. On 31 January 2024, the CPWG discussed the final draft statements. On 12 February 2024, staff confirmed that the ALAC unanimously endorsed the [Draft ICANN FY25 Plan statement](#) and the [Draft PTI FY25 Operating Plan and Budget statement](#).

As part of its development of the Draft ICANN FY25 Plan statement, the OFB-WG revised its approach to the development, review, and implementation of approved At-Large Funding Requests (AFRs) (noting that the previous Additional Budget Requests (ABRs) process was retired). The OFB-WG received [ten At-Large Community AFR proposals](#), which were then reviewed against the [FY25 ALAC Criteria for AFRs](#) also developed by the OFB-WG. Of the ten AFRs received, two were approved by the ALAC for submission for ICANN's budgetary planning. These two approved AFRs were for an annual At-Large Leadership Strategic Meeting, and a periodic Global End User Survey. The remaining eight AFRs were proposed to be taken up by respective RALOs in discussion with their respective regional Global Stakeholder Engagement (GSE) group.

### **Continuous Improvement Program Community Coordination Group (CIP-CCG) - Amrita Choudury**

The Continuous Improvement Program Community Coordination Group (CIP-CCG) has been set up based on the [ATRT 3 recommendation 3.6](#) (to evolve the organisational review of ICANN into a continuous improvement process).

At the first call a presentation of ICANN orgs research overview of the principle based approach to the CIP program was shared and all the SO/ ACs, along with the timelines of the WG. All were asked to share back what we are doing as a part of our continuous improvement efforts.

The ALAC and APRALO efforts have been updated in [this document](#). In the second and third call all the SO/ACs shared their efforts to continuous improvement.

At the third [meeting](#) there was a discussion on the next steps related to what should be the principles, criteria and indicators for the framework for continuous improvement.

As a next step the group would meet in San Juan on 6 March to work on deliberating on the Principles, criterias and indicators the group together and SO/ACs individually would be working on.

Community members are encouraged to share their suggestion on enhancing the improvement in APRALO.

## **NOMCOM update - Maureen Hilyard (APRALO delegate)**

REMEMBER March 15, 2024 at 23:59. This is the deadline for NOMCOM applications for anyone who might still be interested in being one of a new group of ICANN leaders for the next two (or three) years. PLEASE, if you know of anyone who you would consider suitable for one of these positions, encourage them to apply. Over one hundred and thirty prospects have started, but still have to complete, their applications online. Yet, there has already been a steady flow of early applicants who have forwarded their completed applications for one of the following vacancies:

- 3 x ICANN Board,
- 2 x ALAC (for EU and NA),
- 1 x GNSO Council, and
- 1 x ccNSO Council.

As one of the Outreach team, I will be also be giving last minute reminders to members at the AP\* Retreat (on 26 Feb) prior to the APRICOT meeting in Bangkok. I will also be at the APAC@ICANN session on March 5 as well as the ICANN Fellows session on March 7, at ICANN79. Hope to see you there :) )

On January 31st, 2024, a significant collaborative effort unfolded as the Philippines-based FMA, Malaysia's TIOF, and the UK-based Global Partners Digital came together for a pivotal roundtable discussion on Internet Fragmentation and Human Rights in the Asia-Pacific region. With a shared vision, the collaboration aimed to combat internet fragmentation via a dual-pronged strategy:

1. Enable civil society to engage with and influence technical standards-setting bodies strategically and sustainably.
2. Promote stronger coordination among stakeholders to reverse the growing trend towards internet fragmentation.

The roundtable, which targeted key organizations including the ITU, WTSA, IETF, and APT, underscored the critical role of a globally accessible and secure internet in safeguarding human rights. Amidst the challenges posed by evolving spatial dynamics and a prevailing lack of understanding, particularly in regions like the global south, the initiative prioritized inclusivity. Through insightful discussions led by a distinguished panel featuring APRALO Chair **Amrita Choudhury**, **Pablo Hinojosa** from APNIC, and **KS Park** from Korea University, alongside a keynote address by APNIC's Director General **Paul Wilson**, the roundtable sought to identify region-specific risks, elevate awareness, and uncover collaborative pathways toward fostering a more cohesive and inclusive internet ecosystem.

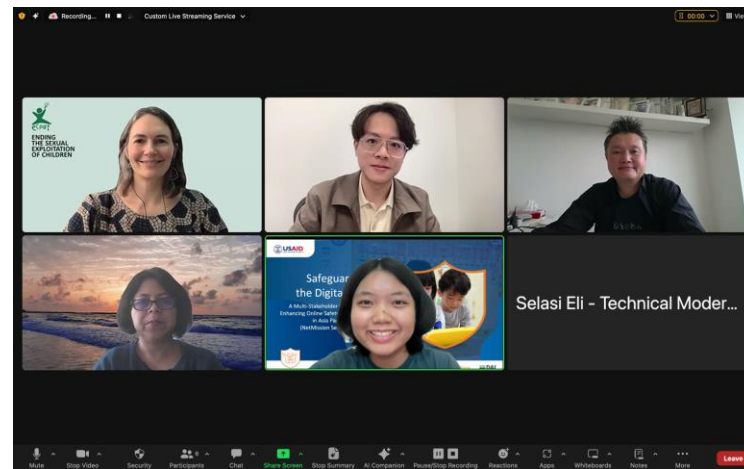

## Cyberpeace- Harish Chowdhary

To support ICANN's vision of a Trusted, safe and secure Internet, along with Initiatives of Government of India for Cybersecurity Capacity building, CyberPeace, as an at large organization, has conducted numerous workshops/conferences/collaborations.

CyberPeace has undertaken several initiatives to improve cybersecurity and promote digital peace. They've partnered with organizations like NIELIT and Resecurity to enhance cybersecurity education and resilience through training programs and joint research efforts. Collaborations with institutions like Chandigarh University and Rashtriya Raksha University aim to bolster India's cyber talent pool and strengthen cyber defense capabilities. CyberPeace has also conducted awareness sessions and workshops nationwide, including on topics like child safety online and cyber hygiene for students. Their participation in conferences and seminars underscores their commitment to staying abreast of the latest developments in the field of cybersecurity, as seen in their engagement at the IFIP WG 11.9 International Conference on Digital Forensics. These efforts collectively contribute to building a safer and more secure digital environment for individuals and organizations alike.





### Nepal Internet Foundation- Bikram Shrestha

The Nepal Internet Foundation (NIF) has been dedicated to making the internet a safer space in Nepal. In line with this mission, NIF organized two significant events.

Firstly, it hosted the screening of the documentary film "From the Shadows" in Kathmandu, shedding light on the issue of human trafficking and raising awareness.
