Rec 3.6: Review, should take place concurrently with subsequent application rounds. In other words, future reviews and/or policy development processes must not stop or delay subsequent new gTLD rounds.

Rec 3.7: If the outputs of any reviews and/or policy development processes has, or could reasonably have, a material impact on the manner in which application procedures are conducted, **such changes must only apply to the opening of the application procedure subsequent to the adoption of the relevant recommendations by the ICANN Board.**

Round 2 can open if:

1. The list of applied-for strings for the ongoing round has been confirmed and the window for string change requests has closed.
2. ICANN org has not encountered significant barriers to its ability to receive and process a new batch of applications.

Note: *The opening of round 2 does not depend on the PDP or the Review (Rec 3.6).*

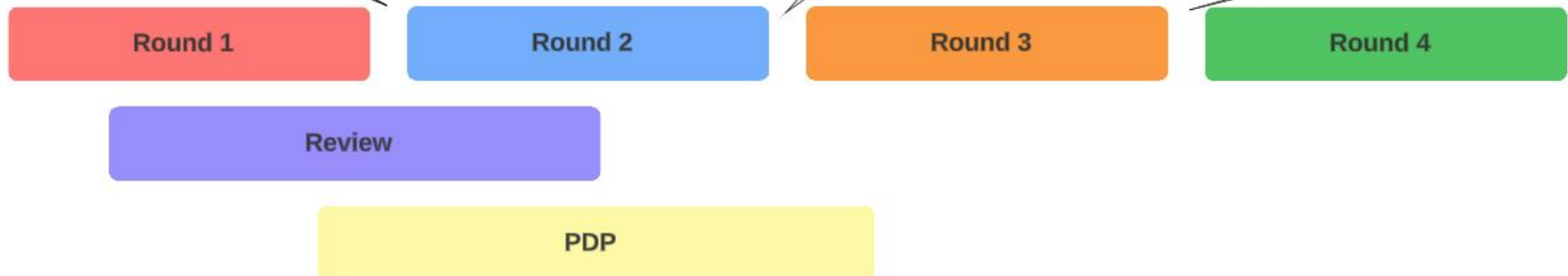
Round 3 can open if:

1. The list of applied-for strings for the ongoing round has been confirmed and the window for string change requests has closed.
2. ICANN org has not encountered significant barriers to its ability to receive and process a new batch of applications.
3. **ICANN org has implemented the ICANN Board-adopted Review outputs (Rec 3.7).**

Note: *The opening of round 3 does not depend on the PDP finishing (Rec 3.6).*

1. The list of applied-for strings for the ongoing round has been confirmed and the window for string change requests has closed.
2. ICANN org has not encountered significant barriers to its ability to receive and process a new batch of applications.
3. **ICANN org has implemented the ICANN Board-adopted PDP outputs (Rec 3.7).**
