Topic 1	<ul style="list-style-type: none"> <li>• ICANN org noted the redline of the 5 draft principles was updated to reflect the CIP-CCG discussions in June. An action item from the last meeting was to summarize thoughts on Principle #4 and finalize through the mailman list. CIP-CCG members provided additional commentary on the principles, including “accountability”.</li> <li>• Tijani Ben Jemaa (NomCom) reiterated his suggestion on Principle 4, Chokri Ben Romdhane (AFRALO) stated he believed “bottom-up” is superfluous in Principle 5, Lori Schulman (IPC) discussed</li> </ul>

	<p>broadening accountability outside of the ICANN community to the global community.</p> <ul style="list-style-type: none"><li>• These 5 principles stem from the ICANN Bylaws, Article 4.4 on the objectives of Organizational Reviews, as well as the recommendations in final reports from prior Organizational Reviews. ICANN Organizational Reviews as described in the Bylaws ensure the ICANN multistakeholder model remains transparent and accountable, and exist to improve the performance of its SOs, ACs, and the NomCom. "Accountability", as articulated in principle 4 is from the <a href="#">Work Stream 2 – Recommendations to Increase SO/AC Accountability</a>.</li><li>• CIP-CCG volunteers continued to provide updates on Phase 3 of their work with their groups related to criteria and indicators - what has been developed so far, as well as any challenges or ways ICANN org can support their work further.</li><li>• Owen Smigelski (RrSG) noted that his group emphasized the importance of providing objective and even critical input in their self-assessments. That it was important to acknowledge and report on what is not working or challenging dynamics. He encouraged that this point be emphasized by ICANN org and the CIP-CCG volunteers.</li></ul>
Topic 2	<ul style="list-style-type: none"><li>• ICANN org presented several questions for CIP-CCG discussion and input from their groups regarding the CIP survey.</li><li>• This work is progressing and as part of developing the survey, ICANN org needs CIP-CCG input on who (or how) each SO, AC and their substructures would envision distributing the survey. This would include identifying who their members are, and having an email address. CIP-CCG volunteers and their groups should consider how to define active vs. inactive members and whether different types of surveys for each would be useful.</li></ul>
