Agenda 2. Background

- The GNSO approved policy recommendations on Privacy & Proxy Services Accreditation Issues in 2016.
 - According to the Final Report, some goals of the recommendations included clarity, transparency, and consistency in the operation of services.
- The Board adopted the recommendations in 2016.
- ICANN org worked on the implementation with an IRT until 2019 then paused the work due to overlapping issues being considered in the community around GDPR, data processing, and the Temporary Specification.
- Although gTLD registration data is no longer public by default, proxy and privacy services still exist within the ecosystem.

Agenda 2. Purpose

- The publication of the Registration Data Policy in February 2024 provides an important foundation for aligning related procedures, including those of proxy and privacy services.
- ICANN is now looking to return to the work on these policy recommendations.
- Consensus Policy Implementation Framework (CPIF):
 - The Implementation Review Team ... will serve as a **resource to implementation staff** on **policy and technical questions** that arise...An IRT is expected to serve as a resource to staff on the **background and rationale of the policy recommendations** and return to the **GNSO Council for additional guidance** as required. Where relevant, the IRT should also include technical or subject-matter experts and contracted parties who can **assist staff in the planning for the technical implementation** of a policy change.
 - The [GDD] staff are responsible for the **entire implementation lifecycle**, from creating an **implementation plan, engaging the IRT ... consulting with relevant ICANN org staff** and any outside parties that are required, and **conducting outreach** surrounding the implementation, including **communicating with the public** and relevant stakeholders regarding the progress of implementation.

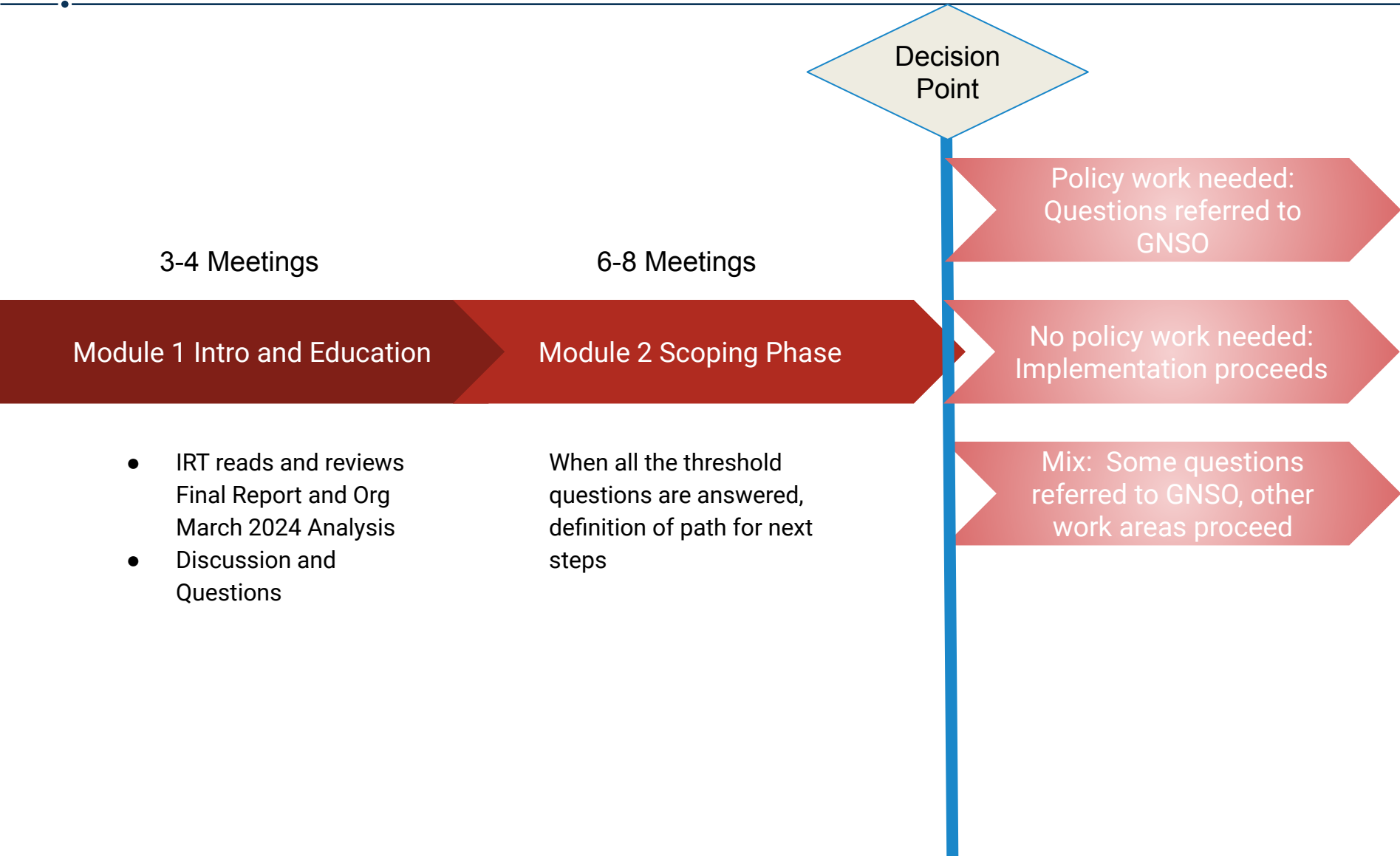
Agenda 3. General Policy Implementation Steps

1. Read, understand, analyze, and interpret policy recommendations
2. Review implementation design
3. Draft consensus policy language and other documents for implementation
4. Public Comment
5. Publish Consensus Policy with Legal Notice issued to Contracted Parties for implementation
6. Implement the Policy by the Policy Effective Date
7. Celebrate! IRT work ends when all implementation work is successfully complete
