01:27:07 Satish Babu: I think 63 is the max length of a label. The max length of a domain name "label.tld" is 255 (including the trailing null).

Yes. RFC1035 AND 3 x 63 + 61 = 250 is a quick calculation. However, RFC1935 has max 255 bytes (1 byte = 1 character = 1 octet). As Siva noted leading and trailing length bytes are there in 255 and if we do not count them it is 253! Three too many possibilities...we need to nail this down whenever. - Dr. T V Gopal, Anna University, Chennai, INDIA
