# 1. Activity: Please describe your proposed activity in detail

Recruit and contract with person to provide secretariat services to IPC, and supervise and evaluate delivery of those services. Professional secretariat services will increase the amount of time available to IPC volunteers for outreach and for substantive participation in ICANN activities, and insure more complete and transparent communication of IPC activities to both current and prospective members. A notional list of duties could include: (1) Maintain authoritative membership contacts list (as directed by Secretary); (2) Manage publicly archived and private listserv; (3) Invoice, receive and record dues payments and manage banking activities (as directed by Treasurer); (4) Manage membership application and review process and onboarding of new members; (5) Arrange conference calls as directed, receive/report RSVP's, and prepare draft summaries of calls; (6) Maintain IPC website.

We propose to expend about \$5K per quarter (total \$20K) to engage these services at a level in the range of 150-200 hours per quarter.
