The Internet Service Provider & Connectivity Providers Constituency which forms part of ICANNs Generic Names Supporting Organisation (GNSO) and also forms part of ICANNs Commercial Stakeholder Group (CSG) is open to all qualifying parties who meet the membership criteria specified within its Articles.

ISPs or Connectivity Providers are defined as any entity that either;

- Operates an Internet backbone network
- Provides transit to either Internet users or 3rd party Internet content
- An industry trade association that represents ISPs or Connectivity Providers

Membership categories

The following membership categories apply.

1. Large ISPs and Connectivity Providers:

Organisations who qualify as a large ISP or Connectivity Provider shall provide ISP or connectivity services to more than 1 Million customers or have an annual turnover of more than \$10m USD.

2. Medium ISPs and Connectivity Providers:

Organisations who qualify as a medium size ISP or Connectivity Provider shall provide ISP or connectivity services to more than 10,000 customers but less than 1M customers, or have an annual turnover ranging between \$1M and \$10M USD.

- 3. Small ISPs and Connectivity Providers:
- Organisations who qualify as a small size ISP or Connectivity Provider shall provide ISP or connectivity services to less than 10,000 customers, or have an annual turnover of less than \$1M USD.
- 4. ISP and Connectivity Provider Associations and Industry Trade Associations: This category applies to national and regional ISP Associations who represent a number of ISPs.
