Asmus: (06:25) Chris: until I hear different from Andrew, I'd treat "structured" as an underfined term (and since it's not defined, it may not be needed).

Joseph Yee: (06:27) Regarding B.4.4, the first paragraph, it says that integration panel not free to amend the details of the generation panel's proposal, but it was expected that integration panel may amend variant rules (B.1.2 - rule 3)

Joseph Yee: (06:27) So I think the text needs to clarify what may be amend or not Dennis Jennings: (06:29) Joseph - thanks

Zhang Zhoucai: (06:30) I have an edirorial comment for the term "varinats", if it implies variant word, not only a character, please add "word" after the "variant".

Asmus: (06:35) Abandoning the Conservatism pirnciple is not called for. And that principle is the one that calls for leaving out anything that can't achieve consensus.

Asmus: (06:36) However, there might be a theoretical issue with obstructionism that is NOT based on technical grounds...

Dennis Jennings: (06:36) Michael - noted

Asmus: (06:38) Agree with Michaels point about handling this kind of extreme problme via panel composition, contract etc.

Asmus: (06:38) Read

Michael Everson: (06:39) Wanton obstructionism on non-technical grounds is something handled by withdrawal of the person's contract.

Michael Everson: (06:40) Isn't that handled by "good practice"?

Dennis Jennings: (06:40) Rinalia - Hand noted

Syed Iftikhar H. Shah: (06:41) Michael, good practice made by whom?

Asmus: (06:42) There may be a disconnect here - there's the question of whether to add IDN at all, where I think the stance is NOT one to allow "the smallest" number. What DOES need to be limited is the number and complexity of additional rules that apply to the shared ROOT.

Rina: (06:44) Response, pls.

Francisco Arias: (06:46) @Rinalia, we also have the chair of the generation panel. I'd think that the chair of the panel would be a facilitator of the discussion.

Asmus: (06:46) I think the document might strengthen the section on how to administer a primary panel.

Rina: (06:47) @Francisco, I'm thinking worse case scenario. First option Chair, second option advisers, if they are trusted by the group third option other trusted parties. I'm being very practical here.

Francisco Arias: (06:48) @Rinalia, agree the Chair is the first option to resolve disputes

Michael Everson: (06:48) "The advisor can also be called upon to assist in facilitatation of dispute resolution where necessary."

Michael Everson: (06:49) What is a "trusted person"? Isn't everyone supposed to be trustworthy and professional? What if the people who are supposed to agree on who is "trusted" can't agree on that person? This becomes endlessly recursive.

Syed Iftikhar H. Shah: (06:50) i am disconnected

Rina: (06:51) In mediation and dispute resolution, Michael, parties in the dispute have to agree on somone that they both agree as someone they trust.

Francisco Arias: (06:52) @Rinalia, I'd think that is the Chair. The Chair of a Generation panel has to be someone trusted by the members of the panel.

Rina: (06:52) Francisco, there may be cases where the CHair is conflicted (i.e., not neutral and siding with one faction).\

Michael Everson: (06:52) I agree with Francisco

Syed Iftikhar H. Shah: (06:53) francisco can you ask telephone operator to call me
