Mike O'Connor: +1 Steve -- but there's more. we need ways to bring people up through steadly-deeper levels of parrticipation

Mike O'Connor: dropping somebody right into a WG is really tough on everybody

Mike O'Connor: we need some baby steps up to that

Steve Crocker: I empathize with Mikey. I have a real heartburn about the way online survey tools work. They are often organized to impose control over the person being questioned, and that's often awkward and annoying. Whoever designs these tools seems to think the person being questioned is obligated to go along with whatever the deesigner r decided. What happenss when the person simply refuses to go along with the game.

Mike O'Connor: question about the agenda -- are we still on "introductory comments"? should we move on to the questions?

Olivier Crepin-Leblond: The majority of ALAC members are currently NOT filling out these forms

Olivier Crepin-Leblond: W9 forms, I mean

Steve Crocker: Re continuity, is there some form of secretariat support for each of the constituencies or is the support only for the council?

Mike O'Connor: no secretariat for the ISPs

Kristina Rosette: @Steve Crocker: Steve, IPC has no secretariat support. We've been requesting it for some time, including in our most recent budget request.

Kristina Rosette: In the IPC, the officers are effectively the secretariat.

Mike O'Connor: +1 Kristina -- plus me (not an officer) in the ISPs

Kristina Rosette: +1 to Steve M.'s comments regarding public comment summary.

Mike O'Connor: how about the comments on the budget?? still no response - almost 2 weeks late

Kristina Rosette: +1 to Elisa w/r/t MSWG. Completely agree.

Mike O'Connor: +1 from the ISPs as well -- very disruptive

Anne Aikman-Scalese: Agree CSG should not be limited to one rep on WG

Mike O'Connor: sorry - my hand keeps magically raising itself.

Kristina Rosette: thank you, Alan

Chris Chaplow: @Alan, if there are common themes which you consider out of scope, perhaps you can state this in a cover or appendix to help focus these problems

Alan Greenberg: Thanks Chris. interesting thought

Anne Aikman-Scalese: Agree learning curve is very steep - you have to be really bold and willing to make big mistakes to jump in.

Fiona Asonga: very interesting views
