Kathy Kleiman: Realistically, we are looking to defend not the exceptions but the vast

majorities: those engaged in free speech, fair use, open business, etc.

Kathy Kleiman: Everyone needs privacy.

rafik:who is talking?

Kathy Kleiman: That's the basic default I think Wendy is asking for.

Lisa Phifer:stephanie perrin

robin gross:why not?

Lisa Phifer:by default, only a few data elements will likely be public by default

Lisa Phifer:we are still working on refining that list, but by default many data elements

will be gated

Kathy Kleiman:@Lisa: what fields?

robin gross:a value judgment that conforms to privacy law is probably a good idea

Lisa Phifer: Kathy, we're working on the list, first trying to define criteria for what must

be public. We welcome input on what that criteria should be

Klaus Stoll:Can't hear anything on Adobe, just someone typing

wseltzer:as this becomes a wish-list for users of WHOIS, we need to consider the

externalities of those uses

Lisa Phifer:By defining a system capable of supporting all purposes, it could be used to support different policies about under what circumstances access is granted to whom, for what purpose

wseltzer:I'd like to speak next, please

Stephanie Perrin: who is minding the queue?

Carlton Samuels: Question: Is it useful to provide a system that supports and enables continuing confidence in the DNS?

Jean-Francois Baril:wendy will be next then Stephanie

Carlton Samuels: And if so, how does a way to identify actors compute?

Avri Doria:But this report does not even protect non commercial individuals.

Rudi Vansnick:@Kathy: very good point

Avri Doria: Having to prove an individual its under threat can be tough in repressive regimes.

Carlton Samuels:@Kathy: What mechanisms are in place to ensure performance? Does the contract compels contact data of one or other type?

Kathy Kleiman:Tx you for so much time!

Kathy Kleiman:@Carlton: It's a great question, but not one I fully understand.

Carlton Samuels:Oh, I was referring ton your arrangement as expert attorney where you say they don't ahve an address for you.

Kathy Kleiman:@Carlton: I see, in the case of business-to-business, often the groups I work with don't know my address until it's time to send a check.

Kathy Kleiman:@Carlton: when I've researched this issue, I found that when a steel producer, for example, deals with a car manufacturer in another country, the disclosures are determined by contract and by due dilegence -- the research the two companies do of each other (privately)

Carlton Samuels:@Kathy: See, that action -sending the check - is connected to performance. So even to record performance contact data is exchanged. And in this case disclosed for purpose. This is the new development in the EWG's proposal.

Kathy Kleiman:+1 Stephanie: Everyone seems to want everything - and the EWG report seems to be embracing that

Alice Jansen:test

robin gross:but the point is what the law requires

Carlton Samuels: @Stephanie: Yes, it was to the RAA 2013 and the data retention provisions

Denise 2: Jurisdictional and legal research also is being done for the EWG

Poncelet ileleji:Pls what kind of Legal research just some clarity pls

Denise 2: issues related to data protection and storage, data retention, and privacy as it relates to EWG work

Carlton Samuels:@Privacy Law: Every one I've seen makes the case that collection and disclosure of personal data be purposeful and may only be used for the purpose it was collected.

Carlton Samuels:@Kathy: Reduction of the dataset collected and held is a good question

wseltzer:[I'll need to leave for another call. Thanks for this meeting.] robin gross:thank YOU, Wendy!

Lisa Phifer: We are considering data generated by WHOIS studies to understand abuse and availability of WHOIS data

Carlton Samuels: I have to leave now. Thanks everybody

Kathy Kleiman:@Lisa: As someone who helped design the studies, I think they will provide some answers, but not designed to provide all answers.

Rod Rasmussen: Have another call to attend - thanks for your input everyone! robin gross: there wasn't an extension in the comment period?

Kathy Kleiman:Basically, the protections of speech are protected through other mechanisms

Kathy Kleiman: e.g., national law and UN Declarations

Rudi Vansnick:+1

Rudi Vansnick:volunteers need also time for reflection with colleagues

Magaly:Not only UN declarations at global level there are other mechanisms too, all of them connected with UN documents.
