Steve DelBianco: we should hesitate to recommend REMOVAL of a metric that's easy to get, even if we see limited utility and potentially conflicting implications of an increase in QR code use

Nathalie Coupet: Could we have feedback from ALAC in London regarding the merits of these metrics?

Nathalie Coupet: LEA could also give false data if investigation or surveillance are underway.

Steve DelBianco: as we set it aside, lets cite the same reasoning we used for 1.13

CW: Christopher wilkinson has joined the call

CW: apologies for delay

Mason Cole: that one will be very tough to get from registrars

Steve DelBianco: Q to those proposing these new metrics: can you suggest whether (and how) they are related to Trust, Choice, or Competition?
