I think that the group was originally created to give advice to ICANN on how to deal with the various Internet Governance issues of 2014. We should not try to be too specific.

Olivier:

What the process is regarding the selection of people for the Brazil meeting. Where does at-large fits in that?

Theresa:

Participation will be through their stakeholder group, some in Civil Society, Technical community, business and so on.

<?> As at large community, we use different hats. Difficult to choose a specific stakeholder group.

Olivier:

Where are the safeguards for geographic balance? Now mainly from Europe and North America.

Theresa:

Respective stakeholder group should agree on the process and mechanisms in respect to geographic representation.

Evan:

Advisory group are creation of ICANN, they are multistakeholder in their own right. The way to approach it should not be to tell them to figure out their participation in their own stakeholder group.

Theresa:

We welcome all the suggestions on how to look at that.

Keith Drazek: Concerned about a significant expansion (mission leap) of ICANN's role outside its narrow technical remit.

Avri Doria: the SO/AC should be advising on the scope of ICANN's missions
