REQUEST DESCRIPTION

1. Activity: Please describe your proposed activity in detail

IPC officers and other leadership are generally volunteers whose travel expenses are not reimbursed. In general, officer attendance at ICANN meetings is diminished if travel support is not available. The historical baseline level of support of full support for 3 persons is appreciated; however, under its by-laws IPC has 4 elected officers and other appointed leadership roles. As a result, the IPC requests full travel support for 4 persons to each ICANN public meeting in FY 2015 as well as any inter-sessional meeting that may occur during FY 2015. In the absence of approval for 4 persons, the IPC requests that the traditional level of travel support for 3 persons be maintained for each ICANN public meeting in FY 2015 as well as any inter-sessional meeting that may occur during FY 2015. The IPC will continue to provide more limited support, from its own funds, for other IPC participants to travel to ICANN meetings.
