# REQUEST DESCRIPTION

#### 1. Activity: Please describe your proposed activity in detail

There are two themes attached with development that can be associated with domain names and the opportunities afforded by the domain name industry, new gTLDs and other innovations in the marketplace.

The first is the promotion of domain names as vehicles for starting new enterprises, confirming business, cultural or community identity, and reaching new markets. Domain names are a singular tool, better than search, QR Codes or "apps" for meeting these needs.

The second is associations and access afforded by relationships within the Domain Name Industry. The DNA (and other similarly situated organizations such as NPOC) provides access to industry expertise and markets. Whether the target markets are global, regional or local, relationships and interactions can foster development: providing training and guidance for new registrars; education and training for ICT professionals; or providing insight into market trends, new business models and developing opportunities.

Following the one-day workshop delivered as a pre-ICANN event in Singapore, thematic working groups will be formed and there will be an agreement that first ongoing work should be performed in between ICANN meetings to gather and second, there will be a need to re-gather and discuss the status of ongoing work prior to the ICANN meetings that will take place during FY15 as a continuous cycle and instead of having one stand alone

The workshops will gather representatives of the ICANN community from the non-commercial sectors and commercial sectors and from outside ICANN to analyse to following thematic themes to specifically address the needs of developing countries and identify challenges in those regions.

- Issue 1: gTLD for development
- Issue 2: The need for rights protection mechanisms in new gTIDs from a development

• Issue 3: ICT4D in transition – building and living with stakeholder engagement:

Please note that the issues might evolve based on the work performed by the permanent working groups that will be created after the Singapore event will take place and the subsequent events will also be tailored depending on locations of the meetings to take into account local/regional needs.
